Seva Ki Paribhasha

Parivaarik Dekhbhal Prashikshan seva vyakti-kendrit hai aur ghar par rahne wale bina vetan wale dekhbhal karne wale vyakti ko, jo bhagidaar ko sahayta pradan karta hai, vyaktigat prashikshan aur shiksha pradan karti hai.

Pradan Karne Ki Shartein

- A. Ek pratyabhagi apni zarurat ke adhar par har seva ka chayan karta hai.
 1. Sevayein swatantrata aur samudaayik ekikaran ko badhava deni chahiye; aur
 2. Chuni gayi waiver seva aur inhe pradan karne wala vyakti pratyabhagi ke Vyaktigat Sahayak Yojana (ISP) mein darj kiya jata hai.
- B. Parivaarik Dekhbhal Prashikshan ka uddeshya bina vetan wale dekhbhal karne wale vyakti ko unke apne kaushalon aur gyaan ko sudhar kar bhagidaar ki avashyaktaon ko samajhne aur unka samadhan karne mein madad karna hai, jisse ve bhagidaar ko unke jeevan ke lakshyon tak pahunchne mein aur adhik kushal ban saken.
- C. Parivaarik Dekhbhal Prashikshan seva nimnalikhit kshetron ko sambodhit kar sakti hai:
 1. Samarthit bhagidaar ki viklangta ko samajhna;
 2. Samarthan pradan karne mein adhik kushalta aur atmavishwas prapt karna;
 3. Pramukh maata-pita ki ran-nitiyon ko viksit karna ya sudharna; aur
 4. Anya kshetra jisme bina vetan wale dekhbhal karne wale vyakti bhagidaar ke chahte huye lakshyon aur parinaamon ko, jo vyakti-kendrit seva yojana mein darj hain, sabse prabhavit tareeke se samarthan de sakte hain.
- D. Parivaarik Dekhbhal Prashikshan seva tabhi avashyak hai jab bhagidaar ke vyakti-kendrit seva yojana mein darj pratyashit parinaamon ko prapt karne ke liye aur yeh bina vetan wale dekhbhal karne wale vyakti ke bhoodika se sidhe sambandhit honi chahiye, jo bhagidaar ko vyakti-kendrit seva yojana mein darj kshetron mein samarthan pradan karta hai. Jo bhi prashikshan bina vetan wale dekhbhal karne wale vyakti ke liye diya jata hai, jo bhagidaar ko samarthan pradan karta hai, use bhagidaar ki seva yojana mein shaamil kiya jana chahiye.
- E. Parivaarik Dekhbhal Prashikshan ki nimnalikhit simaayein hain:
 1. Yeh seva vetan prapt dekhbhal karne wale vyaktiyon ko prashikshan ya shiksha dene ke liye pradaan nahi ki ja sakti.
 2. Yeh seva Rajya Swasthya Yojana ke tahat pradan ki ja rahi anya tulnatmak sevayon ke saath milti-jultti, badalti, ya nakal nahi honi chahiye, jisme bacchon ke vikas aur rognivaran se judi sevayein aur ghar aadharhit sevayein shaamil hain.

Pradata Ki Avashyaktaayein

Nichee di gayi jankari mein sabhi pradata ki avashyaktaayein shaamil nahi hain. Yeh is vishesh DD seva ke pradataon ke baare mein samanya jankari dene ke liye hai.

- A. Waiver ka Sabhi seva pradaataon ko yah karana hogi:
 - 1. Medicaid pradata hona chahiye;
 - 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
 - 3. Medicaid aur Dirgha kaalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
 - 4. Anurodh par DHHS prashikshan poora karna chahiye; aur
 - 5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.
- B. Parivaarik Dekhbhal Prashikshan ek vikreta dwara pradaan kiya ja sakta hai.
 - 1. Ek vikreta ek company ya sanstha hai jo Medicaid pradata ke roop mein registered hai, lekin DD pradata ke roop mein pramanit nahi hai.
- C. Parivaarik Dekhbhal Prashikshan swayam-nirdeshit nahi ho sakta.
- D. Bhagidaar ka ek ristedar, jo uska abhibhaavak ya anya kanooni roop se jimmendar vyakti na ho, anya aavashyaktaon ko poora karne par Parivaarik Dekhbhal Prashikshan pradan kar sakta hai. Kyunki yeh seva sirf sanstha pradataon ke dwara uplabdh hai, isliye rishtedaar ko sanstha pradata ka karmachari hona padega.

Mullya

- A. Parivaarik Dekhbhal Prashikshan mein unkshetron ke sambandhit panjikaran aur prashikshan shulk ke liye bhugtaan shaamil hai, jo seva yojana mein bhagidaar ki avashyaktaon ke anusar anaupcharik nirdeshan se jude hote hain. Prashikshan karyakram ya sammelan mein shaamil hone ke liye yatra/savaar, bhojan aur raatri avasthaan ke kharche ke liye bhugtaan uplabdh nahi hai.
- B. Pehle se anumodit sevayon ki raashi bhagidaar ki vyakti-kendrit seva yojana mein darj avashyaktaon aur bhagidaar ke manzoor varshik budget ke antaragat aadharit hoti hai.
- C. Bina vetan wale dekhbhal karne wale vyakti ke liye shiksha/prashikshan karyakram, karkashala aur sammelan panjikaran ke kharche ek varshik budget ke antaragat \$500.00 tak seemit hote hain.
