Seva Ki Paribhasha

Ghar Ki Sudhaaron Ki Seva, ek bhagidaar ke niji ghar mein aise badlaav hote hain jo uske liye ghar ke andar aasani se ghoomna aur surakshit rehna banaye.

Pradan Karne Ki Shartein

- A. Ek pratyabhagi apni zarurat ke adhar par har seva ka chayan karta hai.
 - 1. Sevayein swatantrata aur samudaayik ekikaran ko badhava deni chahiye; aur
 - 2. Chuni gayi waiver sevaen aur inhe pradan karne wala vyakti pratyabhagi ke Vyaktigat Sahayak Yojana (ISP) mein darj kiya jata hai.
- B. Ghar Ki Sudhaaron Ki Seva mein shaamil hain:
 - 1. Ek bhagidaar ke niji ghar mein sharirik roop se badlaav jo bhagidaar ki dincharya ki kriyaon ko poora karne ki kshamata badhaye, zyada svatantrata ke saath kaam karne mein madad kare, ya unke ghar tak pahuchne mein madad kare; aur
 - 2. Bhagidaar ke niji ghar ke vartaman kshetra ke andar kiye gaye sudhaar.
- C. Ghar Ki Sudhaaron Ki Seva ek kaushal vikas sewa nahi hai.
- D. Ghar Mein Sudhaar ke udaharan hain, lekin in tak simit nahi hain:
 - 1. Chadhai;
 - 2. Bathroom mein badlaav, jaise ki sahaj pahuchne layak snan kendra ya shower;
 - 3. Darwazon ka chauhadda karna; ya
 - 4. Naye ya sudhaare gaye bijli ya paani ki pipes aur unse judi bavasthayein.
- E. Ghar Ki Sudhaaron Ki Seva neeche diye gaye kuch simaayein hain:
 - 1. Sudhaaron Ki Seva mein aise badlaav nahi shaamil kiye ja sakte jo ghar ke liye aam upyog ke ho aur jo bhagidaar ko seedha medical ya upcharatmak labh na de. Udaaran ke liye:
 - a. Ghar bhar mein kharaab baithne ki chadar ko badalna;
 - b. Kai bathrooms ko asaani se istemal karne layak banana; ya

- c. Ghar ke upar ya neeche ke star tak pahuchne ki suvidha jabki sabhi zarooratein mukhya manzil par hi puri ki ja sakti hain.
- 2. Ghar Ki Sudhaaron Ki Seva un sthalon par lagu nahi ki ja sakti jo kisi aur ke dwara chalaye ya maalik ho, jaise ki Saajha Rehne ki Sthiti ya Grihasth Ghar.
- 3. Sudhaaron Ki Seva ghar ke kul kshetra mein izafa nahi kar sakti, jab tak ki ghar ke pravesh ko sudhaarne ya bathroom ko wheelchair ke liye anukool banane ki avashyakta na ho.
- 4. Kirayedaar ke bima ya ghar ke maalik ke bima ka praman patra maanga ja sakti hai.
- 5. DDD ko ek upyukt Medicaid-naamaankit peshewar pradata dwara sthaniya moolyaankan ki avashyakta ho sakti hai. Moolyaankan Paryavarun Sudhaar Moolyaankan ke tahat pradan kiya jata hai.
- 6. Ghar Ki Sudhaaron Ki Seva Medicaid ke madhyam se pradan kiye gaye anya samanya sevaon se samanantar nahi ho sakti, unhe badal nahi sakti, ya unka nakal nahi kar sakti. Ek bhagidaar ko is seva ko maangne se pehle yeh pata karna chahiye ki kya Medicaid ghar ki sudhaaron ki seva ke liye bhugtan karega.

Pradata Ki Avashyaktaayein

Nichee di gayi jankari mein sabhi pradata ki avashyaktaayein shaamil nahi hain. Yeh is vishesh DD seva ke pradataon ke baare mein samanya jankari dene ke liye hai.

- A. Waiver ka Sabhi seva pradaataon ko yah karana hogा:

 - 1. Medicaid pradata hona chahiye;
 - 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
 - 3. Medicaid aur Dirgha kaalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
 - 4. Anurodh par DHHS prashikshan poora karna chahiye; aur
 - 5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.

- B. Ghar Ki Sudhaaron Ki Seva DD sanstha ke pradan karta, ek swatantra pradan karta, ya ek vikreta ke dwara pradan ki ja sakti hai.

 - 1. Ek DD sanstha pradata ek company hai jo Medicaid pradata ke roop mein panjikrit hai aur DHHS dwara DD sevaayein pradan karne ke liye pramanit hai aur nimnlikhit ke liye zimmedar hai:
 - a. Un karmachariyon ki bharti aur nigraani jo pratibhagee ke saath kaam karte hain;
 - b. Karmachariyon ko unki yogyata, anubhav, aur pradarshit kshamataon ke aadhar par niyukt karna;
 - c. Karmachariyon ko prashikshan pradan karna taaki ve aavashyak star ki dekhbhal dene ke liye yogy ho sakein;
 - d. DHHS ke liye prashikshan yojnaayein uplabdh karane ke liye sahamat hona;
 - e. Seva ki paryapt uplabdhata aur gunwatta sunischt karna; aur
 - f. Anya prashasanik kriyaen.
 - 2. Ek DD swatantra pradata ek vyakti ya vikreta hai jo Medicaid pradata ke roop mein registered hai aur ek bhagidaar dwara niyukt kiya gaya hai.
 - a. Bhagidaar apne pradata ko niyukt karne aur nigrani rakhne ke liye zimmedar hota hai.
 - 3. Ek vikreta ek company ya sanstha hai jo Medicaid pradata ke roop mein registered hai, lekin DD pradata ke roop mein pramanit nahi hai.

- C. Ghar Ki Sudhaaron Ki Seva ko swayam niyantrit kiya ja sakti hai.

- D. Ghar Ki Sudhaaron Ki Seva bhagidaar ke kisi rishtedaar dwara pradan ki ja sakti hai, lekin bhagidaar ke kanooni jimedar vyakti ya abhibaabak dwara nahi.

Mullya

- A. Ghar Ki Sudhaaron Ki Seva ko bhagidaar ke varshik vyaktigat budget ke andar kharida jana chahiye.
- B. Ghar Ki Sudhaaron Ki Seva har ghatna ke liye bhugtan ki jaati hai.
- C. Ek vitarak apne saman ko samanya janata se jyada nahi bech saka. Ek vitarak jo kisi vishesh samuh, jaise ki students ya vridh nagrikon ko chhoot deta hai, usi chhoot ko us samuh ke ek bhagidara ko bhi dena chahiye.
- D. Ghar Ki Sudhaaron Ki Seva ka ek budget sima \$10,000 per 5 saal ke liye hota hai.
 - 1. Ek bhagidara apni gambhir swasthya ya suraksha ki avashyakta ke chalte budget ki seema ke upar vitran ki maang kar saka hai.
 - 2. DDD ki manzoori uplabdh vitran ke aadhar par nirnayit ki jati hai.
- E. Yatra ki lagat isme shamil nahi hai.
