

Asadharan Dekhbhal ke liye LRI Niji Dekhbhal (LRI Personal Care for Extraordinary Care)

Nebraska mein **Asadharan Dekhbhal** ka arth hai vyakti ke Rozmarra ke Jeevan Ki Gatividhiyon (ADLs) aur Zaruri Rozmarra ki Gatividhiyon (Instrumental Activities of Daily Living – IADLs) mein aise hands-on sahayata pradan karna jo us gatividhi ki seema se adhik ho jo ek mata-pita ya jeevansathi am roop se usi umra ke bina viklangata ya chronic illness wale vyakti ke liye ghar mein karte hain.

Asadharan Dekhbhal Tool (The Extraordinary Care Tool)

Kanooni Roop se Uttardayi Vyakti (LRI) Vyaktigat Dekhbhal seva ke liye bhagidar ka Asadharan Dekhbhal ki paribhasha mein aana zaroori hai. LRI Vyaktigat Dekhbhal tab prayaog mein layi jati hai jab bhagidar ki avashyaktayein पूरी karne ke liye anya koi seva ya pradana upalabd nahi hota.

Asadharan Dekhbhal Tool (Extraordinary Care Tool) (DD-26) ko shuru me Seva Samanvyak parivar ke saath milkar poora karta hai, aur baad me PCP team iski samiksha karti hai. Isme ank is aadhar par diye jate hain ki bhagidar ko ek kaam poora karne ke liye kitni sharirik madad chahiye. Asadharan Dekhbhal Tool varshik aadhaar par poora kiya jaata hai.

Yadi bhagidar Asadharan Dekhbhal Tool mein kam se kam teen kshetron mein “haan” score karta hai to use Asadharan Dekhbhal ke roop mein mana jata hai. Sirf wahi avashyaktayein jo “haan” score karti hain, vyaktigat Dekhbhal seva ke liye anumodit ki ja sakti hain. LRI Vyaktigat Dekhbhal 40 ghante prati saptah se adhik nahi ho sakti.

Asadharan Dekhbhal Tool mein kuch tasks ayu-vishesh hote hain. Ye tasks aur unki ayu-seema tool mein diye hote hain aur yadi bhagidar us di gayi seema mein ata hai to us task ka score ya anumodan nahi kiya ja sakta. Jab bhagidar us ayu tak pahuch jata hai jahan ayu-seema ab lagu nahi hoti, to SC ko LRI Vyaktigat Dekhbhal ke liye us task ka anumodan lene ke liye ek naya tool poora karna hota hai.

LRI Vyaktigat Dekhbhal Seva

LRI Vyaktigat Dekhbhal ek LRI ko chhoot bhagidar ko Vyaktigat Dekhbhal pradan karne ki anumati deti hai. LRI Vyaktigat Dekhbhal ekmatra chhoot seva hai jo ek LRI pradan kar sakta hai. LRI ki paribhasha hai ek alpavayask bachhe ke praktik ya god lene wale mata-pita ya chhoot bhagidar ka jeevansathi.

Jab kisee LRI ko koee karya karane ke lie adhikrt kiya jaata hai, to koee any vyakti usee avadhi ke dauraan ADL aur IADL samarthan ke pravadhaan ke lie bil nahin de sakata hai. Koee any vyakti usee avadhi ke dauraan aupacharik ya anaupacharik ADL aur IADL sahaayata pradaan nahin kar sakata hai, jis avadhi ke lie LRI, LRI vyaktigat dekhbhal sevaon ke lie biling kar raha hai. LRI Vyaktigat Dekhbhal sevaon ka bil tab tak nahin lagaaya ja sakata jab tak LRI dekhbhal karta anya rojagaar mein sanlagh hai.

Is seva ko pradan karne ke liye LRI ka ek agency ke sath niyukt hona zaroori hai, siway kuch seemit parishthityon ke. Adhik jankari ke liye kripya apne SC se sampark karein.
