

Developmental Disabilities (DD) Waivers

Definitions

Relative Any person related to the participant by blood or marriage to the third degree of consanguinity, including a foster parent, foster child, stepparent, stepchild, and adopted children and their adoptive parents. In the case of an Indian child, relative is defined in Neb. Rev. Stat. § 43-1503.

Legal Guardian is a person appointed by a court to serve as a guardian for someone ages 19 years or older. Legal Guardians may only serve as agency providers.

Legally Responsible Individual (LRI) is a spouse or the natural or adoptive parents of minor children.
