Seva Ki Paribhasha

Gair-Chikitsa Parivahan ek seva hai jo HCBS Waiver ke antargat vrudh aur vikalang (AD) aur Chot Se Samarthit Mastisk Ghatna (TBI) Waiver ke liye vrudh aur bachon ko pradan ki jati hai. Yeh waiver aur anya samudaayik sansadhan tak pahunch pradan karta hai jo bhagidaar ko unke ghar mein rehne ki kshamata mein sidhe yogdan dene wale pehchane gaye hain. Yeh seva ek vyakti, sanstha (chhuti prapt parivahan pradan karta), ya ek samanya parivahan karne wale dwara pradan ki ja sakti hai.

Pradan Karne Ki Shartein

- A. Gair-Chikitsa Parivahan ki avashyakta bhagidaar ke moolyaankan ke dauran pehchani jaani chahiye aur vyakti kendrit yojna (PCP) mein shamil ki jaani chahiye.
- B. Pradata ek samay mein ek se adhik bhaagidar ko seva nahi de sakte, jab tak bhaagidar ki PCP mein anya roop se na likha ho.
- C. Bhagidaar ko is seva ke liye nimnalikhit mankon ke anusar anumati di ja sakti hai:
 1. Bhagidaar ke paas koi kaam karne wala licensed vahan nahi hai ya usse vahan tak pahunch nahi hai;
 2. Bhagidaar ke paas vartaman mein manaya gaya driver ka license nahi hai;
 3. Bhagidaar kisi dastavezit sharirik, maansik, ya vikasatmak sima ke karan gaadi chalane mein asamarth hai;
 4. Bhagidaar kisi dastavezit sharirik, maansik, ya vikasatmak sima ke karan akela safar karne ya intezaar karne mein asamarth hai; ya
 5. Bhagidaar muft parivahan prapt karne mein asamarth hai.

- D. Gair-Chikitsa Parivahan nimnalikhit stitiyon mein se ek ya adhik ke liye anumati di ja sakti hai:
1. Labhon ke liye avedan karna – Jab kisi karyakram ke liye vyakti se samvaad ke liye vyakti roop se milna avashyak ho, tab bhagidaar ko labhon aur sevaon ke liye avedan ya punah pramanit karne ki suvidha pradan karna:
 - a. Nebraska Swasthya aur Manav Seva Vibhag;
 - b. Samajik Suraksha Prashasan; ya
 - c. Purv Sainik Prashasan.
 2. Saman Kharidna – Bhagidaar ko bhojan aur avashyak saman kharidne ki suvidha pradan karna. Praptikaran ek calendar saptah mein ek roundtrip tak ki adhikam anumati di jaati hai.
 3. Kanuni Seva Prapt Karna – Bhagidaar ko kanuni madad samiti, nijee vakilon, zila vakilon, aur anya peshewar kanuni srot se aparadh se sambandhit na hone wale mamlo mein kanuni salah lene ki suvidha pradan karna. Praptikaran ek calendar mahine mein ek ghoomkar yatra tak ki adhikam anumati di jaati hai.
 4. Vittiya Seva Prapt Karna – Bhagidaar ko banking sanstha mein vittiya mamle suljhane ki suvidha pradan karna. Praptikaran ek calendar mahine mein ek ghoomkar yatra tak ki adhikam anumati di jaati hai.
 5. Waiver Seva Tak Pahunch – Bhagidaar ko Vruddh Divas Swasthya Seva (ADHS) ya Svatantrata Kaushal Vikas (ISB) tak aur unse vapas le jaane ki suvidha pradan karna.
 6. Makan Ki Suvidha Prapt Karna – Bhagidaar ko uchit makan ya svatantrik jeevan vyavastha dekhne aur prapt karne ki suvidha pradan karna. Praptikaran kisi bhi 12-mahine ke avadhi mein adhikam paanch ghoomkar yatron tak ki anumati di jaati hai. Jab bhagidaar ki sehat aur suraksha khatre mein ho, tab atirikt yatron ki anumati di ja sakti hai.
 7. Samudaayik Gatividhiyon Tak Pahunch – Bhagidaar ko unki pasand ki gatividhiyon tak aur unse vapas le jaane ki suvidha pradan karna, taaki samudaay mein mil-jul kar rehna badhava diya ja sake. Praptikaran ek saptah mein ek ghoomkar yatra tak ki adhikam anumati di jaati hai.
 8. Kaam Tak Pahunch – Jab sarvajanik parivahan uplabdh ya sulabh na ho, tab bhagidaar ko kaam tak aur wapass le jaane ki suvidha pradan karna.
 9. Shikshan Gatividhiyan – Bhagidaar ko niyमित व्यवसायिक या शिक्षण प्रशिक्षण में भर्ती होने और भग लेने की सुविधा प्रदान करना, ताकि वे सामान्य शिक्षण विकास (GED) या एक undergraduate degree या certificate प्राप्त कर सकें.
 - a. Ismein un chhatron ko shamil nahi kiya jata jo doosri undergraduate degree, doosre certificate ya license, aur koi bhi graduate degree ya usse uchit prapt kar rahe hain.
 - b. Class ke samay-suchi ki pushti ki avashyakta hai.
 - c. Online kakshaaon ko samaksh upasthiti nahi maana jata.
 - d. Parivahan ko un vyaktiyon ke liye shikshan sevaen prapt karne ke liye anumati nahi di ja sakti jo 20 varsh ya usse kam umra ke hain aur jo kisi sthaley school district dwara pradan ki ja rahi hain.
- D. Gair-Chikitsa Parivahan mein shamil ho sakta hai:
1. Sarvajanik parivahan ke token ya pass kharidna.
 2. Un bhagidaar ka saath dena jo akela safar karne aur intezaar karne mein asamarth ho, unhe gair-chikitsa gatividhiyon ya niyukti milan tak le jana.
- E. Gair-Chikitsa Parivahan ke dauran bhagidaar ko kabhi akela nahi chhoda ja sakta.
- F. Bhagidaar ki parivahan seema DHHS dwara nirdharit ki jaati hai.
- G. AD aur TBI Waivers ke antaragat sevaen sirf un atirikt sevaon tak seemit hoti hain jo Medicaid rajya yojna ke tahat anya roop se shamil nahi hoti hain, lekin sansthaagat karan ko talne ke waiver ke lakshyon ke anukul hoti hain.
- H. Waiver ke madhyam se Gair-Chikitsa Parivahan ko Medicaid rajya yojana ke parivahan ke sthaan par nahi istemal kiya ja sakta, jo Nebraska ko 42 CFR 440.170 ke antargat pradan karna anivarya hai.

Pradata Ki Avashyaktaayein

- A. Waiver ka Sabhi seva pradaataon ko yah karana hoga:

1. Medicaid pradata hona chahiye;
 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
 3. Medicaid aur lambe samay Dekhbhaal Seva Pradata Samjhauta mein varnit maapdandhon ka paalan karna;
 4. Anurodh par DHHS prashikshan poora karna chahiye; aur
 5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.
- B. Gair-Chikitsa Parivahan pradan karne wale ko yah sunishchit karna hoga ki unka vahan bhagidaar ke liye sulabh aur surakshit ho.
