Yeh survey Nebraska ke sabhi license prapt bachon ki dekhbhal pradataon se data ikatha karta hai, taaki un bachon ke liye jo medical aur vyavhaar sambandhi zaruraton ke saath ya bina, private pay bachon ki dekhbhal dar ka pata chal sake.

2023 ka survey avashyak rajya aur kendriya benchmark ko pura karta hai: (a) ismein moolya ki gayi bachon ki dekhbhal market shamil hai; (b) yah poora aur vartaman data pradan karta hai; (c) yah bhaugolik antar ko darshata hai; (d) kathor data sangrahan prakriya ka upyog karta hai; aur (e) yah data ko is tarah se vishleshit karta hai ki yah market ke antar ko umra ke group, pradata ke prakar, aur bhaugolik sthal ke roop mein darshata hai.

Bachche ke maa-baap ya mukhya dekhbhaal karne wale vyakti ko niyमित bachon ki dekhbhal ke kharch ka zimma hota hai. Yeh rakam seva pradata ke daamon ke adhar par tay ki jaati hai, jo Child Care Sahayata Karyakram ke Title 392 mein prat kiye jaate hain, jo seva pradata ke ghar ya kisi kendra mein di gayi dekhbhal ke liye hoti hai. Bachche ke ghar mein di gayi dekhbhal ke liye, bina license wale parivarik bachon ki dekhbhal ghar ki dar chart vyakti-gat seva pradataon par lagu hoti hai, aur bachon ki dekhbhal kendra ki chart sanstha seva pradataon par lagu hoti hai. Vibhag niyमित bachon ki dekhbhal ke mool kharch ke upar sewa ke manzoor kiye gaye kharch ki bhugtan ke liye zimmedar hai.
