Seva Ki Paribhasha

Rojgar Poorv Kaushal ek kaushal vikas sambandhi seva hai jo pratyabhagi ko unki ruchiyon se sambandhit samanya kaushalon ko viksit karne mein madad karti hai, taaki ve samudaayik aur ekikrit sthiti mein bhavishya mein naukri prapt kar saken.

Pradan Karne Ki Shartein

- A. Ek pratyabhagi apni zarurat ke adhar par har seva ka chayan karta hai.
 1. Sevayein swatantrata aur samudaayik ekikaran ko badhava deni chahiye; aur
 2. Chuni gayi waiver sevaen aur inhe pradan karne wala vyakti pratyabhagi ke Vyaktigat Sahayak Yojana (ISP) mein darj kiya jata hai.
- B. Rojgar Poorv Kaushal mein shamil hai:
 1. Samudaay mein naukri prapt karne ka samanya lakshya hona;
 2. Aise kaushalon ka vikas karna jo samanya ho aur naukri-vishesha na ho;
 3. Vyapak rojgar sambandhi lakshya aur kaushal vikas sambandhi karyakram hone chahiye, agar pratyabhagi Rojgar Punarvas sevaon ke liye pratiksha suchi mein ho; aur
 4. Dainik Jeevan ki Gatividhion, Swasthya Rakshan, aur Nigraani mein Sahayata.
- C. Rojgar Poorv Kaushal ek kaushal vikas sambandhi seva hai aur isme kaushal vikas karyakram shamil hone chahiye. Vyakti vishesha kaushal vikas karyakram chalaye jaane chahiye, aur jab bhi seva pradan ki jaaye, tab har baar data record kiya jaana chahiye.
- D. Rojgar Poorv Kaushal vikas karyakramon ke udaharan jo kaushalon ka vikas karne mein madad karte hain, inme shamil hain, lekin in tak simit nahi hain:
 1. Anya ke saath prabhavit roop se samvaad karna;
 2. Saamanya roop se swikarya samajik kaushal aur veshbhusha;
 3. Kai kadam wale nirdeshon aur suchnaon ka palan karna;
 4. Lambe samay tak apne kaam par kendrit rehna;
 5. Vartaman udyog mein takneekiyon ka upyog karna;
 6. Samanya samasya-samadhan kaushal aur rananiti; aur
 7. Vibhinn vatavaranon mein samanya suraksha aur gati kshamataen.
- E. Is seva ka ek hissa virtual roop se diya ja sakta hai, jo ki is tak simit nahi hai, balki shamil hai:

1. Pratyabhagi ki zarurat ko shabdk sanket auranya sahayata ke madhyam se poora kiya ja saktahai, jo virtual roop se pradan ki ja saktihai;
2. Yeh moolik aur madhyam stariya funding ke antaragat pratyabhagiyon ke liye uplabdh hai;
3. Har hafte pradan kiye jaane wale Rojgar Poorv Kaushal ka pramukh hissa vyakti roop se pradan kiya jaana chahiye;
4. Online sahayata ke liye kul milaye gaye ghante hafte mein 10 ghante se adhik nahi ho sakte; aur
5. Yeh 10 ghante din sevaon ke 35 ghante per hafte ki seema mein shamil hain.

F. Rojgar Poorv Kaushal ki nimnlikhit seemaayein hain:

1. Rojgar Poorv Kaushal mukhyataya samudaay mein vibhinn sthalon par pradan kiya jaata hai.
2. Jab Rojgar Poorv Kaushal wahi sthaan par pradan kiya jaata hai jo pradata ke dwara malik ya kiraye par liyagaya ho, ya jahaan anya waiver sevaayein pradan ki ja rahi ho, to koi bhi karmchari jo anya waiver sevaayein de raha ho, wahi samay par Rojgar Poorv Kaushal seva nahi de sakti.
3. Rojgar Poorv Kaushal 12 lagatar mahine se adhik samay tak nahi istemal kiya ja sakti.
4. Ek pratyabhagi Rojgar Poorv Kaushal ko anya din sevaon ke saath milakar prapt kar saktahai, lekin kul milaye gaye ghante hafte mein 35 ghante se adhik nahi ho sakte. Ek hafte ko is prakar paribhashit kiya jaata hai: 12:00 am Somvaar se lekar 11:59 pm Ravivaar tak. Anya din sevaayein hain:
 - a. Vyask Din;
 - b. Vavhaarika Ghar Par Kaushal Vikas;
 - c. Samudaayik Samanvay;
 - d. Dinik Samarthan;
 - e. Chikitsa Ghar Par Kaushal Vikas;
 - f. Chhoti Samuhik Vyavsayik Sahayata;
 - g. Samarthit Rojgar – Anukaran Seva; aur
 - h. Samarthit Rojgar – Vyaktiagat.
5. Rojgar Poorv Kaushal mein koi bhi seva ya seva ka hissa shamil nahi ho saktajosarvajanik shiksha ke madhyam se uplabdh ho, ismein shamil hain:
 - a. Pratibhagee ke sthaniya school jila mein chalu karyakram, jismein school ke baad ki dekhbhal aur aise dinon ki sevaayein shaamil hain jab school band ho, jaise ki garmiyon ki chhuttiyan, nirdharit school chhuttiyan, aur shikshak seva divas;
 - b. Pratibhagee ke liye sthaniya school jila dwara nirdharit school ke samay ke dauran, chahe school ka prakar kuch bhi ho (sarvajanik, private, ya ghar par); aur
 - c. Jo shikshan seva ke ghante pradan kiye jaate hain ya uplabdh hote hain, unhe kul milaye gaye din seva ke ghamton mein shaamil kiya jaata hai, jo ki hafte mein 35 ghante se adhik nahi ho sakte.
6. Rojgar Poorv Kaushal Medicaid Rajya Yojana, HCBS Waiver seva, ya Rojgar Punarvas ke madhyam se pradan ki ja rahi anya samaan sevaon se overlap, pratinishtan, ya nakal nahi kar sakti.
7. Rojgar Poorv Kaushal seva ko nimn likhit sthitiyon mein samapt karna hogi:
 - a. Rojgar ki talash Rojgar Punarvas ke saath shuru hoti hai; ya
 - b. Iska upyog 12 mahine ke liye ho chuka hai.

Pradata Ki Avashyaktaayein

Nichee di gayi jankari mein sabhi pradata ki avashyaktaayein shaamil nahi hain. Yeh is vishesh DD seva ke pradataon ke baare mein samanya jankari dene ke liye hai.

A. Waiver ka Sabhi seva pradaataon ko yah karana hogi:

1. Medicaid pradata hona chahiye;
 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
 3. Medicaid aur Dirgha kaalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
 4. Anurodh par DHHS prashikshan poora karna chahiye; aur
 5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.
- B. Rojgar Poorv Kaushal ek DD sanstha pradata ke dwara pradan kiya ja sakta hai.
1. Ek DD sanstha pradata ek company hai jo Medicaid pradata ke roop mein panjikrit hai aur DHHS dwara DD sevaayein pradan karne ke liye pramanit hai aur nimnlikhit ke liye zimmedar hai:
 - a. Un karmachariyon ki bharti aur nigraani jo pratibhagee ke saath kaam karte hain;
 - b. Karmachariyon ko unki yogyata, anubhav, aur pradarshit kshamataon ke aadhar par niyukt karna;
 - c. Karmachariyon ko prashikshan pradan karna taaki ve aavashyak star ki dekhbhal dene ke liye yogy ho sakein;
 - d. DHHS ke liye prashikshan yojnaayein uplabdh karane ke liye sahamat hona;
 - e. Seva ki paryapt uplabdhata aur gunwatta sunischit karna; aur
 - f. Anya prashasanik kriyaen.
- C. Rojgar Poorv Kaushal swayam-nirdeshit nahi ho sakta.
- D. Pratyabhagi ka ek rishtedaar, lekin unka Abhibhabak ya anya kanoonan zimmedar vyakti nahi, Rojgar Poorv Kaushal pradan kar sakta hai jab ve anya aavashyaktaon ko poora karte hain. Kyunki yeh seva sirf sanstha pradataon ke dwara uplabdh hai, isliye rishtedaar ko sanstha pradata ka karmachari hona padega.

- A. Rojgar Poorv Kaushal ko pratyabhagi ke varshik vyaktigat budget rashni ke antaragat kharida jaana chahiye.
- B. Rojgar Poorv Kaushal ka bhugtan ghante ke mullya par kiya jaata hai.
- C. Mullya seva prapt karne wale logon ki sankhya par aadharit hoti hai:
1. Vyaktigat (ek pratyabhagi);
 2. 2 se 3 pratyabhagiyon ka chhota samuh; aur
 3. 4 se 5 pratyabhagiyon ka bada samuh.
- D. Rojgar Poorv Kaushal ke liye parivahan ka kharcha:
1. Rojgar Poorv Kaushal ke dauran mullya mein shamil hai;
 2. Rojgar Poorv Kaushal shuru hone wale sthal tak ke liye dar mein shamil nahi hai; aur
 3. Rojgar Poorv Kaushal ke ant hone wale sthal se dar mein shamil nahi hai.
