Neeche di gayi seva ki paribhasha aur seemaen sabhi vivaran aur aavashyaktaon ko shamil nahi karti hain. Seva ke maapdand, seemaon, pradata ke prakar aur yogyata, aur pratipurti ki jaankari ke liye, sambandhit Medicaid HCBS DD Chhoot ka sandarbh lein.

Seva Ki Paribhasha

Remote Samarthan ka arth hai takneek ka upyog jiske madhyam se ek pradata kisi anya sthal se live do-tarfa sanvad ke zariye bhagidar ki sahayata karta hai. Yeh pradata ko bina sharirik roop se maujood hue sensor aur alerts jaise upkaranon ke madhyam se bhagidar ke swasthya aur suraksha ka nigrani karne ki suvidha deta hai jo turant data utpann karte hain.

Remote Samarthan staff ke sath sanvad live ya turant audio aur/ya video ke madhyam se, ya asynchronous (pahle se record ki gayi) takneek ke madhyam se hota hai. Remote Samarthan seva ke dauran jab bhi zarurat ho, staff ko in-person sahayata dene ke liye uplabdh rehna anivarya hai.

Pradan Karne Ki Shartein

- A. Ek bhagidar apni zarurat ke adhar par har seva ka chayan karta hai.
 1. Sevaayein swatantrata aur samudaayik ekikaran ko badhava deni chahiye; aur
 2. Bhagidar ki vyakti-kendrith yojna (PCP) mein chuni gayi chhoot sevaayein aur unhein pradan karne wale vyaktiyon ka ullekh hota hai.
- B. Remote Samarthan ke upkaranon mein nimnalikhit mein se ek ya adhik pranaliyan honi chahiye:
 1. Motion sensing system;
 2. Radio frequency Pehachan;
 3. Live video aur/ya audio feed;
 4. GPS Tracking;
 5. Web-aadharit monitoring system; ya
 6. Aisa koi upkaran jo do-tarfa sanvad ki avashyaktaon ko poora karta ho.
- C. Remote Samarthan prapt kar rahe bhagidar aur unke sath rehne wale pratyek vyakti se likhit roop mein, poori jankari dene ke bad, sahmati lena anivarya hai. Remote Samarthan staff bhagidar ki gatividhiyon ka nigrani karenge aur/ya unke vartalap sunenge us awaas mein jahan Remote Samarthan di ja rahi ho.
- D. Remote Samarthan mein nimnalikhit seva ghatakon ka samavesh hoga:

1. Upkaran: Aise upkaranon ka sthapan jo bhagidar ya anya niwasiyon ki nijta mein dakhla na de, aur jinhein bhagidar zarurat anusaar on/off kar sakta ho.
 2. Seva Prastuti: Seva ka masik kriyavayan aur upkaranon evam vyakti ki zarurat anusaar monitoring.
- E. Remote Samarthan ki nimn seemayein hain:
1. Pradata ko yah sunishchit karna hoga ki Remote Samarthan pradan karne ke liye jo takneeken upyog mein lai ja rahi hain, ve Health Insurance Portability and Accountability Act (HIPAA), Health Information Technology for Economic and Clinical Health (HITECH) Act, aur 45 CFR ke sections 164.102 to 164.534 ki anupalna me ho.
 2. Remote Samarthan ko un samayon par anumodit nahi kiya ja sakta jo Continuous Home, Host Home, Shared Living, ya Youth Continuous Home ke samay se overlap karte ho.
 3. Remote Samarthan is tareeke se pradan kiya jayega jo bhagidar ki nijta ka samman kare aur iska uddeshya daily living activities ka nigrani nahi hoga. Bedroom aur bathroom mein video cameras/monitors ki anumati nahi hai.
 4. Remote Samarthan ka upyog vyakti kendrit nirnay hona chahiye jo community integration mein sahayak ho, aur bhagidar ko samuday ya anya vyaktiyon se alag hone ka jokhim na ho.
 5. Shuruati sthal mein sabhi program ke upkaran ke liye sthal aur data bhejne ki poori kshamata honi chahiye.
 6. Remote Samarthan kisi bhi anya chhoot seva ke samay se overlap nahi kar sakti jismein supervision shamil ho.

Pradata Ki Avashyaktayein

Nichee di gayi jankari mein sabhi pradata ki avashyaktayein shaamil nahi hain. Yeh is vishesh DD seva ke pradataon ke baare mein samanya jankari dene ke liye hai.

- A. Sabhi Chhoot Seva pradataon ko:
1. Medicaid pradata hona chahiye;
 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karna chahiye;
 3. Medicaid aur Dirgha kalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
 4. Department of Health and Human Services (DHHS) dwara mangi gayi training ko poora karna hoga; aur
 5. Sarvabhaumik savdhaniyon ka palan karna chahiye.
- B. Remote Samarthan agency ya svatantra pradata ke dwara pradan ki ja sakti hai. svatantra pradata ko DDD Central Office se manzoori lena anivarya hai.
1. Ek DD sanstha pradata ek company hai jo Medicaid pradata ke roop mein panjikrit hai aur DHHS dwara DD sevaayein pradan karne ke liye pramanit hai aur nimnlikhit ke liye zimmedar hai:
 - a. Un karmachariyon ki bharti aur nigraani jo bhagidar ke saath kaam karte hain;
 - b. Karmachariyon ko unki yogyata, anubhav, aur pradarshit kshamataon ke aadhar par niyukt karna;
 - c. Karmachariyon ko prashikshan pradan karna taaki ve aavashyak star ki dekhbhal dene ke liye yogy ho sakein;
 - d. DHHS ke liye prashikshan yojnaayein uplabdh karane ke liye sahamat hona;

- e. Seva ki paryapt uplabdhata aur gunwatta sunischit karna; aur
 - f. Anya prashasanik kriyaen.
2. Ek DD swatantra pradata ek vyakti ya vikreta hai jo Medicaid pradata ke roop mein registered hai aur ek bhagidar dwara niyukt kiya gaya hai.
 - a. Bhagidar apne pradata ko niyukt karne aur nigrani rakhne ke liye zimmedar hota hai.
- C. Remote Samarthan sva-nirdeshit roop mein pradan nahi kiya ja sakta hai.
 - D. Remote Samarthan ek parivarjan dwara pradan kiya ja sakta hai, lekin ek Legal abhibhavak ya Legally Responsible Individual dwara nahi.
 - E. Jo pradata Remote Samarthan pradan karte hain, unhein nimnalikhit policies aur prakriyaein viksit karni hoti hain:
 1. Bhagidar ke nijta, garima aur samman ke adhikaron ko banaye rakhna, jaise ki prayaog mein lai gayi takneek HIPAA anukool ho.
 2. Bhagidar, abhibhavak (yadi lagu ho), aur anya prabhavit vyaktiyon se likhit sahmati lena aur in sahmatiyon ka record banaye rakhna.
 3. Remote Samarthan ki lagatar uplabdhata sunishchit karna, jismein in-person sahayata ya EMS se sampark shamil ho.
 4. Bhagidar aur caregiver ko upkaran ke upyog ke sambandh mein nirdesh dena.
 5. Bhagidar ko Remote Samarthan upkaranon ke upyog mein lagatar guidance dena.
 6. Samarthan pradan karne wale staff ke liye lagatar prashikshan.
 7. Monitoring ghatnaon ke sambandh mein zaroori record taiyar karna.
