Seva Ki Paribhasha

Awasik Kaushal Vikas – Grihasth Ghar ek kaushal vikas, nirantar seva hai, jo pratyabhagi ko swatantrata se jeene se sambandhit kaushalon aur samudaayik ekikaran se sambandhit kaushalon ka prashikshan deti hai. Is samarthan mein, seva ka naam "Grihasth Ghar" ke roop mein sankshipt kiya gaya hai.

Grihasth Ghar ek niji ghar mein pradan kiya jata hai jo kisi vyakti, jode, ya parivar ke dwara malikana ya kiraye par liya gaya ho, jo bhagidaar ko jaana-pehchaana ho aur jo pradan karta sanstha ka karmachari ho. Grihasth Ghar ka karmachari aur pratyabhagi ek saath rehte hain, aur pratyabhagi apne ghar aur samudaay mein Grihasth Ghar ke parivaar ke saath apni daily life ka anubhav karta hai. Ghar Grihasth Ghar ke karmachari aur pratyabhagi dono ka ekmatra niwas sthal hota hai.

Pradan Karne Ki Shartein

- Ek pratyabhagi apni zarurat ke adhar par har seva ka chayan karta hai.
 - Sevayein swatantrata aur samudaayik ekikaran ko badhava deni chahiye; aur
 - Chuni gayi waiver sevaen aur inhe pradan karne wala vyakti pratyabhagi ke Vyaktigat Sahayak Yojana (ISP) mein darj kiya jata hai.
- Grihasth Ghar mein swasthya dekhbal aur nigraani ke liye madad shamil hoti hai.
- Grihasth Ghar ek kaushal vikas seva hai aur ismein kaushal vikas karyakram shamil hone chahiye. Vyakti vishesh kaushal vikas karyakram chalaye jaane chahiye, aur jab bhi seva pradan ki jaaye, tab har baar data record kiya jaana chahiye.
- Grihasth Ghar ke udaharan mein dincharya ke karyo mein anukoolan kaushalon ka prashikshan shamil hai, jinmein lekin in tak simit nahi hai:
 - Vyaktigat safai;
 - Kapde dhona aur ghar ke kaam;
 - Bhojan tayar karna;
 - Samudaay mein gatividhiyan; aur
 - Samajik aur manoranjan kaushal.
- Grihasth Ghar ki nimmalikhit seemaayein hain:
 - Grihasth Ghar ek samay mein adhik se adhik 3 pratyabhagini ko pradan kiya ja sakra hai.
 - Jo pratyabhagi Grihasth Ghar seva le rahe hain, unhe ek hi din mein Svatantra Jeevan ya Samarthit Parivarik Jeevan seva nahi mil sakti.

3. Jo pratyabhagi Grihasth Ghar seva le rahe hain, unhe Bachon Ki Dink Kaushal Vikas, Aaramik Seva, ya Chikitsa Grihasth Awasi Kaushal Vikas seva nahi mil sakti.
 4. Grihasth Ghar mein koi bhi seva ya seva ka koi hissa shamil nahi ho sakta jo sarvajanik shiksha ke madhyam se uplabdh ho, jinmein shamil hain:
 - a. Pratibhagee ke sthaniya school jila mein chalu karyakram, jismein school ke baad ki dekhbhal aur aise dinon ki sevaayein shaamil hain jab school band ho, jaise ki garmiyon ki chhuttiyan, nirdharit school chhuttiyan, aur shikshak seva divas; aur
 - b. Pratyabhagi ke liye sthaniya school zila dwara nirdharit school ke samay, chahe school ka prakar kuch bhi ho (sarkari, private, ya ghar par).
 5. Grihasth Ghar Medicaid ke madhyam se pradan ki ja rahi anya saman sevaon ke saath na toh samanantar kar sakta hai, na unka badal sakta hai, aur na unhe nakal kar sakta hai.
- F. Ek kiraye ka anubandh, awasik samjhauta, ya likhit samjhauta ka koi anya roop hona chahiye jo pratyabhagi ko malik aur kirayedaar ke kanoon ke anusar nikale jaane se bachane ke liye surakshit kare.
- G. Grihasth Ghar seva ko hospital ke paripeksh mein pradan kiya ja sakta hai jab ek pratyabhagi ko sankatmak upchar ke liye bharti kiya jata hai.
1. Sahayata pratyabhagi ki avashyaktaon ko hospital ke paripeksh mein poora karne aur unke ghar wapas jane ke liye ek sahaj parivartan mein madad karne ke liye design ki gayi hai.
 2. Sahayata mein un kaushalon ka shikshan shamil hai jo pratyabhagi ko unke vartaman swatantrata ke star ko banaye rakhne mein madad karenge, avashyakta anusar vyavhaaric sahayata pradan karna, aur dincharya ke karyo mein sahayata jo pratyabhagi ko unke upchar aur arogya mein hospital mein madad karte hain.
 3. Sahayata mein koi bhi swasthya rakshan kriyaen, upchar, prakriyaen, davaon ka prabandhan, ya abhyas shamil nahi hain, jo hospital ke karmachariyon dwara kiye Jane chahiye.
 4. Jab yeh seva hospital ke paripeksh mein pradan ki jaati hai, to vyakti- kendrit seva yojana ko update kiya jaayega.

Pradata Ki Avashyaktaayein

Nichee di gayi jankari mein sabhi pradata ki avashyaktaayein shaamil nahi hain. Yeh is vishesh DD seva ke pradataon ke baare mein samanya jankari dene ke liye hai.

- A. Waiver ka Sabhi seva pradaataon ko yah karana hogा:
1. Medicaid pradata hona chahiye;
 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
 3. Medicaid aur Dirgha kaalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
 4. Anurodh par DHHS prashikshan poora karna chahiye; aur
 5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.
- B. Grihasth Ghar ek DD sanstha pradata dwara pradan kiya ja sakta hai.
1. Ek DD sanstha pradata ek company hai jo Medicaid pradata ke roop mein panjikrit hai aur DHHS dwara DD sevaayein pradan karne ke liye pramanit hai aur nimnlikhit ke liye zimmedar hai:
 - a. Un karmachariyon ki bharti aur nigraani jo pratibhagee ke saath kaam karte hain;
 - b. Karmachariyon ko unki yogyata, anubhav, aur pradarshit kshamataon ke aadhar par niyukt karna;
 - c. Karmachariyon ko prashikshan pradan karna taaki ve aavashyak star ki dekhbhal dene ke liye yogy ho sakein;
 - d. DHHS ke liye prashikshan yojnaayein uplabdh karane ke liye sahamat hona;
 - e. Seva ki paryapt uplabdhata aur gunwatta sunischt karna; aur

- f. Anya prashasanik kriyaen.
- C. Grihasth Ghar svayam-nirdeshit nahi ho saktा.
- D. Pratyabhagi ka ek rishtedaar, lekin pratyabhagi ka abhibhabak ya anya kanooni roop se zimmedar vyakti nahi, Grihasth Ghar pradan kar sakta hai jab ve anya aavashyaktaon ko poora karte hain. Kyunki yeh seva sirf sanstha pradataon ke dwara uplabdh hai, isliye rishtedaar ko sanstha pradata ka karmachari hona padega.
- E. Grihasth Ghar ko Grihasth Ghar karmachari ka ekmatra nivasi sthaan hona chahiye aur yeh DD sanstha pradata ke dwara maalik ya kiraye par nahi liya ja sakta. Grihasth Ghar karmachari ko pratyabhagi ke saath ghar mein rehna chahiye.
- F. Jab Seva Samanvay ko niyojan ya survey pratikriya ke baare mein koi chinta hoti hai, to SC sanstha pradata ke saath milkar koi bhi update ya sudhar karta hai.
1. Sanstha pradata is baat ke liye zimmedar hai ki sabhi chintayein Grihasth Ghar karmachari ke saath suljhaayi jaayein aur hal ki jaayein.
 2. Seva Samanvay sabhi jama ki gayi surveys aur samagri ko samiksha karta hai aur pratyabhagi ke team ke saath is par charcha karta hai. Ve is prakriya ke kisi bhi charan mein seva pramanikaran ya niyojan ke inkaar ke saath aage badh sakte hain.
 - a. Sewa pramanikaran tab tak manzoor nahi kiya jayega jab tak Grihasth Ghar karmachari ne Home Study Survey poora nahi kiya hai, antim stthiti niyam sthal moolyaankhan mein niyam ke anusar sudhar nahi kiya hai, seva sanyojan ke sthal par chhavi ka avlokan nahi kiya hai, aur ek team meeting nahi hui hai jisme sambhavit niyojan par charcha ki gayi ho.
 - b. Jab stthiti ko manzoori nahi milti, tab sanstha pradan karta, na ki Grihasth Ghar karmachari, nyayik sunwai ki maang kar sakta hai.
- G. Sanstha pradata ko sthal par kiye gaye darshanon ko pramanit karna hogा:
1. Maasik roop se Aadhaarik-Uch Star ke bhagidaron ke liye aur
 2. Maasik do baar Agrim-Jokhim Star ke bhagidaron ke liye.
- H. Har 90 din ke avadhi mein, sanstha pradata ko bina soochna diye aayojit mulakatein karni hoti hain:
1. Kam se kam do mulakatein Moolbhut-Uch Star ke bhagidaron ke liye, aur
 2. Char mulakatein Viksit-Jokhim Star ke bhagidaron ke liye.
- I. Jab ek Grihasth Ghar Mool-Shraman Ucch Star ke bhagidar ko sahayata de raha ho, toh ghar mein kewal do rajya-dwara vittapit vyakti ho sakte hain, jinmein CFS, Parole, aur DD, AD, ya TBI Waivers shamil hain. Jab bhagidar Unnat-Jokhim Star par ho, tab ghar mein koi anya rajya-dwara vittapit vyakti rehne ki anumati nahi hoti.
1. Pratinidhi pradata ko SC ko suchit karna hogा jab koi vyakti, jo kisi bhi HCBS Waiver, CFS, Pariksha, ya kisi anya rajya pradata ke madhyam se vittapit hai, ghar mein rehta ho.
 2. Sewa Samanvayak, CFS, Pariksha Avastha, ya kisi anya rajya pradata ki anumati ko satyapit karega, Grihasth Ghar ko manzoori dene se pehle.
- J. Jab ek Grihasth Ghar Unnat-Jokhim Star par ek Bhagidaar ka samarthan kar raha ho, tab ghar mein do karmachariyon ka poora samay rehna aur awasik seva ke samay mein samvidha ke tahat uplabdh rehna aniwarya hai.
1. Jab kisi Bhagidaar ko ek asthai vishesh vittmantrana ki maang ke liye manzoori milti hai, to Bhagidaar apne vartaman Grihasth Ghar me ek karmchari ke saath asthai vishesh vittmantrana ke dauran reh sakte hain.
- K. Jab kisi Grihasth Ghar ke karmchari ke paas 13 saal se kam umar ke bachche hote hain, to ek aur vyakti ko puri tarah se ghar mein rehna zaroori hota hai aur uska ullekh Ghar Adhyayan Sarvekshan mein hona chahiye, taaki aapda ki stthiti mein bachche ki dekhbhali aur nigrani ki ja sake.

- L. Grihasth Ghar ke karmchari aur Bhagidaar jahan bhi rehte hain, uss nivaas ka apna ek United States Postal seva dwara manyata prapt pata hona chahiye. Alag basement apartments, garage ke upar ke apartments, ya aise apartments jo ghar mein puri tarah se samilit na hon, unhe anumati nahi hai.
- M. Sanstha pradata ka daayitva hai ki wo Therap case notes mein documentation upload kare:
1. Purna Grihasth Ghar Adhyayan Survey;
 2. Kiraya patta, jo Bhagidaar ya abhibhavak dwara sign kiya gaya ho aur
 3. Grihasth Ghar Samjhauta, jo Grihasth Ghar karmchari aur sanstha pradata dwara sign kiya gaya ho.
- N. Bhagidaar dwara chuna gaya pratinidhi karmchari Grihasth Ghar karmchari ke sthaan par istemal kiya ja saktा hai.
1. Pratinidhi karmchari ko yeh karna hogा:
 - a. Pratinidhi karmchari ko Bhagidaar ke ghar mein wahi kaushal vikas sewa pradan karni hogi;
 - b. Bhagidaar ke niyamit samay-suchi ka paalan karna hogi; aur
 - c. Sabhi pradan karta yogyaataon ko pura karna hogi. 2. Pratinidhi karmchari ka upyog bhagidaar ke ISP mein dastavez ke roop mein darj karna hogi.
 3. Pratinidhi karmchari ke upyog ka abhipray sanstha dwara dastavez ke roop mein darj kiya jana chahiye aur SC ke anurodh par uplabdh karaya jana chahiye.
 4. Grihasth Ghar karmchari kisi bhagidaar ke ISP varsh mein 360 ghanto se adhik pratinidhi karmchari ka upyog nahi kar sakte.
 - a. Ek din (10-24 ghante) ka pratinidhi karmchari ka upyog 360 ghanto ke seema mein das ghante ke roop mein gina jayega, jo vyakti ke budget varsh ke liye hai.
 - b. Avyavahrit pratinidhi karmchari ke ghante agle ISP varsh mein nahi jode ja sakte.
- O. Bhagidaar dwara chune gaye sahayak karmchari ka upyog Grihasth Ghar ke karmchari ki madad ke liye kiya ja saktा hai.
1. Sahayak karmchari Grihasth Ghar karmchari ke saath milkar bhagidaar ke liye sevaayein pradan karta hai.
 2. Sahayak karmchari Grihasth Ghar ke karmchari se alag se sevaen pradan nahi kar sakte.
 3. Sahayak karmchari ko yeh karna hogा:
 - a. Bhagidaar ko wahi kaushal vikas ki seva pradan karein;
 - b. Bhagidaar ke niyamit samay-suchi ka paalan karna hogi; aur
 - c. Sabhi pradan karta yogyaataon ko pura karna hogi.
 4. Sahyogi karmchari ka upyog Bhagidaar ke ISP mein dastavejikaran kiya jana chahiye.
 5. Sahyogi karmchari ke upyog ka abhilekh sanstha pradata dwara dastavejit kiya jana chahiye aur aavashyakta par SC ko uplabdh karaya jana chahiye.
 6. Grihasth Ghar karmchari sahayak karyakarta ka nirantar, 24 ghante ka samay istemal nahi kar saktा.
- P. Koi bhi Grihasth Ghar karmchari ya ghar mein rehne wala vyakti apne ghar mein rehne wale kisi bade Bhagidaar ke liye din mein karyakarta ke roop mein seva pradaan nahi kar saktा.
1. Ek Grihasth Ghar karmchari ya ghar mein rehne wala vyakti us sanstha ke liye kaam kar saktा hai jo Bhagidaar ko din mein samarthan pradaan karti hai, parantu ve us Bhagidaar ko seva pradaan nahi kar sakte jo unke saath rehta hai.
 2. Koi bhi Grihasth Ghar karmchari ya ghar mein rehne wala vyakti apne ghar mein rehne wale bade Bhagidaar ko din ke samarthan pradan karne ke liye swatantra pradan karta nahi ban saktा.
- Q. Ek Grihasth Ghar karmchari ya ghar mein rehne wala bada vyakti, 21 varsh ya usse kam umr ke vyakti ko shaikshik samay ke dauran, jab school band ho ya school ki chhutti ho, din bhar ki seva pradan kar saktा hai, yadi ve nivas sanstha ke karmchari ho ya ek swatantra pradan karta ho jise din bhar ki sevaon ke liye vishesh anumati prapt ho.
- R. Jab ek bhagidaar Grihasth Ghar sevaen prapt kar raha ho, tab sanstha pradan karta bhagidaar ki dekbhalki ke liye zimmedar hota hai aur Grihasth Ghar karmchari ko 24/7 madad pradan karni hoti hai jab

zarurat ho. Bhagidaar ki team ko ISP mein ek sahayak yojna ka dastavez karna hota hai jo sankat ya apaatkalin paristhitiyon ke samay ke liye ho.

- S. Bhagidaar ke liye sahayak yojnaen vyakti ke kendrit honi chahiye, jo itihaasik aur sambhavit bhavishya ki avashyaktaon ko pura kar sakein, aur ye bhi pehchana jaye ki bhagidaar ne yeh yojna chuni hai.
- T. Kisi bhi Grihasth Ghar ka punaravlokan tab kiya jayega jab wahan kuch bhi badlav hogा, jaise karmchari ka badlav, seva ka sthal badalna, niwasi ka badalna, ya Grihasth Ghar mein kisi bhi prakar ka badlav. Grihasth Ghar ke karmchari ko kabhi bhi un bhagidaaron ki swasthya, suraksha aur kalyan ko banaye rakhne ke liye samapt kiya ja sakta hai.

- A. Grihasth Ghar ko bhagidaar ke varshik vyaktiagat bajat ke andar kharidi jaana chahiye.
B. Grihasth Ghar ko pratidin mullya par pratipurti ki jaati hai.
 1. Pradata ko 24-ghante ke samay ke dauran, 12:00 am se 11:59 pm tak, pratyabhagi ke saath kam se kam das ghante ya usse adhik samay tak aawas mein rehna chahiye.
 2. Jab 24-ghante ke samay ke dauran, 12:00 am se 11:59 pm tak, das ghante se kam samay ke liye seva pradan ki jaati hai, to pradata ko dainik mullya ka aadha bhugtan kiya jaayega.
 3. Din ke 10 ghante ka kuch hissa ya poora samay pradata aur pratyabhagi neend mein ho sakta hai, jab tak yeh pratyabhagi ke ISP ke anusar uchit ho aur sabhi avashyaktaayein poori ki ja rahi ho.
- C. Yatra ka kharcha hai:
 1. Grihasth Ghar ke dauran mullya mein shamil hai;
 2. Grihasth Ghar jahan se shuru hota hai uss sthal tak mullya mein shamil hai; aur
