Viklang Bachchon Ka Karyakram (DCP)

Yeh karyakram viklang bachchon ki madad karta hai aur unhe gair-chikitsiya sevaon aur samarthan ke bhugtan me madad pradan karta hai. Sevaayein avashyaktaon ke ek moolyankan se tay ki jati hain aur parivaar ke saath milkar viksit kiye gaye plan me darshayi jati hain.

Is karyakram ke liye patr hone ke liye, bachcha 16 varsh se kam umr ka hona chahiye, Nebraska ka nivasi hona chahiye, vartaman me SSI sthiti prapt honi chahiye, aur apne parivaar ke saath ghar me rehna chahiye. Is karyakram ke liye Medicaid patrata ki aavashyakta nahi hai.

Viklang Vyakti aur Parivaar Samarthan (DPFS)

Yeh karyakram un sabhi umron ke logon ki madad karta hai jinko kisi licensed chikitsak dwara diagnosed ek gambhir, dirghakaalik viklangta hai. Yeh karyakram parivaarik ekta banaye rakhne, svatantra jeevan ki sthiti banaye rakhne, aur viklang vyaktiyon ke rozgaar me bane rehne ya rozgaar prapt karne me sahayak hai.

Patr paye gaye aavedakon ko anumodit sevaon ke liye \$400 prati mahina ya \$4,800 prati varsh tak ki rashi mil sakti hai.

Is karyakram ke liye Medicaid patrata ki aavashyakta nahi hai. Yeh karyakram vyakti ko kisi anya karyakram dwara prapt ya patr sevaon ko dhohra nahi sakta. Yeh karyakram anya karyakramon dwara poorn roop se cover na ki gayi anumodit sevaon ke liye atyirikt roop me arthik madad pradan kar sakta hai.

Anuvanshik Viklang Vyakti Karyakram (GHPP)

Yeh karyakram 21 varsh ya usse adhik umra ke vyaktiyon ke liye vishesh chikitsiya sevaayein pradan karta hai jo Cystic Fibrosis, Hemophilia, aur/ya Sick Cell rog se peedit hain.

Is karyakram ke liye Medicaid patrata ki aavashyakta nahi hai.

Jeevankal Vishram (Lifespan Respite)

Yeh karyakram dekhbhal karton ko un vyaktiyon ki nirantar dekhbhal ki maang se rahat dene ke liye design kiya gaya hai jo apni khud ki dekhbhal karne me asamarth hain. Patr bina-vetan mukhya parivaarik dekhbhal karton ko vishram sevaayein kharidne ke liye arthik sahayata pradan karta hai.

Patr hone ke liye, dekhbhal karta ko:

1. Bina kisi pratipurti ya bhugtaan ke vishesh avashyakta wale aavedak ya praptakarta ki dekhbhal ya nirikshan kar rahe hon;
2. Vishram sevaon ki aavashyakta honi chahiye;
3. Vishesh avashyakta wale vyakti ke saath ek hi ghar me rehna chahiye ya kam se kam 4 ghante prati din, Ravivaar se Shanivaar tak, praptakarta ke ghar me dekhbhal pradan karni chahiye; aur
4. Rozgaar sambandhit kriyaon ke dauraan vishram sevaon ka upayog nahi karna chahiye.

Is karyakram ke liye Medicaid patrata ki aavashyakta nahi hai. Yeh karyakram vyakti ko kisi anya karyakram dwara prapt ya patr sevaon ko dhohra nahi sakta.

Chikitsiya Roop Se Viklang Bachchon Ka Karyakram (MHCP)

Yeh karyakram vishesh swasthya dekhbhal avashyakta wale bachchon aur yuvaon ke liye vishesh chikitsiya sevaayein pradan karta hai. Sevaon me seva samyojan/case prabandhan, vishesh chikitsiya team dwara moolyankan, vishesh chikitsakon tak pahunch, aur anumodit chikitsiya sevaon ka bhugtan shaamil hai.

Is program ke liye patrata ke liye, vyakti ki umr 21 saal se kam honi chahiye, Nebraska ka nivasi hona chahiye, ek yogy chronic chikitsiya sthiti ka diagnosis prapt hona chahiye, aur ek sakriya vyaktigat chikitsiya upchar yojna honi chahiye. Is karyakram ke liye Medicaid patrata ki aavashyakta nahi hai.
