Seva Ki Paribhasha

Samarthit Rojgar – Vyaktiगत ek kaushal vikas seva hai jo ek naukri prashikshak pradan karta hai, jisse ek pratyabhagi ko vyakti ke liye vyakti shikshan ke madhyam se pratispardhi sammilit rojgar mein kaam banaye rakhne mein madad milti hai. Samarthit Rojgar – Vyaktiगत ko ek sammilit samudaayik rojgar ke parivesh mein pradan kiya jana chahiye.

Pradan Karne Ki Shartein

- A. Ek pratyabhagi apni zarurat ke adhar par har seva ka chayan karta hai.
 - 1. Sevayein swatantrata aur samudaayik ekikaran ko badhava deni chahiye; aur
 - 2. Chuni gayi waiver sevaen aur inhe pradan karne wala vyakti pratyabhagi ke Vyaktiगत Sahayak Yojana (ISP) mein darj kiya jata hai.
- B. Samarthit Rojgar – Vyaktiगत mein shamil hain:
 - 1. Kaushal vikas karyakram jo rojgar se sambandhit kaushalon ko banaye rakhne aur badhane ke liye hote hain;
 - 2. Pratyabhagiyon ko kaam ke sthal par sahyogi karmachariyon se jodna aur pratyabhagi ke liye samarthan karna;
 - 3. Naukri prashikshak ki avashyakta ko kam karne ke liye ek yojana viksit karna; aur
 - 4. Pratyabhagi ko rojgar network, Ticket to Work sevaayein, Rojgar Protsahan Yojana aur Sahayata (WIPA) sevaayein, ya anya yogy rojgar seva karyakramon ke liye sandarbh karna, jo labh yojana ki suvidha pradan karte hain.
- C. Samarthit Rojgar – Vyaktiगत ek kaushal vikas seva hai aur ismein kaushal vikas karyakram shamil hone chahiye. Vyakti vishesh kaushal vikas karyakram chalayae jaane chahiye, aur jab bhi seva pradan ki jaaye, tab har baar data record kiya jaana chahiye.
- D. Samarthit Rojgar – Vyaktiगत mein apna vavsay shamil ho sakta hai. Apna vavsay chalana ka matlab hai:
 - 1. Labhdayak vavsay chalana aur vishesh maal, utpad ya chukta ki jaane waali sevaayein pradan karke paise kamaana;
 - 2. Apne vavsay ya peshe se sidhe aay kamana, jo pratyabhagi dwara sidhe chalaya jata ho; aur
 - 3. Vavsay ka kam se kam 51% hissa apne paas rakhna.

- E. Is seva ka ek hissa virtual roop se diya ja sakta hai, jo ki is tak simit nahi hai, balki شامل hai:
1. Pratyabhagi ki zarurat ko shabdik sanket aur anya sahayata ke madhyam se poora kiya ja sakta hai, jo virtual roop se pradan ki ja sakti hai;
 2. Yeh moolik aur madhyam stariya funding ke antaragat pratyabhagiyon ke liye uplabdh hai;
 3. Har hafte pradan kiye gaye Samarthit Rojgar – Vyaktiagat ka pramukh hissa vyakti ke roop mein pradan kiya jana chahiye;
 4. Online sahayata ke liye kul milaye gaye ghante hafte mein 10 ghante se adhik nahi ho sakte; aur
 5. Yeh 10 ghante din sevaon ke 35 ghante per hafte ki seema mein شامل hain.
- F. Samarthit Rojgar – Vyaktiagat ke udaharan ho sakte hain, lekin in tak simit nahi hain:
1. Kaam ka samay pata karna;
 2. Sahyogi karmachariyon ke saath kaam karna;
 3. Kaam ki zaruraton par boss se baat karna; ya
 4. Naukri ki ummeedon ko samajhna.
- G. Samarthit Rojgar – Vyaktiagat ke kuch niyam hain:
1. Samarthit Rojgar – Vyaktiagat ko tabhi manzoori di ja sakti hai jab pratyabhagi VR ke mahatvapurn padav poora kar chuka ho.
 - a. Yeh un logon ke liye manzoori nahi di ja sakti jo apne aap naukri dhoondh chuke hain; ya
 - b. Un sthitiyon ke liye jahan ek pradata ne vyavsayik punarvasan prakriya ke bahar, anaupcharik roop se pratyabhagi ko sahayata di ho.
 2. Samarthit Rojgar – Vyaktiagat DD pradata dwara malik ya chalaya gaya sthal mein nahi ho sakta.
 3. Ek pratyabhagi Samarthit Rojgar – Vyaktiagat ko anya din sevaon ke saath prapt kar sakta hai, lekin kul milaye gaye ghante hafte mein 35 ghante se adhik nahi ho sakte. Ek hafte ko is prakar paribhashit kiya jaata hai: 12:00 am Somvaar se lekar 11:59 pm Ravivaar tak. Anya din sevaayein hain:
 - a. Vyask Din;
 - b. Vavhaarika Ghar Par Kaushal Vikas;
 - c. Samudaayik Samanvay;
 - d. Dinik Samarthan;
 - e. Chikitsa Ghar Par Kaushal Vikas;
 - f. Vavsayik prashikshan se pehle ka;
 - g. Samarthit Rojgar – Anukaran Seva; aur
 - h. Vavsayik Punarvasan naukri ki talash aur naukri coaching.
 4. Ek vavsayik ghar ke vyavsay se aayi ko minimum mazdoori ki avashyaktaon ko pura karne ki zarurat nahi hoti.
 5. Samarthit Rojgar – Vyaktiagat mein koi bhi seva ya seva ka hissa شامل nahi ho sakta jo sarvajanik shiksha ke madhyam se uplabdh ho, شامل hain:
 - a. Pratibhagee ke sthaniya school jila mein chalu karyakram, jismein school ke baad ki dekhbhal aur aise dinon ki sevaayein shaamil hain jab school band ho, jaise ki garmiyan ki chhuttiyan, nirdharit school chhuttiyan, aur shikshak seva divas; aur
 - b. Pratibhagee ke liye sthaniya school jila dwara nirdharit school ke samay ke dauran, chahe school ka prakar kuch bhi ho (sarvajanik, private, ya ghar par); aur
 - c. Jo shikshan seva ke ghante pradan kiye jaate hain ya uplabdh hote hain, unhe kul milaye gaye din seva ke ghanton mein shaamil kiya jaata hai, jo ki hafte mein 35 ghante se adhik nahi ho sakte.
 6. Samarthit Rojgar – Vyaktiagat Medicaid ke madhyam se pradan kiye gaye anya saman sevaon ke saath na toh samanantar kar sakta hai, na unka badal sakta hai, aur na unhe nakal kar sakta hai. Yeh seva ek doosre ke sthaan par ya uska pratinidhitva nahi kar sakti.

Pradata Ki Avashyaktaayein

- A. Waiver ka Sabhi seva pradaataon ko yah karana hoga:
1. Medicaid pradata hona chahiye;
 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
 3. Medicaid aur Dirgha kaalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
 4. Anurodh par DHHS prashikshan poora karna chahiye; aur
 5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.
- B. Samarthit Rojgar – Vyaktiagat DD sanstha pradata ya swatantra pradata dwara pradan kiya ja sakta hai.
1. Ek DD sanstha pradata ek company hai jo Medicaid pradata ke roop mein panjikrit hai aur DHHS dwara DD sevaayein pradan karne ke liye pramanit hai aur nimnlakhit ke liye zimmedar hai:
 - a. Un karmachariyon ki bharti aur nigrani jo pratibhagee ke saath kaam karte hain;
 - b. Karmachariyon ko unki योग्यता, अनुभव, aur pradarshit kshamataon ke aadhar par niyukt karna;
 - c. Karmachariyon ko prashikshan pradan karna taaki ve aavashyak star ki dekhbhal dene ke liye योग्य हो सके;
 - d. DHHS के liye prashikshan yojnaayein uplabdh karane के liye सहमत होना;
 - e. Seva ki paryapt uplabdhata aur gunwatta sunishchit karna; aur
 - f. Anya prashasanik kriyaen.
 2. Ek DD swatantra pradata ek vyakti ya vikreta hai jo Medicaid pradata के roop mein registered hai aur ek bhagidaar dwara niyukt kiya gaya hai.
 - a. Bhagidaar apne pradata ko niyukt karne aur nigrani rakhne के liye zimmedar होता है.
- C. Samarthit Rojgar – Vyaktiagat ko apne aap से चला सके हैं.
- D. Samarthit Rojgar – Vyaktiagat ko ek rishtedar dwara pradan kiya ja sakta hai, lekin pratyabhagi के kanooni zimmedar vyakti ya abhibhabak dwara nahi.
- E. Pratyabhagi ka ek rishtedar, lekin abhibhabak ya pratyabhagi के anya kanooni zimmedar vyakti nahi, jab वे anya avashyaktaon ko pura karte हैं, tab Samarthit Rojgar – Vyaktiagat pradan कर सके हैं.

Mullya

- A. Samarthit Rojgar – Vyaktiagat ko pratyabhagi के varshik vyakti budget rashi के andar kharida jana chahiye aur iske liye team charcha ki avashyakta hoti hai taaki yah sunishchit kiya ja sake ki uchit dar के karan vittiya saadhan uplabdh हैं.
- B. Samarthit Rojgar – Vyaktiagat ko prati ghante के hisaab से muawza diya jata hai.
- C. Waiver rashi ka upyog nahi kiya ja sakta:
1. Pratibhagee ki mazdoori को देने या usme जोदने के liye; या
 2. Vavsay को प्रोत्साहन भत्ता या अनुदान देने के liye, या अनुचित व्यवसायिक प्रशिक्षण खर्चों के liye.
- D. Yatra ka kharcha hai:
1. Samarthit Rojgar – Vyaktiagat के मूल्या में शामिल है;
 2. Samarthit Rojgar – Vyaktiagat के मूल्या में उस स्थल को शामिल नहीं किया जाता जहाँ से Samarthit Rojgar – Vyaktiagat शुरू होता है; और
 3. Samarthit Rojgar – Vyaktiagat के मूल्या में उस स्थल को शामिल नहीं किया जाता जहाँ से Samarthit Rojgar – Vyaktiagat समाप्त होता है.
