Seva Ki Paribhasha

Samarhit Rojgar – Anukaran Seva ek seva hai jo HCBS Samarthit Mastisk Ghatna (TBI) Waiver ke bhagidaron ke liye hai. Yeh ek se ek samarthan pradan karti hai jo ek bhagidaar ko apni vartaman rojgari banaye rakhne mein madad karti hai.

Sevayein mein kaam ki jagah par safalta ka moolyankan karna; sthaniya roop se chhoti avadhi ke liye kaushal sahayata pradan karna; prakritik samarthan ko viksit aur badhava dene ke liye prashansha dena; aur bhagidaar ko apne kaam se sambandhit maqsadon ke liye niyoktaon, sahyogiyon, ya grahak ke saath apne liye madad karne mein sahayata pradan karna shamil hai.

Pradan Karne Ki Shartein

- A. Is seva ki avashyakta ko bhagidaar ke moolyaankan ke dauran pehchana jaana chahiye aur bhagidaar ki vyakti-kendrit yojana (PCP) mein shamil kiya jaana chahiye.
- B. Vyakti-kendrit yojana (PCP) mein nimnlikhit ka abhipray hona chahiye:
 1. Samarthit Rojgar – Anukaran Seva ki avashyakta;
 2. Rojgar sahayata ko jaari rakhne ke karan;
 3. Seva ke liye avashyak ghanton ki sankhya; aur
 4. Seva ko kam karne aur samapt karne ke liye likhit parinaam yojana.
- C. Pradata ek samay mein ek se adhik bhaagidar ko seva nahi de sakte, jab tak bhaagidar ki PCP mein anya roop se na likha ho.
- D. Pradata mahine ke samapan report tayar karne ke liye zimmedar hai, jisme pragati ya pragati ki kami, aur bina sahayata ke svatantra rojgar ki aur badhne ki gati shamil ho. Pradata ko reports Seva Samanvayak ke liye upalabdh karni chahiye.
- E. Kam se kam mahine mein ek baar Seva Samanvayak aur bhagidaar bhagidaaro ki PCP ka nigrani karenge. Isme waiver sevaon ke upyog ya anuupyog ka nigrani karna shamil hai.
- F. Vyaktigat dekbhaal aur ADLs mein madad is seva ka hissa nahi hai.
- G. Swayamsevak kaam is seva ka hissa nahi hai.
- H. Beech-beech mein sahayata sthaniya roop se, door se, aur bhagidaar ke liye ya unki or se pradan ki ja sakti hai. Yeh pradata ke karmchari aur bhagidaar ke niyokta ke beech phone call ke jariye ho sakti hai, jisme bhagidaar ke saath aamne-samne milkar kaam ko majboot aur sthir karne ke liye puna: samarthan kiya jata hai.
- I. Yeh seva un gatividhiyon ko shamil karti hai jo bhagidaar dwara vetan prapt kaam ko banaye rakhne ke liye avashyak hoti hain, aur yeh kaam ko banaye rakhne ya aage badhane ke liye banayi gayi hai.
- J. Samarthit Rojgar – Anukaran Seva mein samuhi gatividhiyan shamil nahi hoti hain, jaise ki kaam karne wale dal, seva ke dauran baithakein, karmchari vikas, vibhag ki baithakein, ya koi aur gatividhiyan jo bhagidaar se sambandhit nahi ho, jisme pradata bhagidaar ki jagah kaam kare.
- K. Ek bhagidaar ko kam se kam mazdoori milni chahiye, lekin usse kam nahi, jo ki pradata dwara usi ya saman kaam ke liye bina viklangta wale vyakti ko di jati hai, usi ke anuroop mazdoori aur laabh ke star par.

- L. Samarthit Rojgar – Anukaran Seva ko Samudaayik Jodon aur Samarthit Rojgar – Vyakti ke saath milakar manzoor kiya ja sakta hai, lekin yeh sevaayein ek hi samay mein pradan aur bill nahi ki ja sakti.
- M. Yeh seva un bhagidaaron ke liye jo school sevaon ke liye yogya hain, sthaniya school jila dwara nirdharit school ghamton ke dauran manzoor nahi ki jaati.
 - 1. Yeh seema sabhi sarvajanik shiksha karyakramon par lagu hoti hai jo Viklangta Wale Vyakti Shiksha Adhiniyam (IDEA) ke tahat vittaposhit hote hain.
 - 2. Jo bhagidaar ghar par shiksha prapt karte hain, unke liye niyamit vidyalaya ke samay aur din lagu hote hain.
- N. 18 se 21 varsh ki aayu ke bhagidaaron ke liye, yeh dastavej unke file mein rakha jana chahiye jo yeh spasht kare ki yeh seva 1973 ke Punarvasan Adhiniyam ke section 110 (Vyavsayik Punarvasan Seva) ya IDEA (20 U.S.C. 1401 et seq.) ke antargat anudit karyakram mein uplabdh nahi hai. Dastavej mein yeh spasht hona avashyak hai ki bhagidaar Vyavsayik Punarvasan Seva ke pratiksha suchi mein hai aur yah seva karyakram ki pratiksha suchi ke karan uplabdh nahi hai.
- O. Rashtriya vittiya yogdan ko protsahan bhugataan, sabsidee, ya anuchit vyavsayik prashikshan kharchon ke liye dawa nahi ki ja sakti, jaise ki:
 - 1. Naukri pradata ko is liye paise dena ki taaki pradata ko samarthit rojgar karyakram mein bhag lene ke liye protsahit ya sahayata mil sake;
 - 2. Samarthit rojgar karyakramon ke upbhoktaon ko diye gaye paise; ya
 - 3. Bhagidaar ke samarthit rojgar karyakram se seedhe sambandhit na hone wale prashikshan ke liye ki gayi bhuktan.
- P. Samarthit Rojgar – Follow-Along seva ek rishtedaar dwara pradan ki ja sakti hai, lekin bhagidaar ke liye kanoonan zimmedar vyakti dwara nahi.
- Q. Yeh seva Medicaid rajya yojna, anya HCBS waiver sevaon, ya Vyavsayik Punarvasan ke tehat pradan ki gayi anya tulhatmak sevaon ke saath milti-julti, unka sthan lene ya unhe dohraane wali nahi honi chahiye.
- R. Is TBI waiver seva ko anumati dene se pehle bhagidaar ko Vyavsayik Punarvasan sevaon ke liye prerit karna anivarya hai.

Pradata Ki Avashyaktaayein

- A. Waiver ka Sabhi seva pradaataon ko yah karana hogा:
 - 1. Medicaid pradata hona chahiye;
 - 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
 - 3. Medicaid aur lambe samay Dekhbhaal Seva Pradata Samjhauta mein varnit maapdandhon ka paalan karna;
 - 4. Anurodh par DHHS prashikshan poora karna chahiye; aur
 - 5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.
- B. TBI Waiver ke pradataon ko Samarthit Rojgar – Anukaran Seva pradan karne se pehle, DHHS ke dwara anumodit TBI prashikshan poora karna avashyak hai.
- C. Samarthit Rojgar – Anukaran Seva pradan karne wale pradataon ko pratyek bhagidaar ki chikitsiya aur vyaktigat avashyaktaon ki paryapt jankari prapt karni chahiye aur unme hone wale sabhi parivartan ka nigrani aur report Seva Samanvayak ko karni chahiye.
- D. Ek pradata vyakti ya sanstha dono ho sakta hai.
- E. Har sanstha pradata ko yeh sab karna hogा:
 - 1. Apne karmchariyon ko unki yogita, anubhav, aur pradarshit kshamtaon ke aadhaar par niyukt karna;
 - 2. Karmchariyon ko prashikshan pradan karna taaki ve avashyak dekhbhal ke star ko pradan karne ke liye yogya ho sakein;
 - 3. Prashikshan yojnaayein DHHS ke liye uplabdh karane par sahmat hona; aur
 - 4. Seva ki praptita aur gunvatta ko sunishchit karna.
- F. Is seva ko pradan karne wale sabhi karmchariyon ke paas avashyak shiksha aur anubhav hona chahiye aur avashyakta padne par pramaan prastut karna hogा:

1. Shiksha, manovaigyanik, samajik kary, samajshastra, manav seva, ya kisi sambandhit kshetra mein bachelor's degree ya samanya pathyakram/prashikshan; ya
 2. Kam se kam 4 saal ka peshewar anubhav hona chahiye jo viklangta wale vyaktiyon (IDD) ke liye kaushal vikas ya rojgar se sambandhit seva pradan karne mein ho; ya viklangta sambandhit karyakram likhne aur data sankalan/visleshan mein anubhav ho; ya IDD wale vyakti ke jeevan shikshan aur samarthan mein 4 saal ka jeevan anubhav ho; ya
 3. Upar varnit shiksha aur anubhav ke sangam ka koi bhi sanyojan ho jo kam se kam 4 saal ya usse adhik ho.
- G. Samarthit Rojgar – Anukaran Seva pradan karne wala pradata, seva prapt karne wale bhagidaar ka niyokta nahi ho sakta.

Mullya

- A. Samarthit Rojgar – Anukaran Seva ke liye mullya DHHS dwara nirdharit ki jaati hain aur ye har saal badal sakti hain.
- B. Samarthit Rojgar – Anukaran Seva ko ghante ke hisaab se muavza diya jaata hai.
- C. Jab seva un kaam ke sthal par pradan ki jaati hai jahan bina viklangta wale log kaam karte hain, toh bhugtan sirf un badlaavon aur prashikshan ke liye kiya jaata hai jo bhagidaar ko unki viklangta ke kaaran zarurat hoti hai.
 1. Yeh us prashikshan ke liye bhugtan nahi karta jo vyavsayik sthal par ek samanya hissa ke roop mein prabandhan ke kaam ke roop mein diya jaata hai.
 2. Niayokta ab bhi sabhi niyamit aur samanya rojgar sambandhi mamalon ke liye zimmedar hai.
- D. Waiver fund ka upyog bhagidaar ki mazdoori dene ya usme vruddhi karne ke liye nahi kiya ja sakta.
- E. Samarthit Rojgar – Anukaran seva pradan karte samay avashyak parivahan ko mullya mein shamil kiya gaya hai.
- F. Rozgar sthal par aur wapas aane ke liye yatra ko is mullya mein shamil nahi kiya gaya hai.
