TBI WAIVER KE LIYE KAUN ELIGIBLE HAI?

TBI Waiver ke liye eligible hone ke liye, ek participant ki umra 18 saal ya usse zyada honi chahiye, use Nebraska Medicaid ke liye eligible hona chahiye, traumatic brain injury ka diagnosis hona chahiye,* nursing facility ke liye care ka level poora karna chahiye, aur waiver sevaayein ki zaroorat honi chahiye.
