Seva Ki Paribhasha

Parivartan seva ek baar ke grah sthapan kharchon aur sahayataon mein madad karti hai jo ek bhagidaar ko ek sansthanik sthiti se niji ghar mein sthaanantaran karne mein madad karti hai taaki ve Medicaid HCBS DD Waiver sevaen prapt kar saken. Parivartan seva ko manzoori mil sakti hai jab bhagidaar ke paas grah kharchon ke liye paisa na ho.

Pradan Karne Ki Shartein

- A. Ek pratyabhagi apni zarurat ke adhar par har seva ka chayan karta hai.
 - 1. Sevayein swatantrata aur samudaayik ekikaran ko badhava deni chahiye; aur
 - 2. Chuni gayi waiver sevaen aur inhe pradan karne wala vyakti pratyabhagi ke Vyaktigat Sahayak Yojana (ISP) mein darj kiya jata hai.
- B. Parivartan seva mein nimnalikhit kharch shamil hain:
 - 1. Avashyak grih upkaran;
 - 2. Grih upkaran;
 - 3. Suraksha jama, jaise ki ek mahine ka kiraya jo nuksan ke liye rakha jaye;
 - 4. Mool upbhogta shulk ya jama, jaise paani, gas, aur bijli; ya
 - 5. Ghar badalne ke kharch.
- C. Parivartan seva ek kaushal vikas seva nahi hai.
- D. Parivartan seva ki nimnalikhit simaayein hain:
 - 1. Parivartan seva ka upyog pradan karta dwara malik ya kiraye par diye gaye, chalayaye gaye, ya niyantrit ghar mein sthaanantaran ke liye nahi kiya ja sakta.
 - 2. Parivartan seva ek bhagidaar ko Nebraska mein kisi sansthan se niji ghar mein sthaanantaran karne ke liye uplabdh hai. Parivartan seva ka upyog keval nimnalikhit sansthanik sthalon se sthaanantaran karte samay kiya ja sakta hai:
 - a. Manasik viklangtaon ke liye madhyam star ki dekhbhal suvidha (ICF/IID);
 - b. Ek kushal nursing suvidha; ya
 - c. Ek kshetriya kendra.
 - 3. Parivartan seva ka upyog kiraya ya kiraye ka jama dene ke liye nahi kiya ja sakta jo sthal ko rokne ke liye ho.
 - 4. Parivartan seva ka upyog vyaktigat dekhbhal vastuon, khana, kapde, ya aise vastuon aur sevaon ke liye nahi kiya ja sakta jo avashyak nahi hain.

5. Ek pradata apne sevaon ke liye unse jyada shulk nahi le sakta jo ve samanya janata se lete hain. Ek pradata jo kuchh vishesh logon, jaise chhatron ya vrudhdhon, ko chhoot deta hai, usse usi group ke pratyabhagi ko bhi wahi chhoot deni chahiye.
6. Parivartan seva ka upyog Medicaid ke madhyam se diye ja rahe anya milti-julti sevaon se na to takraane, na hi badalne, na hi dohrane ke liye kiya ja sakta.

Pradata Ki Avashyaktaayein

Nichee di gayi jankari mein sabhi pradata ki avashyaktaayein shaamil nahi hain. Yeh is vishesh DD seva ke pradataon ke baare mein samanya jankari dene ke liye hai.

- A. Waiver ka Sabhi seva pradataon ko yah karana hoga:
 1. Medicaid pradata hona chahiye;
 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
 3. Medicaid aur Dirgha kaalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
 4. Anurodh par DHHS prashikshan poora karna chahiye; aur
 5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.
- B. Parivartan seva DD Sanstha pradan karta ya svatantra pradan karta dwara pradan ki ja sakti hai.
 1. Ek DD sanstha pradata ek company hai jo Medicaid pradata ke roop mein panjikrit hai aur DHHS dwara DD sevaayein pradan karne ke liye pramanit hai aur nimnlikhit ke liye zimmedar hai:
 - a. Un karmachariyon ki bharti aur nigraani jo pratibhagee ke saath kaam karte hain;
 - b. Karmachariyon ko unki yogyata, anubhav, aur pradarshit kshamataon ke aadhar par niyukt karna;
 - c. Karmachariyon ko prashikshan pradan karna taaki ve aavashyak star ki dekhbhal dene ke liye yogya ho sakein;
 - d. DHHS ke liye prashikshan yojnaayein uplabdh karane ke liye sahamat hona;
 - e. Seva ki paryapt uplabdhata aur gunwatta sunischit karna; aur
 - f. Anya prashasanik kriyaen.
 2. Ek DD swatantra pradata ek vyakti ya vikreta hai jo Medicaid pradata ke roop mein registered hai aur ek bhagidaar dwara niyukt kiya gaya hai.
 - a. Bhagidaar apne pradata ko niyukt karne aur nigrani rakhne ke liye zimmedar hota hai.
- C. Parivartan seva ko svayan nirnayit kiya ja sakta hai.
- D. Ek bhagidaar ka rishtedaar, lekin ek abhibhabak ya kisi anya kanuni roop se zimmedar vyakti, jab ve anya aavashyaktaen पूरी करते हो, tab parivartan seva pradan kar sakte hain.
