Neeche di gayi seva ki paribhasha aur seemaen sabhi vivaran aur aavashyaktaon ko shamil nahi karti hain. Seva ke maapdand, seemaon, pradata ke prakar aur yogyata, aur pratipurti ki jaankari ke liye, sambandhit Medicaid HCBS DD Waiver ka sandarbh lein.

### Seva Ki Paribhasha

Parivahan ek seva hai jo Medicaid HCBS DD Waiver sevaon, samudaayik gatividiyon, aur sansadhan ke liye chikitsa se sambandhit na hone wala parivahan pradan karti hai. Yeh ek swatantra seva hai, jo anya waiver sevaon mein shamil parivahan se alag hai.

### Pradan Karne Ki Shartein

- A. Ek pratyabhagi apni zarurat ke adhar par har seva ka chayan karta hai.
  1. Sevayein swatantrata aur samudaayik ekikaran ko badhava deni chahiye; aur
  2. Chuni gayi waiver sevaen aur inhe pradan karne wala vyakti pratyabhagi ke Vyaktigat Sahayak Yojana (ISP) mein darj kiya jata hai.
- B. Parivahan ek achhe kaam karte hue vahan mein pradan kiya jana chahiye, jo pratyabhagi ki zaruraton ko pura karta ho, jaise wheelchair lift jaise avashyak sudhaar.
- C. Sahmat ho aur sunishchit karein ki nimnlikhit vahan manako ka palan kiya gaya ho:
  1. Sabhi lagu shehron, jilon, rajyon, aur kendriya niyamon ke antargat license, panjikaran, aur bima policies ke sambandh mein paalan kiya gaya ho;
  2. Yadi Lok Seva Aayog ya Nebraska Sadak Vibhag dwara niyantrit hai, to vahan suraksha aur maintenance ke liye sabhi niyamik aavashyaktaon ka paalan kiya gaya ho;
  3. Jab pratyabhagi ko le ja rahe ho, vahanon mein dhumrapan ki ijazat na dena; aur
  4. Yeh sunishchit karein ki suraksha bandhan, jaise gaadi seat/booster seat, pratyek pratyabhagi ke liye upalabdho aur unka sahi upyog ho sake.
- D. Parivahan ek kaushal vikas seva nahi hai.
- E. Parivahan ke udaharan ismein shaamil hain, lekin inhee tak simit nahi hain:
  1. Parivahan jo ek DD pradata dwara pradan kiya jata hai;
  2. Taxi ya anya gaadi seva; ya
  3. Haandi van pass ya sheher bus pass ki kharid.
- F. Parivahan ki nimnalikhit simaayein hain:

1. Parivahananya vikalpon, jaise prakritik samarthan, ko badal nahi sakta. In vikalpon ka poori tarah se upyog kiya jana chahiye aur yeh shamil ho sakte hain:
  - a. Sthaniya samudaayik vriddh sevaon se vishesh parivahan;
  - b. Pratyabhagi ke Medicaid Prabandhit Seva Sangathan (MCO) dwara pradan kiye gaye chikitsa sambandhi parivahan sevaayein; aur prakritik samarthan, jisme parivaar, dost, aur sahkarmiyon ka shamil hona.
2. Parivahan mein chikitsa sambandhi mulakaton ke liye parivahan shamil nahi hai.
  - a. A-apatkalin chikitsa parivahan pratyabhagi ke MCO ke madhyam se pradan kiya jata hai.
3. Parivahan pratyabhagi ko ek sthal par jane aur wahan se lautne ke liye sabse seedha rasta istemal karke pradan kiya jata hai.
4. Parivahan Medicaid ke madhyam se pradan kiye gaye anya saman sewaon ke saath na toh samanantar kar sakta hai, na unka badal sakta hai, aur na unhe nakal kar sakta hai.

## Pradata Ki Avashyaktaayein

*Nichee di gayi jankari mein sabhi pradata ki avashyaktaayein shaamil nahi hain. Yeh is vishesh DD seva ke pradataon ke baare mein samanya jankari dene ke liye hai.*

- A. Waiver ka Sabhi seva pradaataon ko yah karana hogi:
  1. Medicaid pradata hona chahiye;
  2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
  3. Medicaid aur Dirgha kaalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
  4. Anurodh par DHHS prashikshan poora karna chahiye; aur
  5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.
- B. Parivahan ko ek DD sanstha pradata, swatantra pradata, ya ek vikreta ke dwara prastut kiya ja sakta hai.
  1. Ek DD sanstha pradata ek company hai jo Medicaid pradata ke roop mein panjikrit hai aur DHHS dwara DD sevaayein pradan karne ke liye pramanit hai aur nimnlikhit ke liye zimmedar hai:
    - a. Un karmachariyon ki bharti aur nigraani jo pratibhagee ke saath kaam karte hain;
    - b. Karmachariyon ko unki yogyata, anubhav, aur pradarshit kshamataon ke aadhar par niyukt karna;
    - c. Karmachariyon ko prashikshan pradan karna taaki ve aavashyak star ki dekhbhali dene ke liye yogi ho sakein;
    - d. DHHS ke liye prashikshan yojnaayein uplabdh karane ke liye sahamat hona;
    - e. Seva ki paryapt uplabdhata aur gunwatta sunischit karna; aur
    - f. Anya prashasanik kriyaen.
  2. Ek DD swatantra pradata ek vyakti ya vikreta hai jo Medicaid pradata ke roop mein registered hai aur ek bhagidaar dwara niyukt kiya gaya hai.
    - a. Pratyabhagi apne swatantra pradata ko niyukt karne aur unki nigraani karne ke liye zimmedar hai.
  3. Ek vikreta ek company ya sanstha hai jo Medicaid pradata ke roop mein registered hai, lekin DD pradata ke roop mein pramanit nahi hai.
- C. Parivahan ko swayan niyantrit kiya ja sakta hai.
- D. Pratyabhagi ka koi rishtedaar, lekin pratyabhagi ka abhibhabak ya anya kanooni roop se zimmedar vyakti nahi, jab ve anya aavashyaktaon ko pura karte hain, tab parivahan pradan kar sakta hai.

- E. Ek pradata apne sevaon ke liye unse jyada shulk nahi le sakta jo ve samanya janata se lete hain. Ek pradata jo kuchh vishesh logon, jaise chhatron ya vrudhron, ko chhoot deta hai, usse usi group ke pratyabhagi ko bhi wahi chhoot deni chahiye.
