Seva Ki Paribhasha

Vahan Sudhaar, bhagidar ke apne vyaktigat vahan mein anukoolan pradan karta hai, taki unki svatantra safar karne ki shamta ko badhaya ja sake.

Pradan Karne Ki Shartein

- A. Vahan Sudhaar mein shaamil hain:
 1. Un bhoutik anukoolan jo bhagidar ki zarooraton ko pura karne ya unki svatantra shamta ko badhane ke liye zaroori hain; aur
 2. Anukoolan ka lagataar dekbal ya marammat.
- B. Vahan Sudhaar ek kaushal vikas seva nahi hai.
- C. Vahan Sudhaar ke udaharan ismein shaamil hain, lekin inhee tak simit nahi hain:
 1. Wheelchair uthaan yantra; ya
 2. Accelerator, brake, turn signal, steering wheel, ya parking brake ke liye anukoolan niyantran upkaran.
- D. Vahan Sudhaar par nimnalikhit simaayein lagu hoti hain:
 1. Vahan Sudhaar ka upyog sirf us vahan ke liye kiya ja sakta hai jo inke dwara adhikrit ho:
 - a. Ek bhagidar; ya
 - b. Bhagidar ka parivaar, jab vahan bhagidar ka mukhya parivahan ho.
 2. Vahan Sudhaar ka upyog DD pradata dwara svamity vale ya kiraye par liye gaye vahanon ke liye nahi kiya ja sakta.
 3. Vahan Sudhaar ka upyog nimnalikhith liye nahi kiya ja sakta:
 - a. Samannya upyog ke anukoolan ya sudhaar, jaise ki:
 - i. Garmin ya thandi kiya gaya kursiyan;
 - ii. DVD player; ya
 - iii. Anukoolit pahiye ya pahiye ke chaakar.
 - b. Vahan ki kharidari ya kiraya par lena;
 - c. Maujuda anukoolan ya pehle se shuru kiye gaye anukoolan ke liye bhugtan; aur

- d. Niyamit roop se niyojita dekbhal.
- 4. Vahan beema ka pramaan mangi ja sakti hai.
- 5. DDD ko ek upyukt Medicaid-naamaankit peshewar pradata dwara sthaniya moolyaankan ki avashyakta ho sakti hai. Moolyaankan Paryavaran Sudhaar Moolyaankan ke tahat pradan kiya jata hai.
- 6. Kiraye par liye gaye vahan mein ki gayi sudhaar agle vahan mein transfer kiya ja sakti hai.
- 7. Vahan Sudhaar Medicaid ke madhyam se pradan kiye gaye anya samanya sevaon se samanantar nahi ho sakti, unhe badal nahi sakti, ya unka nakal nahi kar sakti.

Pradata Ki Avashyaktaayein

- A. Waiver ka Sabhi seva pradaataon ko yah karana hogi:
 - 1. Medicaid pradata hona chahiye;
 - 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
 - 3. Medicaid aur Dirgha kaalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
 - 4. Anurodh par DHHS prashikshan poora karna chahiye; aur
 - 5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.
- B. Vahan Sudhaar ek vitarak dwara pradan kiya ja sakti hai.
 - 1. Ek vikreta ek company ya sanstha hai jo Medicaid pradata ke roop mein registered hai, lekin DD pradata ke roop mein pramanit nahi hai.
- C. Vahan Sudhaar ko khud se niyantrit nahi kiya ja sakti.

Mullya

- A. Vahan Sudhaar ko ek bhagidara ke saal bhar ke vyaktigat budget ke andar kharida jana chahiye.
- B. Vahan Sudhaar ko har ghatna ke liye bhugtan ki jaati hai.
- C. Ek vitarak apne saman ko samanya janata se jyada nahi bech sakti. Ek vitarak jo kisi vishesh samuh, jaise ki students ya vridh nagrikon ko chhoot deta hai, usi chhoot ko us samuh ke ek bhagidara ko bhi dena chahiye.
- D. Vahan Sudhaar par 5 saal ke abadhi mein \$10,000 tak ki seema hoti hai.
 - 1. Ek bhagidara apni gambhir swasthya ya suraksha ki avashyakta ke chalte budget ki seema ke upar vitran ki maang kar sakti hai.
 - 2. DDD ki manzoori uplabdh vitran ke aadhar par nirnayit ki jati hai.
