8. 2025 Hybrid Tri-Board Meeting Update – Kristen Larsen

The Tri-Board consists of the DD Network Partners (the DD Council, Disability Rights Nebraska, and Munroe-Meyer Institute/University of Nebraska Medical Center UCEDD). The 2025 **Hybrid** (in-person and virtual) Tri-Board meeting will be on Friday – June 13, 2025. 10. Report of the Planning Committee: State Needs Assessment Survey – Judy Trent, Dr. Kerry Miller, and Kristen Larsen

Judy Trent and Kristen Larsen will provide an update on the 2027-2032 Five Year State Plan Development.

The Planning Committee Five Year State Plan Development launch meeting was on March 3, 2025, and the Planning Committee met again on April 10, 2025. NCDD is working with MMI contractor, Dr. Kerry Miller, to develop the Needs Assessment questions and focus areas to collect data over the summer.

Dr. Miller will share the prioritized issues identified by the Planning Committee on March 3rd to address in the State Needs Assessment Survey. We will discuss proposed survey questions for Council feedback. Additionally, Dr. Miller will seek Council input on needs and gaps.

Dr. Miller and the MMI team will prepare the final draft of the Needs Assessment survey by **May 15, 2025**, and work with the Council to identify contacts for distributing the survey. Council members will be asked to help disperse.

The Needs Assessment will be published in October 2025 and will guide the Planning Committee with setting State Plan Goals and Objectives to share at the November 21, 2025 meeting.

11. Report of the Planning Committee: Subaward Recommendations for FFY2026 – Judy Trent and Kristen Larsen

The Planning Committee met on April 10, 2025, to make recommendations for formal subaward projects for the Fall. Although NCDD federal funding for FFY2026 is currently uncertain, we still need to discuss and approve funding for a potential RFA release. The Council will consider the Planning Committee's recommendations and vote to approve Requests for Applications (RFAs) for formal and continuous subawards to be released this June. Reminder that FFY2026 will be the last year for the current State Plan.
