**10. 2027-2031 Five Year State Plan Development & Public Comments Update
Judy Trent and Kristen Larsen**

Kristen Larsen and Judy Trent will provide an update on the 2027-2031 Five Year State Plan Development.

The draft 2027-2031 Five-Year State Plan Goals and Objectives were open for public comment December 8, 2025, to January 23, 2026. The Planning Committee

met on January 29, 2026, to review the public comments that were received. Judy Trent, the Planning Committee Chair, will report on any potential suggestions or changes to the draft goals and objectives, and recommend a second public comment period following the February meeting to recruit additional input.

11. 2026 Tri-Board Meeting Update – Kristen Larsen

The Tri-Board consists of the DD Network Partners (the DD Council, Disability Rights Nebraska, and Munroe-Meyer Institute/University of Nebraska Medical Center UCEDD). The 2026 Tri-Board training will be on **Friday – June 12, 2026**. The topic will be **Disability Advocacy Training** to strengthen the voice of people with lived experience. We will meet at the Munroe-Meyer Institute facility located near the UNO Scott Campus at 6902 Pine Street. More information and details will be shared at the April Council meeting.

12. Aged and Disabled Waiver Renewal Application Concerns – Kristen Larsen

Every five years, DHHS must renew Home and Community-Based Services waivers with CMS. Nebraska's Aged & Disabled (A&D) Waiver renewal is due July 1, 2026. DHHS posted the draft application for public comment Dec. 5, 2025–Jan. 5, 2026, and held four informational sessions.

DHHS will review all comments, post a summary with responses on the DDD website, and include them in the CMS submission. If comments require significant changes, the waiver will be revised and re-posted for another comment period.

Key concerns raised by the disability community include:

- Individual cost limits and unclear high-utilization review process.
- Cost caps tied to Medicaid nursing home rates (175% limit), which may not meet some individuals' needs, suggesting referrals to other services or institutional care.

- Service hour caps: Proposed 40-hour weekly limit for personal care, LRI personal care, and companion services combined, compared to the current 112-hour allowance for those meeting nursing facility level of care.

Kristen Larsen submitted comments on behalf of NCDD; these are included in the meeting packet.

13.
