Change Control Documentation

Purpose of change:

These changes are being made to reflect revisions to the Comprehensive and Adult Day waivers for the developmentally disabled. These changes are part of waiver amendments NE.4154.R06.14 and NE.0394.R03.10.

Description of changes:

Remove the following service rates:

- 1) Habilitative Workshop Agency daily rates. This service will only be billed hourly.
- 2) Habilitative Community Inclusion Agency daily rates. This service will only be billed hourly.
- 3) Habilitative Community Inclusion Independent daily rates. This service will only be billed hourly.
- 4) Continuous Residential Habilitation Agency Half Day rates. This service will only be billed on daily authorizations. Therap is modifying billing validation rule for service to pay 0.5 daily unit when time and attendance for service is less than 10 hours.
- 5) Host Home Residential Habilitation Agency Half Day rates. This service will only be billed on daily authorizations. Therap is modifying billing validation rule for service to pay 0.5 daily unit when time and attendance for service is less than 10 hours.
- 6) Shared Living (Independent Contractor) Agency Half Day rates. This service will only be billed on daily authorizations. Therap is modifying billing validation rule for service to pay 0.5 daily unit when time and attendance for service is less than 10 hours.
- 7) Respite Individual Independent daily rate. This service will only be billed hourly.
- 8) Respite Individual Agency daily rate. This service will only be billed hourly.

Remove the following service:

Hospital Support – Agency. This service is no longer needed as providers may now bill for residential habilitation (continuous, host home, and shared living) during acute, short-term hospitalizations.

Modify the name of the following service:

"Habilitative Community Inclusion" to "Community Inclusion" to reflect change in service name.
