The Nebraska Department of Health and Human Services (DHHS) invites public input on the Title V Block Grant application to the federal government.



TIMELINE

Every 5 years Title V completes a needs assessment to identify the priorities for Nebraska. Annually, we write and update the action plan that will address the needs. We are at the beginning of the 5-year cycle and have just selected new priorities.

Title V can select 7-10 priority needs to address.



IMPROVING MENTAL AND BEHAVIORAL HEALTH FOR WOMEN



Objective 1: Increase mental health screenings and referrals

 Promote community collaborative care model and universal screening for depression and anxiety at every well-check, prenatal and postpartum care, and pediatrician visit

Objective 2: Increase access to mental health support and resources

- Promote universal screening at community-based services for pregnant and postpartum women
- Promote mental health resources for women/mothers to reduce stigma around mental health

2 REDUCING MATERNAL MORTALITY AND MORBIDITY

- Cobjective 1: Improve maternal health outcomes in areas with
 - Map maternity care services and providers in NE to understand gaps and capabilities of the perinatal health care system and identify needs in areas with longer distances to care
 - Explore and use alternative delivery methods to improve access to prenatal and postpartum care services
 - Pilot universal home visiting to identify women who need support and services
 - ➤ Objective 2: Increase connection to services

4 REDUCING PRETERM BIRTHS



Objective 1: Increase percent of birthing hospitals with a maternal level of care designation



- Define maternal/prenatal levels of care through perinatal regionalization to ensure facilities are equipped to deliver care appropriate for individual medical needs
- Develop and promote education campaign to increase awareness of need for riskappropriate PNC and how to address risk factors for PTB, promote awareness of presumptive eligibility
- Tie education campaign to strategy to address perinatal health via alternative delivery method

This will not be a separate goal for 2025-2030 and strategies/activities to impact Infants will be combined with the Children's activities (see the next two slides).







O TO EARLY SCREENING AND IDENTIFICATION



- Objective 1: Improve the percentage of families that have a medical home
 - Build capacity with ESUs to screen, identify, and refer families to patient centered medical homes
- Objective 2: Increase provider knowledge about available screening resources for CYSHCN
 - Promote materials about early intervention to health care providers, ESUs, MHCP clinics/providers, and community-based organizations
 - Promote available screening options to health care providers and community partners (including MHCP)

INCREASING ACCESS TO MENTAL AND BEHAVIORAL HEALTH SERVICES



- Objective 1: Increase the percentage of CYSHCN with mental/behavioral health needs who are receiving services
 - Use CHWs, PRCs, and patient navigators to provide care coordination services for mental/behavioral health
 - Develop a centralized resource hub with expertise to triage, screen, refer, and support CYSHCN in mental health crisis
- Objective 2: Increase use of resources by building connections among families, providers, and ESUs
 - Strengthen collaborations between partners to increase support and assistance for CYSHCN families
 - Build family awareness and knowledge of existing programs and support by hosting sessions at family-centered conferences in Nebraska
