# VI. Special Topics

## A. PHE Unwind Update

Schweitzer Masek provided an update on the end of the public health emergency (PHE) unwind. She directs that further questions can be directed to the State.

## **B. SUPPORT ACT**

Spencer Moore presents data on concurrent use of Opioid and Gabapentin or Pregabalin for Nebraska Medicaid members. Tom Dunn requests that in future averages are presented. There was a request to use less broad age bands which would include 19-64 and 65 -70 and older and to also report data where prescriptions were prescribed and administered within a skilled nursing facility.

### C. Adult Vaccine Coverage

Leah Spencer gave information on the coverage of adult vaccines as part of the Inflation Reduction Act (IRA) which requires coverage of The Advisory Committee on Immunization Practices (ACIP) recommended vaccines as of October 1, 2023. The CDC also has recommendations for maternal RSV vaccine. Medicaid will send information to NPA and NMA on coverage of RSV vaccine to request sharing with their members.

## D. Molina Healthcare of Nebraska

Schweitzer Masek reminded that effective January 1, 2024, Molina Healthcare of Nebraska will replace Healthy Blue of Nebraska to administer healthcare coverage for Nebraska Medicaid.

# B. New Business- Proposed Topics for review in 2024

Schweitzer Masek brings forward previously discussed topics for DUR projects in 2024. Four project topics were unanimously approved as follows: Diabetes diagnosis and outpatient hospital service among using an age band of  $\leq$  18,19-64, and  $\geq$  65 years, mirroring HEDIS measures for  $\geq$  67 years of age; Lithium prescriptions and history of lithium levels every  $\leq$  6 months ; Concurrent opioid/ benzodiazepine and atypical anti-psychotic utilization among members with an overlap of prescription dispensing by  $\geq$  15 days with a distinction between prescription medications that are 'prn' compared to regularly prescribed; Research standards and treatment of preobesity of adults with criteria of bmi of  $\geq$  25 and  $\leq$  30 kg/m<sup>2</sup>, and among children defined by age/weight/gender, and brought back to the Board for discussion.

# X. Concerns & Comments Board:

Charlie Moore states that he feels there is a lack of communication to providers and members by the impending health plan, Molina, on enrollment and Plan information. Schweitzer Masek states she will bring this information back to the State and Molina Healthcare plan.

Comments on the medication Vyvanse and its generic was brought up for consideration at the next P&T as providers are concerned about coverage. Magellan representative, Czechowski, informs that there are shortages across the whole drug class including both Brand and generic and are aware of those medications are reviewed.

Questions on managed care MAC pricing is asked as to if there are differences among manufacturers on medications that drives reimbursement. MCOs will work with Moore and Randolph on MAC appeals.

Tom Dunn asks if with the implementation of the Molina there will be a transition fill notification messaging back the pharmacy. The State will contact Molina to verify. It is noted that not all pharmacies may be capable of receiving the messaging.

### **DUR Director and State representatives:**

Schweitzer Masek shares that Board member, Robert Wergin, has contacted the State for support and consideration of a Gold Card for providers as previously discussed in prior DUR meetings.

It is announced that Medicaid director Kevin Bagley is leaving Nebraska Medicaid and will be replaced interim with Matt Ahern.

The State indicates that discussion regarding the frequency of DUR Board meetings will be held at the next DUR meeting as an agenda item.

Donna Osterlund with Sanofi questions if there will be a transition time for prior authorizations for current Healthy Blue members when Molina starts in 2024. The State responds that a 90-day transition will be in place for prior authorizations and applies to all Medicaid members.
