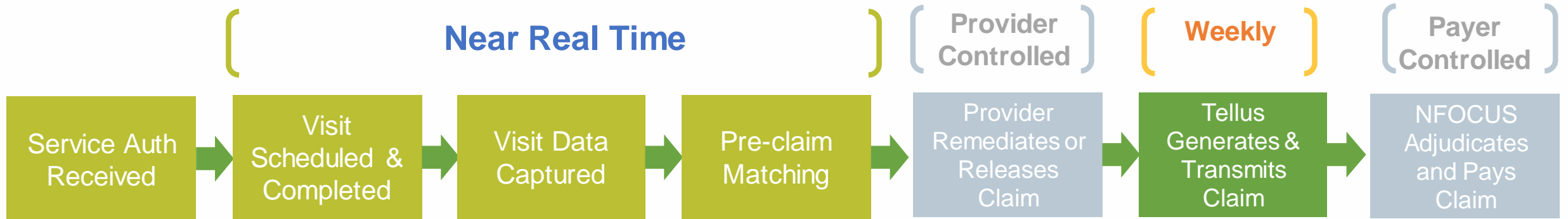

Claims Release for Billing in Admin Portal



- The Tellus system creates the claim, the provider remediates the claim (if necessary) and marks the claim for submission
- The Tellus system transmits the claim to NFOCUS every Tuesday for adjudication and payment
- The payment cycle remains the same as it is today
