Access to COVID-19 Vaccinations for Nebraskans with Disabilities

The COVID-19 emergency presented a unique set of challenges to all states with respect to ensuring that all residents had access to testing and ultimately vaccines. The emergency was even more impactful for Nebraskans with disabilities who may require reasonable accommodations to access health care, including access to vaccinations. In Nebraska, the local health districts/departments and the state's Department of Health and Human Services have worked together to provide vaccinations to individuals requiring accomidations due to disability.

To-date, Nebraska's health departments have collectively been administering vaccinations to those who have identified as having a disability, their caregivers, and family members. Additional vaccinations have been provided at other locations by way of arranging specific events targeting the disabled community, furnishing reasonable accommodational in various residential settings, and working with providers who deliver other medical services to these residents. These efforts underscore the state's commitment to the accessibility of vaccinations for some of its most vulnerable residents.

Those meeting the following criteria are eligible to receive reasonable accommodation via coordination with their local health department:

- 1. Physical or mental impairment that substantially limits one or more major life activity OR
- 2. A person who has a record or history of such an impairment
