PASRR Review

- NEVER admit a resident without a valid PASRR.
 - If the PASRR needs to be a Level II, you will need to wait until the Level II is completed.
- REMEMBER that Acentra's clock does not start until they have a complete referral packet
 - Meaning ALL the information they have asked for including the OBRA-8.
- Time Limited PASRR
 - o Do an admission/discharge case and Acentra will track it for you and send reminders.
 - In Acentra website resources tab, there is a training on how to do an admit/discharge option for your resident and set reminders for doing the follow-up PASRRs on time. Reminder that Medicaid cannot and will not pay for days when there is not a valid PASRR in place; don't admit a resident without a valid PASRR and do the follow-up PASRRs if there is a time-limited PASRR.
 - ALWAYS submit the new PASRR 7-10 calendar days prior to the "expiration" of the time-limited PASRR.
 - (use Google day/calendar calculator to get the date from the date on the PASRR letter)

- Question
 - If resident has a PASRR that expires in 30 days (30-day hospital exempt), can you admit the resident?
 - yes, you have up to 30 days to get the new PASRR completed.
 - I'm in the business office. I know we're supposed to update Casemix monthly, but what am I supposed to update.
 - Current resident report, load errors and other reports and tools; email Dawn and she will set up a time with this person to show you what the reports are, and how to update them.
 - Email Dawn and she will set up a "CaseMix 101" training if there is a group of people that would like this training.

NF LOC Review

- 14-day post Medicaid determination explanation private pay notice of role of nursing facility
 - Facility has 14 days to make the referral for NF LOC when someone becomes eligible for Medicaid after were previously private pay.
- 471 NAC 44 3(C)iii(1)
 - o Process in place for referrals and retroactive Medicaid
- When asked for more information it is very, very important that the facility respond
 - if you have staff turnover or absences, please put someone in charge of responding and getting AAA/LHD the information they are requesting.

- Please be sure to report resident's movements in and out of Medicaid certified beds as quickly as possible.

Weighted Days Review

- Please include the name of facility and the city in the subject line
- If the difference in days is <u>under 100</u> yours will be considered reconciled and complete and you will <u>NOT</u> hear from us.
- Weighted days compares the count of days report to your facilities cost report (census). This is how your rates
 for the following fiscal year (July 1 June 30) are determined, so it is important to have these reconciled as
 accurately as possible.
- EXCELLENT Job
 - Last week had only 50 facilities that have not heard from
 - Email blast went out to them last week
 - Several have already responded
 - o BEST response and completion we have ever had since Dawn started in 2017!!
- Helpful for making weighted days smoother.
 - Check load errors (error report) weekly.
 - Check care level report monthly.
 - Available between the 14th and 18th of the month.
 - Past Due Assessments
 - Lists residents with no assessments processed within the last 4 months (or more)
