Re: Nebraska Medicaid Provider Directory

This provider bulletin is being issued to notify Nebraska Medicaid providers of the new Nebraska State Medicaid Provider Directory. The directory will be available on the Nebraska Medicaid website starting on July 1, 2025. The directory will be a valuable resource for locating healthcare and service professionals enrolled in the Nebraska Medicaid program. This up-to-date directory is designed to assist beneficiaries in connecting with physicians and other Nebraska Medicaid service providers in their area. It is a new tool for Nebraska Medicaid recipients and their caregivers, simplifying the choice of the right care options for themselves and their families.

The Nebraska Medicaid Provider Directory is the first step in finding care. After reviewing the directory and selecting a preferred provider, beneficiaries can confirm whether that provider is part of their Nebraska Medicaid managed care organization (MCO) or approved under their specific waiver. The directory helps Nebraska Medicaid beneficiaries access necessary services from active Nebraska Medicaid providers.

The directory is populated with information submitted to the Provider Data Management System <a href="https://www.nebraskamedicaidproviderenrollment.com">www.nebraskamedicaidproviderenrollment.com</a> during the provider's enrollment. The Provider Directory Information tab in MAXIMUS gives providers a chance to review and update any information contained in the new public online directory. **Providers are responsible for keeping the following information current and accurate:**

- Address(es)
- Telephone number(s)
- Languages available
- Accepting new Nebraska Medicaid patients
- Physical disability accommodations
- Website
- Telehealth availability
