Carroll discussed the Legislative Committee Charter and shared the information with the Council. Vinton made the motion to approve the Charter.

Presentation: Women's Fund

Jo Giles discussed the "Omaha Women's Fund". Some of the Legislative Bills that were discussed:

- LB 118 extends the duration of protection orders from one to five years
- LB 772 protects survivors of violence from debt collectors
- LB 1009 establishes a domestic abuse death review team
- LB 1246 provides survivors of sexual violence with anonymity
- LB 768 Prohibits State Board of Ed from enacting comprehensive sex education
- LB 881 Remove sales tax on menstrual products and provide them for free detainees
- LB 1129 Free Contraception for women
- LB 290 to create an insurance program for businesses to provide paid family and medical leave.
- LB 929 Extend Medicaid Postpartum coverage

Giles mentioned that this is a short Legislative session and will end in May of 2022.

The Nebraska Legislature website will have the updated information on the Nebraska State Senators.

Presentation: "Strategic Planning"

Borg discussed the "Strategic Planning" and the "2021 SWOT Analysis Survey Summary Report". The proposed version of the "Mission" is to Help Women of all ages in Nebraska have Equitable Access to Resources that support Optimal Health and Wellbeing through Policy, Outreach, Advocacy and Education. Tabor made the motion to accept the updated "Mission" statement and DeBonis seconded the motion. The Strategic Plan include the following proposed workgroups:

- Legislation/Policy
- Strategic Planning
- Membership
- Advocacy/Education

Borg talked about the SWOT Analysis Survey which included Strengths, Weakness, Opportunities and Threats.

The new "Priorities" of the Strategic Planning are:

- 1. Mental Health
 - A. Depression Screening
 - B. Violence
- 2. Reproductive Health

Tabor made a motion to approve the "New Priorities" and DeBonis seconded the motion.
