Demonstration Waivers

RE: Medically Monitored Inpatient Withdrawal Management (ASAM Level 3.7-WM)

This health plan advisory is being issued to notify the Heritage Health plans that Nebraska Medicaid has received approval from Centers of Medicare and Medicaid Services (CMS) to cover Medically Monitored Inpatient Withdrawal Management (ASAM Level 3.7-WM) services. These services may be billed retrospective to date of services on or after January 1, 2020.

Licensed residential facilities in accordance with the American Society of Addiction Medicine (ASAM) criteria described under Level 3.7 Medically Monitored Inpatient Programs, licensed as required by DHHS Division of Public Health, and enrolled as an active provider with Nebraska Medicaid are required to deliver services in accordance with the Medically Monitored Inpatient Withdrawal Management service definition as outlined here:
