- SPA
  - Demonstration Prime and Basic ABPs on Hold
  - SUPPORT Act MAT Tribal Notice sent
    - MAT Prime and Basic ABPs
  - o 2021 HCPCS File
    - CMS may not require a SPA for these rates
    - No impact to the Tribes because we pay up to the AIR
    - Awaiting to hear from CMS if a SPA is needed as there are no new services types, just new codes
    - DHHS will issue a correction to the tribal notice previously sent
      - An updated Tribal Notice was sent on 3/4/21, updated the notice sent previously on 3/1/21
- Waiver Authority
  - HHA Expansion Update

    - CMS has not yet provided a decision yet on the implementation plan, exceptions remain

    - Amendment submitted, effective date 3.22.21
    - Division of Developmental Disabilities, operationalize the waivers and we are moving admin of waivers to them, is working on updates to this and another TN will be sent this week
  - Developmental Disabilities Day Services Waiver for Adults (DDAD)
    - Tribal Notice sent 3.3.21
  - Comprehensive Developmental Disabilities Services Waiver (CDD)
    - Tribal Notice sent 3.3.21

## Discussion

Donna with Carl T. Curtis, brought up an issue they have been experiencing with MCNA regarding RAs not being paid correctly.

- Ricky with MCNA assured that they are working to get this corrected and it has been take to upper management for resolution.

Nancy discussed FFS claims from 11/2019 that were reversed and paid at the AIR in 8/2020.

Becky Crase asked if the tribes are unable to bill a T-code for a 99211 since their nurses aren't credentialed, but only their providers are.

- Crystal can bill T-code with a nursing visit
- Santee has done this and has gotten paid at the AIR. As long as the nurses are enrolled through Maximus and billed under a provider.
- Jacob and Catherine will double check the state plan and follow up with Health Services regarding this.
- Jena also bill the T-code for lab services as well (with an ordering physician)
- Private companies are paying up to the AIR for testing
- Current thought is that nurse practitioners can sign off on this like PT when tribes put order and referring in diagnostic/lab services to add the T-code

MLTC has been looking into this and will discuss on the 4.7.21 Tribal/Medicaid Call
