## **AGENDA ITEM: Office of Emergency Health Systems**

- a) Wilson reported licensing renewal has been extended due to the Governor's Executive Order until June 30, 2021. In 2020, the department issued 574 licenses. There was a discussion on audits of the educational requirements for 2020 license renewals.

- b) Jorgensen clarified the second bullet point on services who are interested in going from a Basic Life Support (BLS) to an Advanced Life Support (ALS) and the rules and regulations they will need to adhere to.
- c) Snodgrass reported there are still a few available slots for the upcoming training in North Platte. Continuing education for National Registry was not extended and the deadline is March 31, 2021. The pass rate spreadsheet was further discussed.
- d) Kuhn had an update the ambulance assessment was at 64.5% completed rate. Goal is 80% by March 31, 2021 at close of the survey.
- e) Kuhn did not have further updates for the Critical Incident Stress Management program than what was previously submitted to the board. Miller asked a question on resiliency training. This is being developed and working with IT to get this class virtual.
- f) Wren reported the State Trauma Advisory Board will be having a Strategic Planning Meeting on February 25, 2021. A Mass Casualty survey went out last week and future town hall meetings will be set up. This will enhance training between trauma providers and EMS services.
- g) Wilson reported Neumiller and Kuhn are working on another Helmsley grant. This one is for \$6.4 million to provide Automated External Defibrillator (AED) in each law enforcement vehicle across the state.
- h) Steele reported there was training for Hospital Hub administrators last week. Between all of the classes, 71 attended. Wilson reported the department is in the final stages of a ticketing system. The board would like to start seeing reports and asked for a 2020 annual report. The data committee will assist in getting this information.

Additional information was compiled from the Office of Emergency Health Systems and provided to the Board prior to the meeting. See Attachment A to the minutes for complete briefing.

#### **AGENDA ITEM: Statewide Physician Medical Director Update**

Smith reported on behalf of Dr. Ernest, the National Association of EMS Physicians (NAEMSP) medical director course has been released for trial runs in 3 separate states. This should be completed in the next month or two. Once feedback is received, the plan is to release to the general public. There will be an opportunity to add state-specific information to the course in addition to the fundamentals of medical direction

We have recently started a local chapter for NAEMSP for the State of Nebraska. Iowa and Missouri are also included in the chapter. If there are any physicians who would be interested in joining, they can contact Dr. Ernest directly for more information.

#### **AGENDA ITEM: EMS Committee Reports**

- a) Legislation and Rules and Regulations (Smith): Smith reported the committee is done with the critical care paramedic portion. The community paramedicine section is at legal with questions from the committee meetings.
- b) Scope of Practice (Fiala): The committee has some changes, additions and deletions to bring to the board:

Emma Zeratsky, Rescue Captain with Valley Rescue, thanked the board and department for assistance with their questions on scope and ultrasound.

Discussion on EMT and above with appropriate training and competency assisting with administering the COVID vaccination. There are protocols from Dr. Anthone, State Chief Medical Officer, and many are also working with their local health departments.

Board took a break at 11:58 am

#### **AGENDA ITEM: NSVFA Update**

Cerny gave update on NSVFA. Nebraska State Fire School is still scheduled for May 21-23, 2021 in Grand Island. EMS classes will be offered. Another class to be offered is a Recruitment and Retention class with all expenses reimbursed through the NSVFA Safer Grant for the participants.

The next deadline for the SAFER Grant: State Tuition Reimbursement as Incentive for Volunteer Emergency Responders (STRIVE) is March 1, 2021. Information and applications are available on the NSVFA website, NSVFA.org, under the SAFER Grant icon.

The NSVFA's Recruitment and Retention Committee will be meeting the evening of February 22, 2021 to hire a grant writer to apply for another SAFER Grant to assist with recruitment and retention.

Two more Recruitment and Retention training classes will be held in the fall in Columbus and Beatrice but the exact dates have not yet been set.

#### **AGENDA ITEM: NEMSA Update**

Bowlin reported NEMSA appreciates the board's participation throughout the various conferences during the year. For the March 2021 conference, the 18<sup>th</sup> is going to be a pre-conference day for instructors. March 19-24 will be for providers. The board will have a small group participate in a forum on the 20<sup>th</sup>. Members are to get their attendance to Wilson prior to the meeting. Additional mini-conferences are set for June 11-12, 2021 in Valentine and October 22-23, 2021 for Scottsbluff.

Wilson will check with the previous facilitators on their schedule for October and bring to the board at the May meeting. Board members did comment strategic planning is greatly needed and they accomplished a lot since the previous planning. This is also important to the stakeholders.

## Attachment A

### EMS Board Meeting, February 22, 2021 Office of Emergency Health Systems Reports

#### a) Licensing (Wilson / Huggins)

- Per Executive Order 20-10, license renewal is being deferred for certain license types. Expiration dates for these licenses will now appear at 6/30/2021 on License Lookup unless the license has renewed. Licenses for these license types may continue to defer renewal until the COVID-19 State of Emergency is lifted. Licensees who choose to renew may do so beginning in mid-January 2021. Postcards have been sent to licensees.
- 574 licenses issued in 2020.
- We will be implementing a new licensing system from LIS and replacing it with Lance system. Lance stands for the NE Licensure and Certification Environment. Applicants will be able to check application status online 24/7 and will be in real time. Applicants will be able to pay reinstatement fee(s), certification fees and administrative penalties online.

#### b) EMS Program (Jorgensen)

- The number of EMS individual contacts the EMS Program has had thus far in 2021 is 599.
- An EMS inspection was done for a BLS non-transport service that has applied to become an ALS non-transport service. An upcoming EMS inspection is scheduled for an ALS service that is changing ownership.
- The EMS Program is planning to resume the periodic EMS inspections in April. The inspections will pick up where they were suspended. The services that were to be inspected in 2020 will be inspected in 2021. It will be up to the service and the EMS Specialist if the inspection is done in-person or virtually.
- The EMS Program continues to provide technical assistance to EMS services, EMS providers, physician medical directors (PMDs), hospitals and training agencies on a daily basis.

#### c) Education and Training Agency Compliance (Snodgrass)

- EMS Leadership Training Levels I and II with SafeTech Solutions is being held February 25-28, 2021 in North Platte. Levels III and IV will be in August.
- EHS Office is offering EMS provider and instructor continuing education classes via Zoom throughout the year. Information is posted on the online training calendar.
- Training Agency site inspections are being scheduled. There will be 8 inspections this year.
- 2020 Training Agency pass rate data has been calculated. The data will be posted on the EHS Education webpage. Corrective action letters were sent to those agencies with a 2 year pass rate below 70%.
- Developing exam coordinator and evaluator training for the new BLS Psychomotor Exam format. The trainings will be held online. Tentatively scheduled to pilot the new format in May with a fall roll out statewide.
- Training Agency course data is being collected. This is the new required student numbers and retention information required to be reported to the Department.



- We will be re-evaluating the tuition reimbursement amounts based on tuition costs submitted by the training agencies.

**d) Emergency Medical Services for Children (Kuhn)**

- Heartland EMS for Children is hosting the third virtual symposium the evening of March 11th on Kids in Crisis – Behavioral Health Emergencies. Nursing CEU's are being provided once again by Minnesota Children's Hospital. A copy of the flyer is attached. We are planning a presentation for EMSC Day in May. The topic will be light and humorous thanking all the providers for being on the frontlines.
- Children's Hospital was approached to provide nursing CEU's for the ALS PEPP courses for nurses. No success yet since they are overwhelmed with their own projects. We are discussing approaching UNMC or asking Minnesota Children's Hospital since they have provided the nursing CEU's for the symposiums.
- We are in the process of creating a hospital packet for voluntary recognition and preparing hospitals for National Peds Readiness Project is well under way. Anne Duhs, Marjorie VanRiper and Debbie presented the data and project at the February ENA meeting. It was well received and many of those in attendance volunteered to share the information and the PowerPoint presented. The packet will be ready by April 1<sup>st</sup>. Once the packet is approved by the Committee, Anne and Marjorie will begin contacting hospitals providing the information. Packets will be sent out as requested.
- The ambulance assessment went live on January 4<sup>th</sup>. The federal goal is an 80% response rate. We struggled last year to achieve an 83%. Currently we have a 58% response rate. Any assistance anyone can provide to support EMSC to reach that 80% mark will be greatly appreciated.

**e) Critical Incident Stress Management (Kuhn)**

- No trainings scheduled for 2021.
- 20 interventions have been requested in 2021. This time last year we had 13 requested.
- The CISM program and Tim have been working on finding a statewide notification system for the team, finding someone to repair the current database and provide more team training. The CISM conference has not been planned yet due to COVID. We have cancelled the last two years due to flooding and COVID.

**f) Trauma System (Bailey / Wren)**

- 51 trauma centers designated
- Pending designation: Perkins County Health, Grant – Basic
- Recent designation: Chase County Community Hospital, Imperial – Basic
- Upcoming designation visits: Basic – Community Hospital, McCook; Avera Creighton, Creighton; Morrill County Community Hospital, Bridgeport; Gordon Memorial Hospital; Ogallala Community Hospital; Box Butte General Hospital, Alliance; and St. Francis Memorial, West Point. General – Mary Lanning, Hastings and CHI Health St. Elizabeth, Lincoln
- Training – TNC Day – targeted for June 25, Younes Center, Kearney; Trauma Disaster Survey was sent out to stakeholders February 16 with completion March 5.
- Draft Trauma Regulations – sent back to the Governor's Policy Research Office for consideration of revisions based on the recommendation of the State Trauma Advisory Board. Awaiting the review and rescheduling of a third public hearing. Recommended revisions to the proposed draft: 003.04 Conflict of interest – delete requirement members of the on-site review team must not be employed in the region which the facility being reviewed is located or be employed by an organization with ownership affiliation in the facility being reviewed.
- Reviewer Request for Qualifications – is in DHHS legal review, estimated completion date end of Spring 2021
- Board vacancies (applications due by February 15, 2021):



- i. State – Rehabilitation Professional and 911 Dispatcher
- ii. Region 2 – Consumer, Physician and 911 Dispatcher
- iii. Region 4 – Rehabilitation Professional

**g) Stroke/STEMI System (Neumiller)**

- We continue to hold Mission Lifeline: Stroke classes. Happily the volume of classes requested has picked up in the last few months. We are in the process of adding some new instructors so hopefully that will also increase the number of classes to be held. So far we have 39 services who have either already had the training or have a scheduled date for training and 20 services who have requested training and are in the process of being scheduled.
- Working out a couple kinks in the EMS stroke awards and then we will get those started. Awards for CAH will soon follow as well and will tie closely to the criteria of AHA “Get With The Guidelines” Stroke awards.
- Continue to expand the CARES registry with the help of Dr. Jason Kruger. We plan to have all of Lancaster County EMS agencies participating in CARES by May 1, 2021. Becka will be re-contacting EMS services up north in an effort to regionalize services up there as well.
- We have started the beginning stages of planning a one day Stroke/STEMI symposium, waiting to see what happens with the COVID vaccine rollout and statewide recommendations before getting too far in. Next month, we will start working on the triage and transfer questionnaire, which is required for all hospitals who do not carry a stroke designation to submit on an annual basis.
- Working on getting NE burden of stroke and cardiovascular disease fact sheets updated.

**h) EHS Data Systems (Steele / Wilson)**

- Hospital Hub review is in progress. Hospitals who did not have access to Hospital Hub have been contacted and asked to provide an individual the hospital would like to be assigned as a Facility Administrator in Hospital Hub for their facility. MMRS regions are being updated to reflect which trauma region a hospital is in Hospital Hub. A training is planned via Zoom in February for Hospital Hub Facility Administrators.
- Reviewing 3<sup>rd</sup> party imports from Ambulance Services who submitted to the eNARSIS system to ensure records from 3<sup>rd</sup> party importers are making it into the eNARSIS system. 3<sup>rd</sup> party importers are Ambulance Services who are not submitting via direct entry into the NE Elite software.
