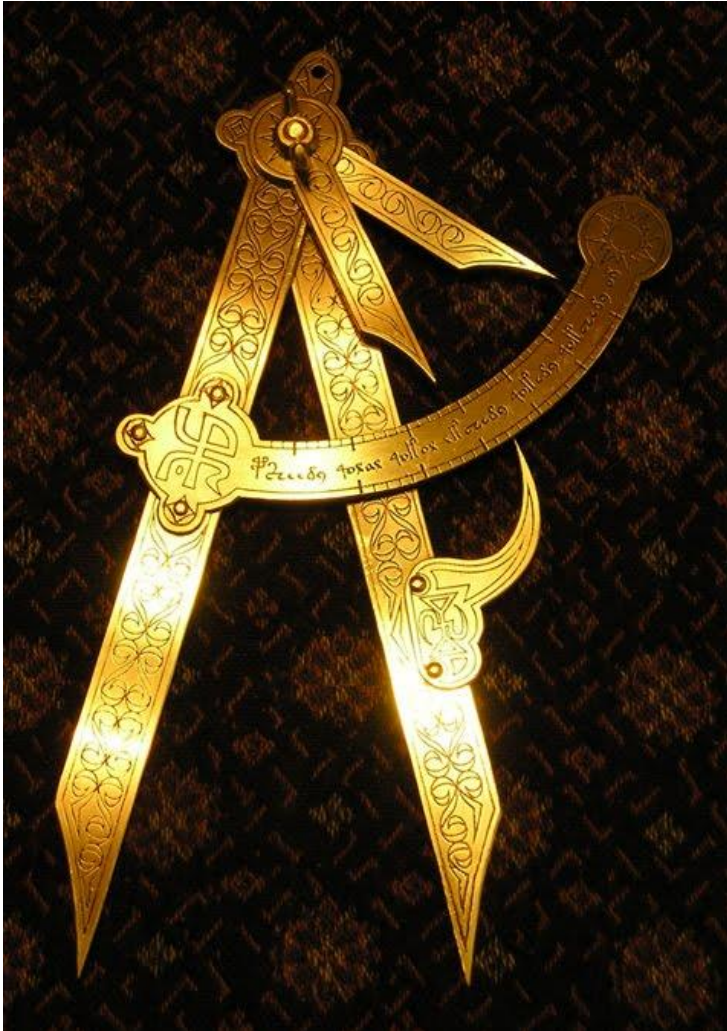

What is Compass-EZ™?

The Compass is a self-administered scale that allows provider that addresses complex co-occurring issues (substance use & mental health) to examine key areas of their recovery-oriented programs.

2023 COMPASS-EZ™ REPORT

Executive Summary

The *Compass-EZ™* is a self-administered scale used to assist organizations, systems, and agencies in designing, implementing, and tracking the progress of recovery-oriented complexity-capable programs with services that address complex co-occurring substance use and mental health issues. The *Compass-EZ™* is utilized as one of the Division of Behavioral Health's (DBH) continuous quality improvement activities in partnership with the Regional Behavioral Health Authorities (RBHA) and contracted mental health and substance use providers. The *Compass-EZ™* has been completed every other year since 2013.

Compass-EZ™ encompasses 15 domains comprised of 69 Likert-style items (1-5 scale).

Data, essential to complexity-capable infrastructure and care, are analyzed at statewide and regional levels to determine areas of strength and opportunity. Results from 2013 (initial year) and 2021 (previous year) data are presented to compare 2023 (current) performance relative to prior responses.

2023 Statewide Level Highlights:

Compared to 2021, the number of provider responses increased by 18% in 2023 (from 79 to 93). There were also some levels of variance in areas of improvement observed between the regions.

Overall statewide from 2021 to 2023, there were negligible differences for nine domains (maintained) and minimal changes of 1% to 2% for the other domains.

2023 Compass-EZ™ Report

Purpose

The COMPASS-EZ™ is designed to help individual programs organize a baseline self-assessment of recovery-oriented complexity (co-occurring) capability as the first step in a continuous quality improvement process, in which the program designs an action plan to make progress. It is designed to help programs have a consistent method for measuring progress and continue the learning and change process by repeating the self-assessment at regular intervals.

COMPASS-EZ™ helps programs begin the process of developing recovery- and resiliency-oriented complexity-capable (co-occurring). It brings together critical knowledge about what helps individuals and families—knowledge about integrated treatment and services, trauma-informed services, person-centered planning, cultural competency, population-specific services, and most fundamentally, empathic relationships that inspire hope and help. One of the most important intents of the COMPASS-EZ™ is to create a foundation for an improvement process through empowered (data substantiated) conversations that involve as many people as possible working together to build the program and its services.

The Department of Health and Human Services (DHHS), Division of Behavioral Health (DBH) contracts with and provides funding, oversight, and technical assistance to six Regional Behavioral Health Authorities (RBHA) hereafter referenced as the Regions. Local programs are subcontracted by the Regions to provide public community-based mental health and substance inpatient, outpatient, and emergency services to people who are may be uninsured by private health insurance or Medicaid. As one of DBH's continuous quality improvement activity in partnership with the Regions, contracted mental health and substance use providers have been asked to complete the *Compass-EZ™* every other year since 2013. A comprehensive approach to complexity-capable care at clinical and organizational levels is esteemed to better improve the recovery and health outcomes for individuals and families with co-occurring conditions.

For this report, contracted providers of the six Behavioral Health Regions were asked to submit responses using the Compass-EZ™ by July 2023.

Assessment Domains

Compass-EZ™ encompasses 15 domains comprised of 69 Likert-style items (1-5 scale). Each item is rated on a scale of 1-5 with 1 being the most negative and 5 being the most positive response.

2023 Compass-EZ Results: Statewide

Statewide Summary

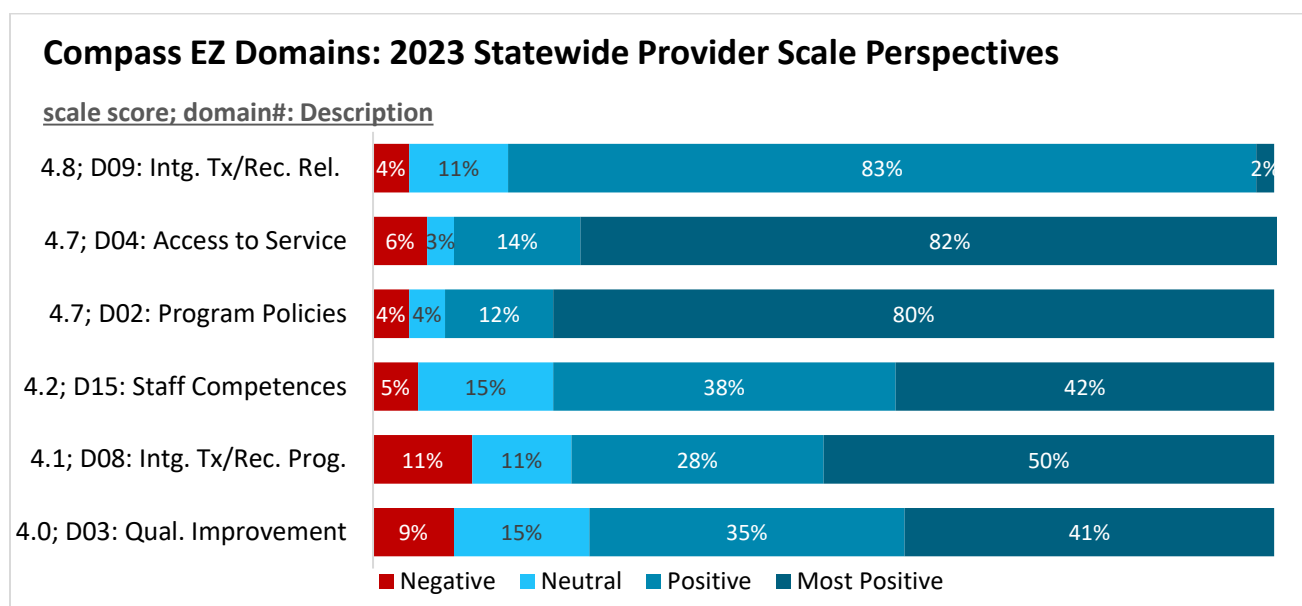


Figure 1A: Statewide perspectives (levels of positivity) for three of the highest and lowest overall scoring domains in 2023

At the statewide level, the self-reported levels of positivity are reflective of providers' perspectives. Across all domains there were high levels of positiveness in 2023. Figure 1A shows the distribution of negative to most positive selections for the domains that had the highest scores and lowest overall scale scores.

There has been improvement in the average domain score across the 15 domains when compared to the 2013 baseline assessment (Figure 1b, Table 1). Of all 15 domains, the domains with the most improvement from 2013 to 2023 are Domain 6, 12, and 14. From the previous measurement in 2021 to 2023, Domain 4 showed the most improvement. For the current *Compass-EZTM* assessment, Domains 2, 4, and 9 had the highest scores at the statewide level. Each of the six Regional Behavioral Health Authorities (RBHA) varied in their areas of improvement.

Statewide Domain Changes

Level of changes between measurement years:

- From the baseline in 2013 to 2023, Domains 12 (0.83, 16.6%), 6 (0.81, 16.2%), and 14 (0.8, 16.0%) showed the largest increases in mean scores.
- From the previous measure in 2021 to 2023, the magnitude of any change observed was negligible to nil.
 - Domains 4 (0.11), 13 (0.07), and 6 (0.07) showed the most positive change in average domain scores.
 - Domains 15 (-0.10), 10 (-0.08), and 5 (-0.06) showed decreases in average domain scores.

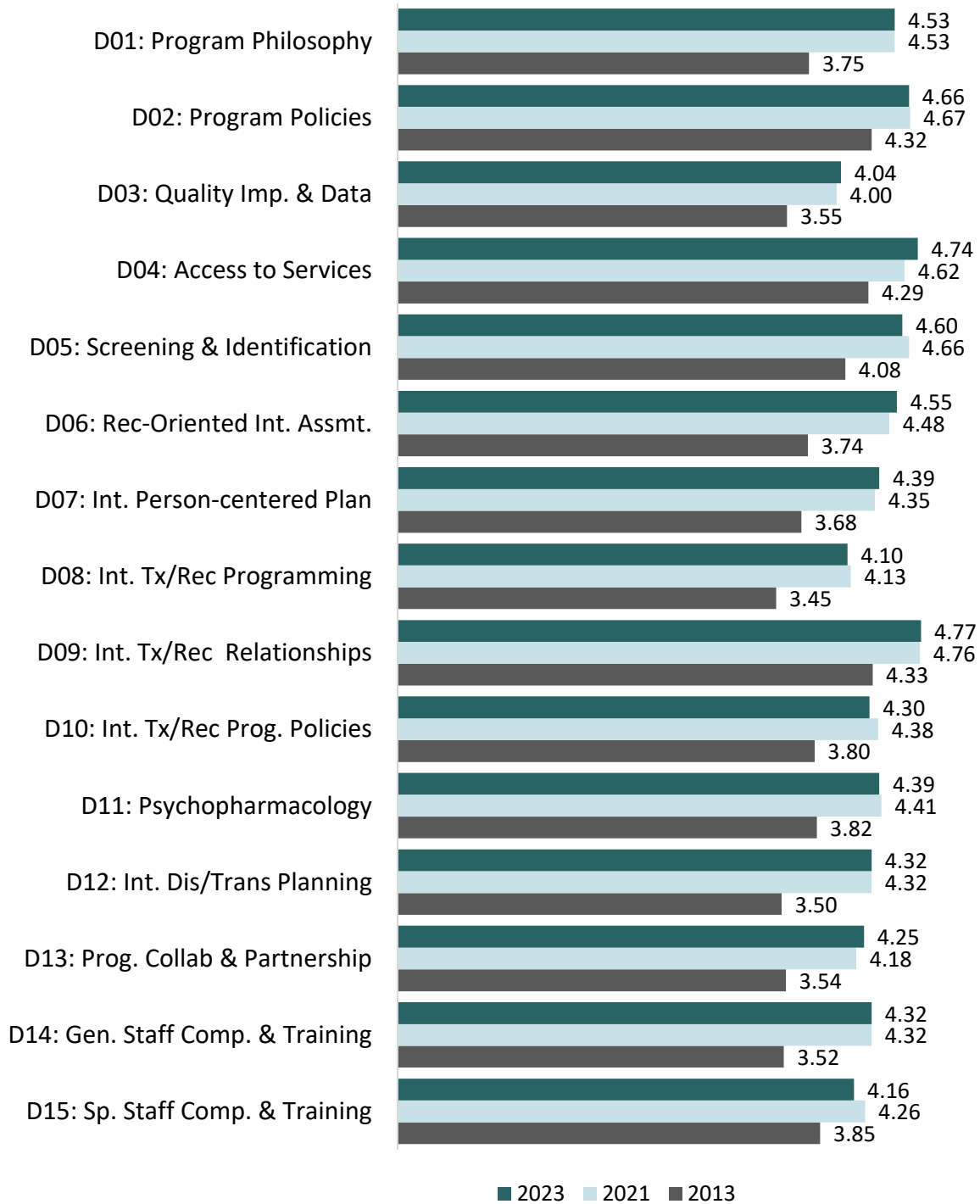


Figure 2B: Statewide Domain Changes

2023 Results by Region

Region 1 Summary

Region 1 exceeded the overall state means in Domains 3 and 7. The scores for Region 1 were lower than the statewide mean for the other domains.

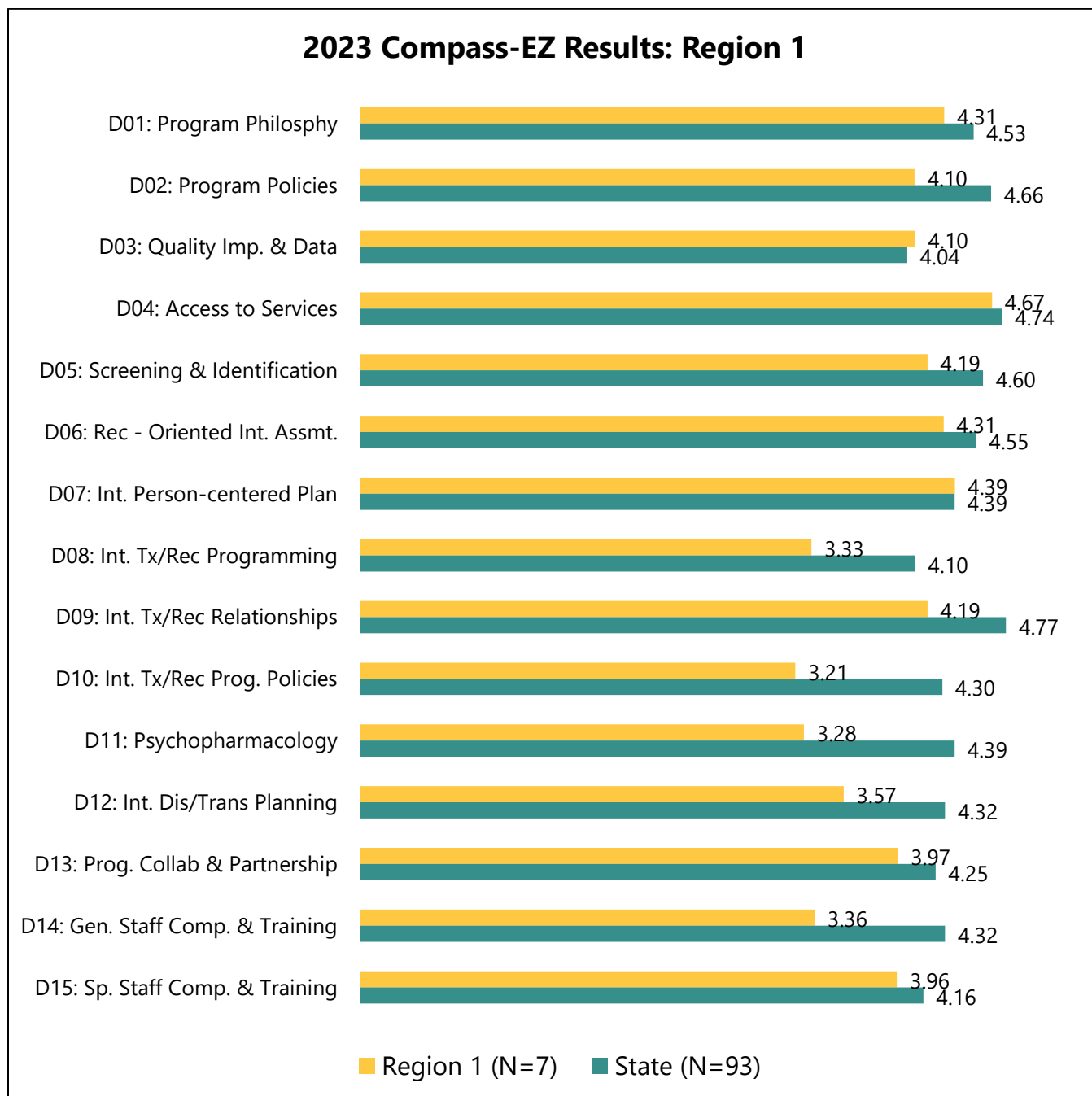


Figure 3: Region 1 and Statewide Domain Means

Region 1 Domain Changes

Level of changes between measurement years (Figure 3, Table 5):

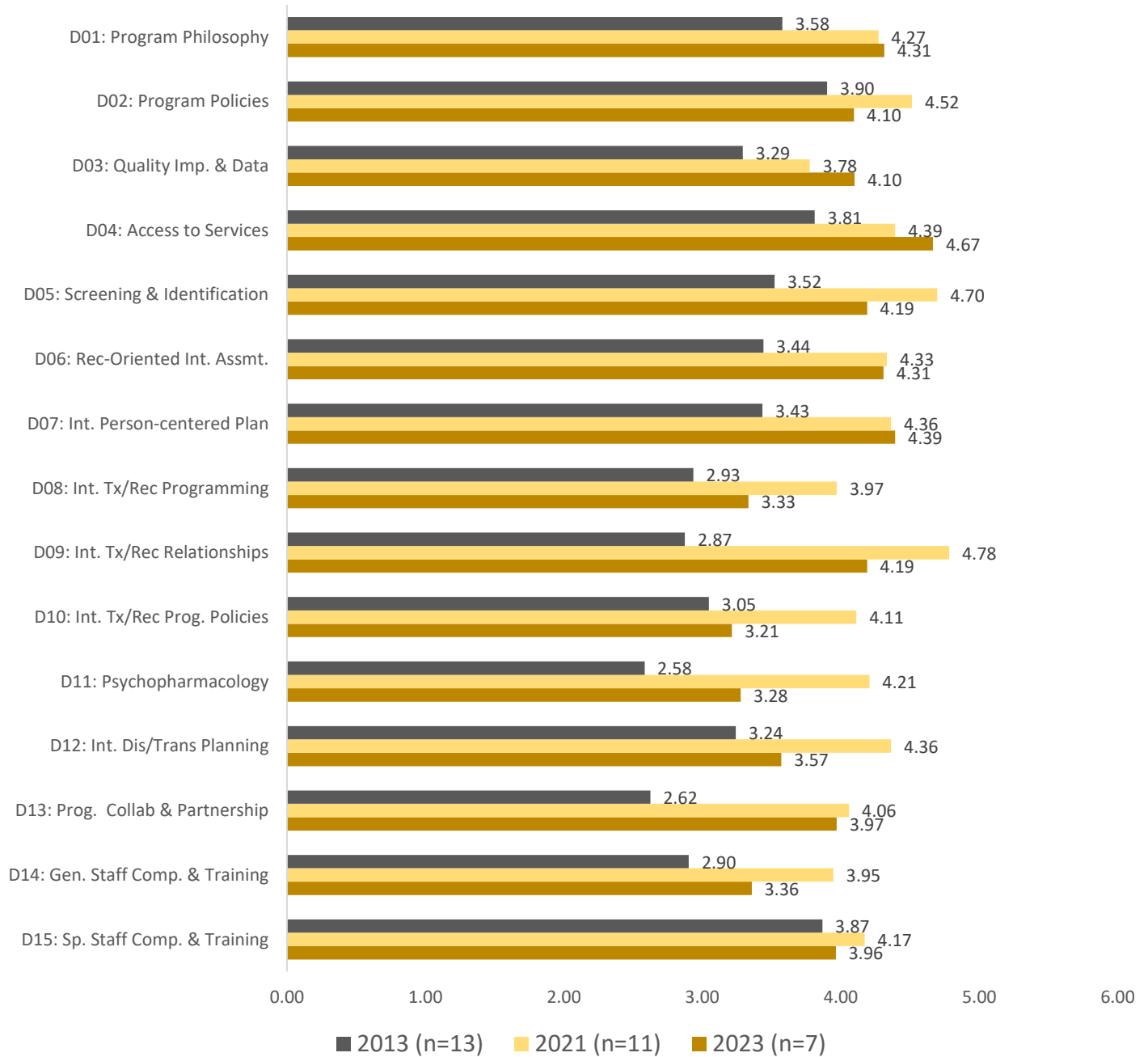
- From the baseline in 2013 to 2023, Domains 13 (1.35), 9 (1.32), and 7 (0.95) showed the greatest increases between means.
- From 2021 to 2023, there were four domains in which the mean scores increased.
 - Domains 3 (0.32), 4 (0.27), and 1 (0.04) had the greatest increases in means over this period.
 - Domains 11 (-0.93), 10 (-0.90), and 12 (-0.79) had the largest decreases in means from 2021 to 2023.

The domain means for Region 2 were greater than the statewide means across all 15 domains.

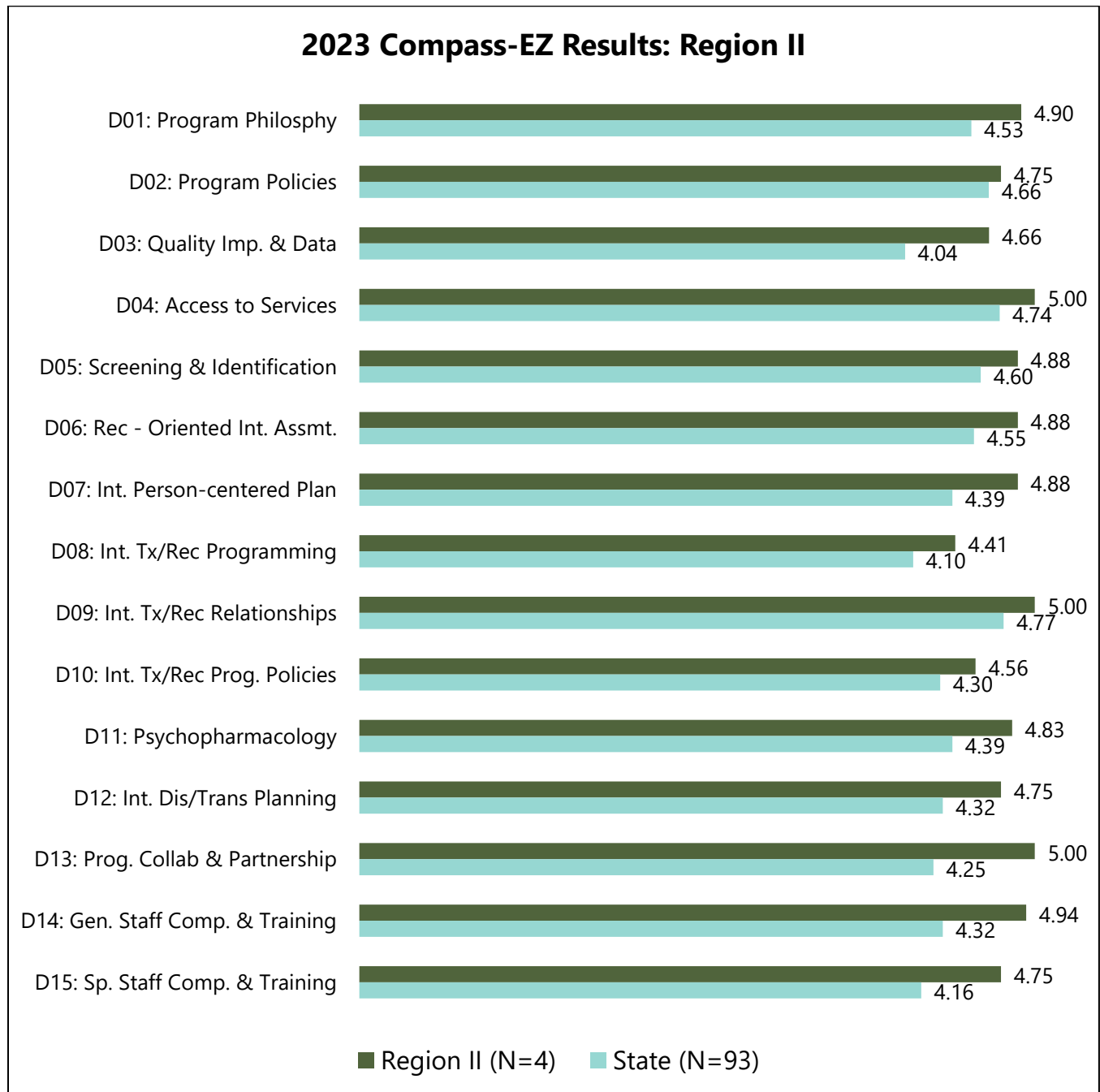


Figure 5: Region 2 and Statewide Domain Means

Region 2 Domain Changes

Level of changes between measurement years (Figure 5, Table 9):

- From the baseline in 2013 to 2023 Domains 6 (1.04), 3 (0.99), and 12 (0.98) showed the greatest increase between means.
- From the previous measure in 2021 to 2023, ten domains saw increased means, three saw decreased mean scores, and two saw no change.
 - Domains 11 (0.83), 1 (0.6), and 8 (0.54) showed the greatest increases between means.
 - Domains 10 (-0.19), 2 (-0.08), and 5 (-0.04) showed the greatest and only decreases between means.

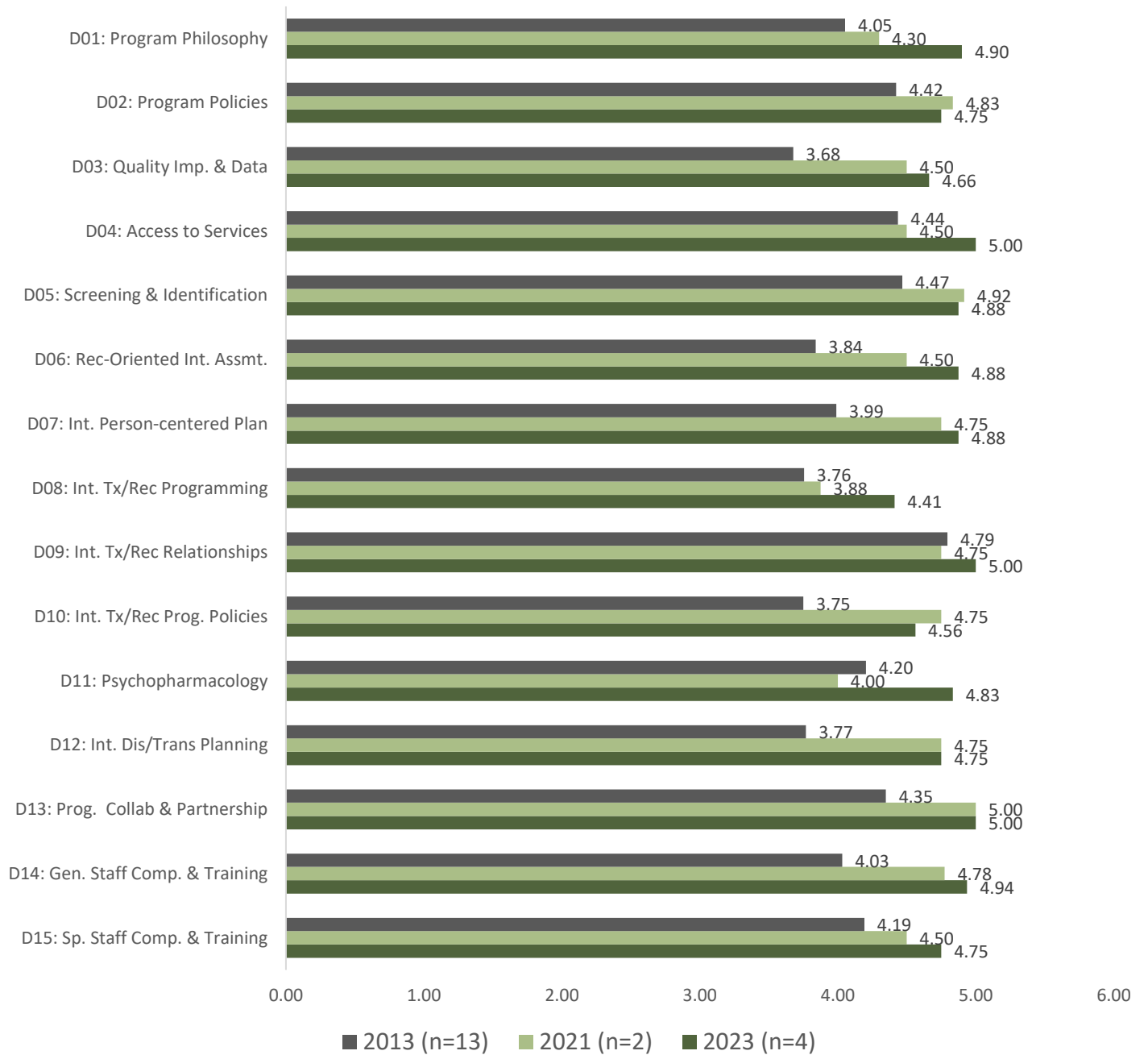


Figure 6: Region 2 Domain Changes

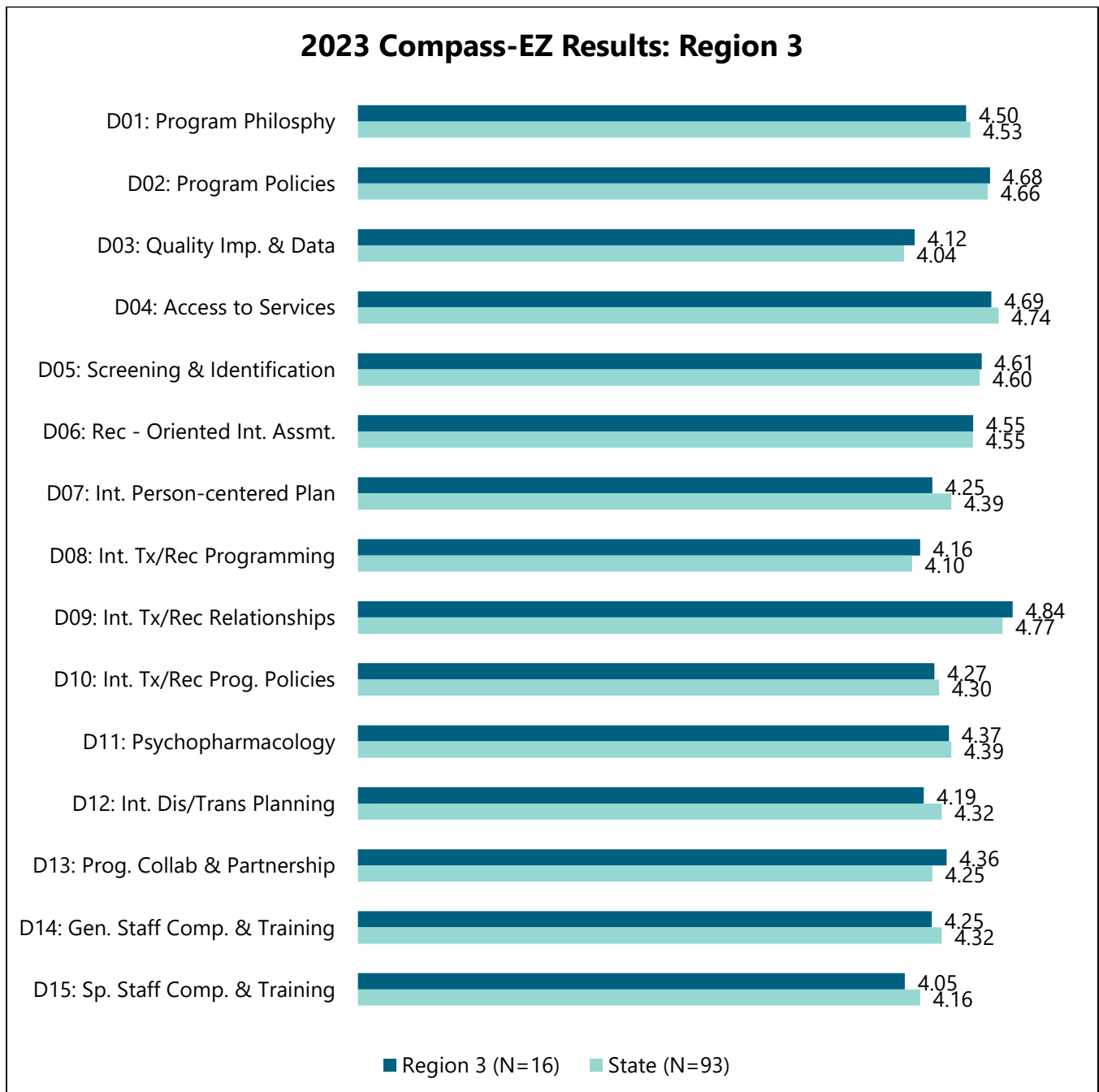


Figure 7: Region 3 and Statewide Domain Means

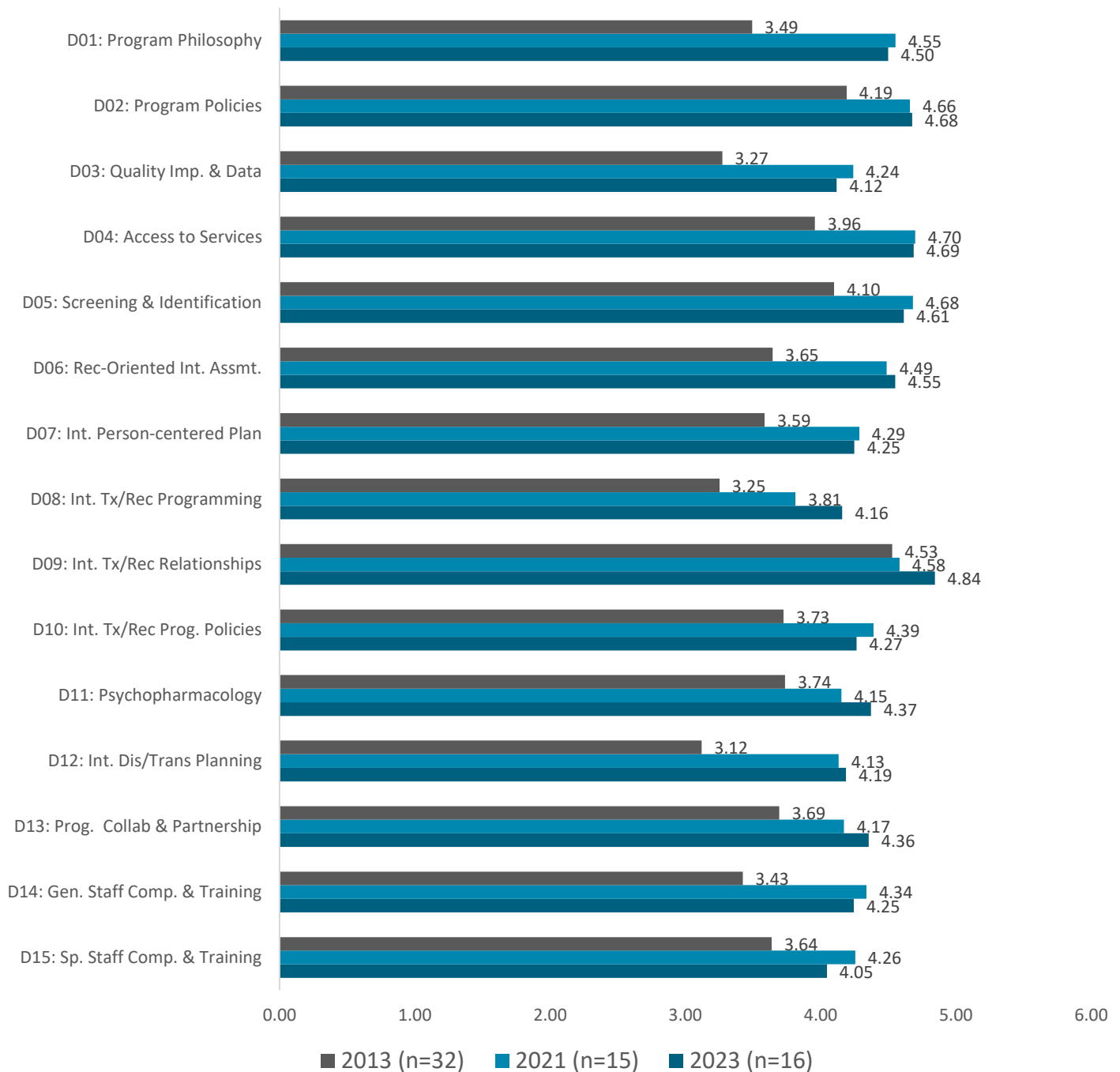


Figure 8: Region 3 Domain Changes

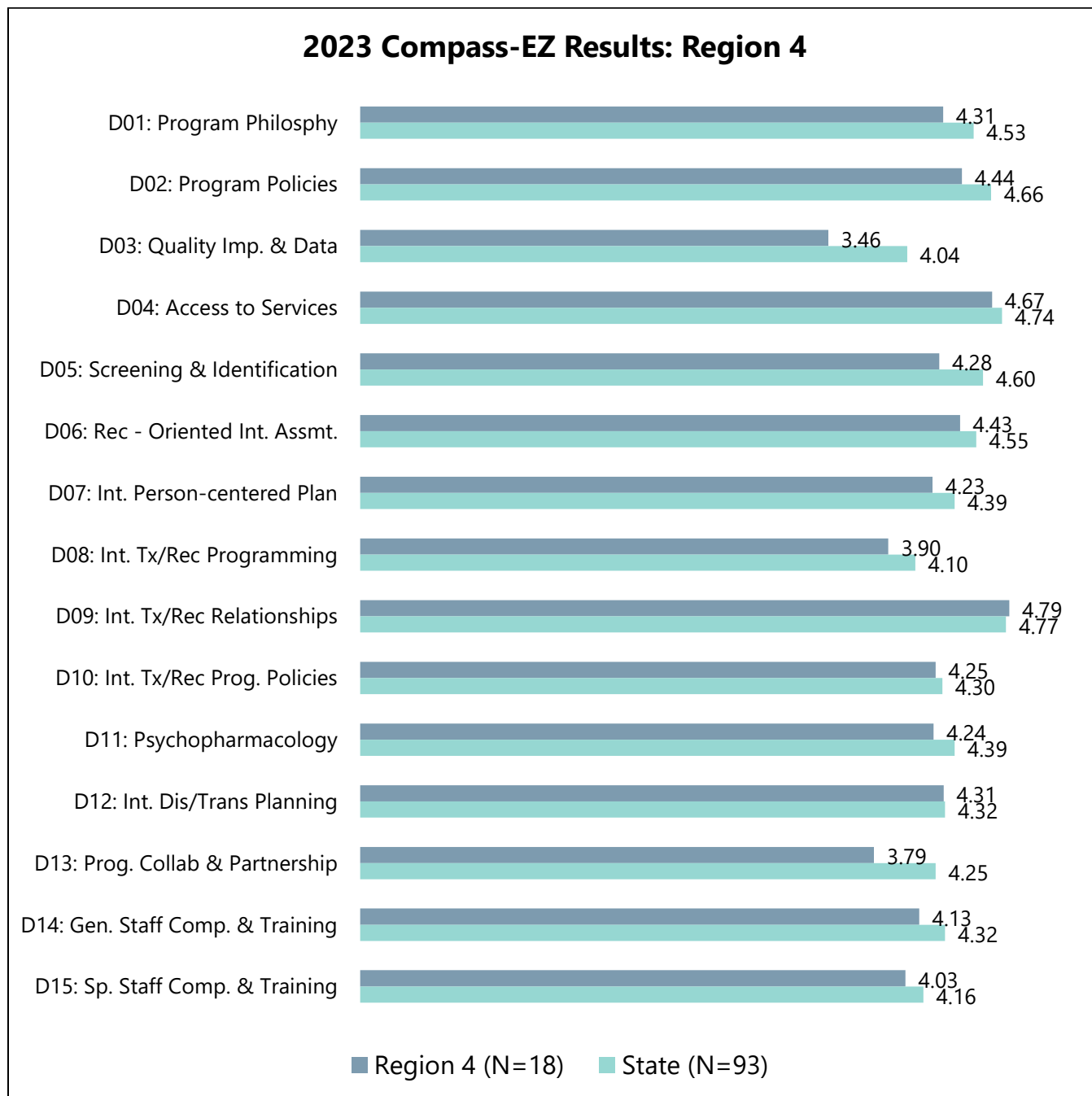


Figure 9: Region 4 and Statewide Domain Means

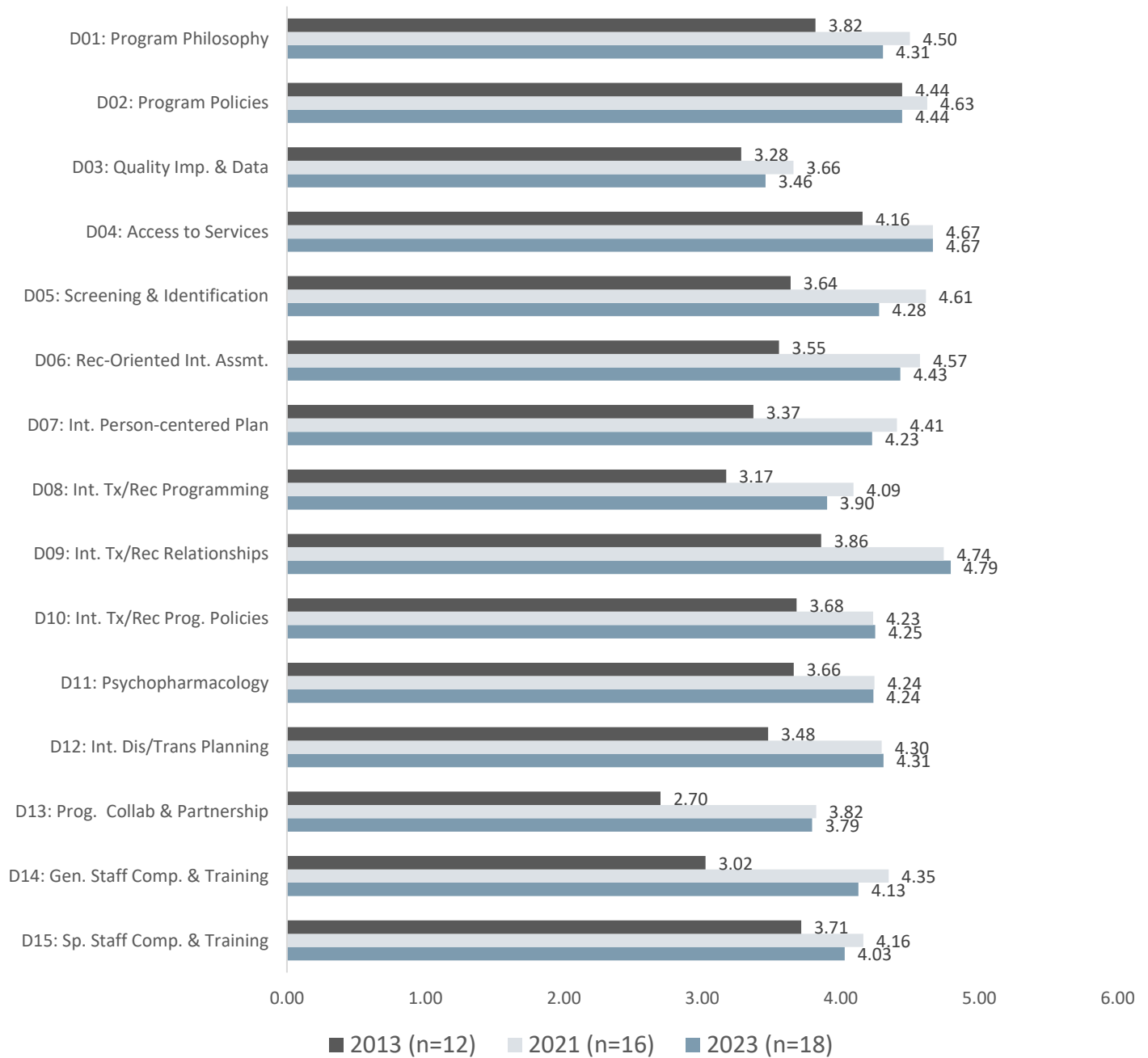


Figure 10: Region 4 Domain Changes

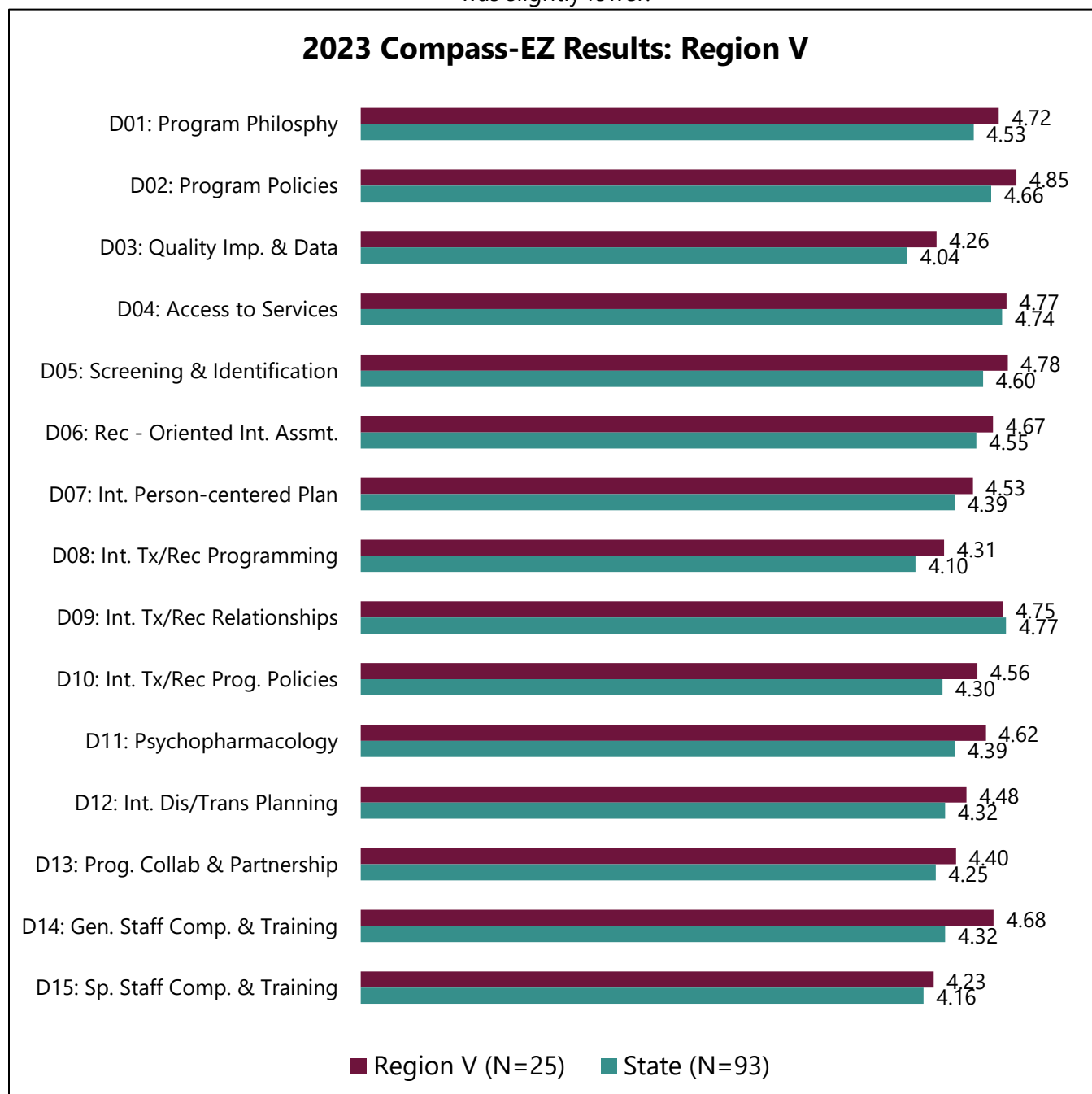


Figure 11: Region 5 and Statewide Domain Means

- From the baseline in 2013 to 2023 Domains 1 (0.97), 12 (0.84), and 14 (0.82) showed the greatest increase. Overall, 14 of the 15 domains showed an increase in mean domain scores.
- From 2021 to 2023, 9 of the 15 domains showed an increased mean domain score.
 - Domains 7 (0.25), 6 (0.25), and 12 (0.18) showed the greatest increases.
 - Domains 15 (-0.29), 9 (-0.10), and 11 (-0.06) showed the greatest decreases.

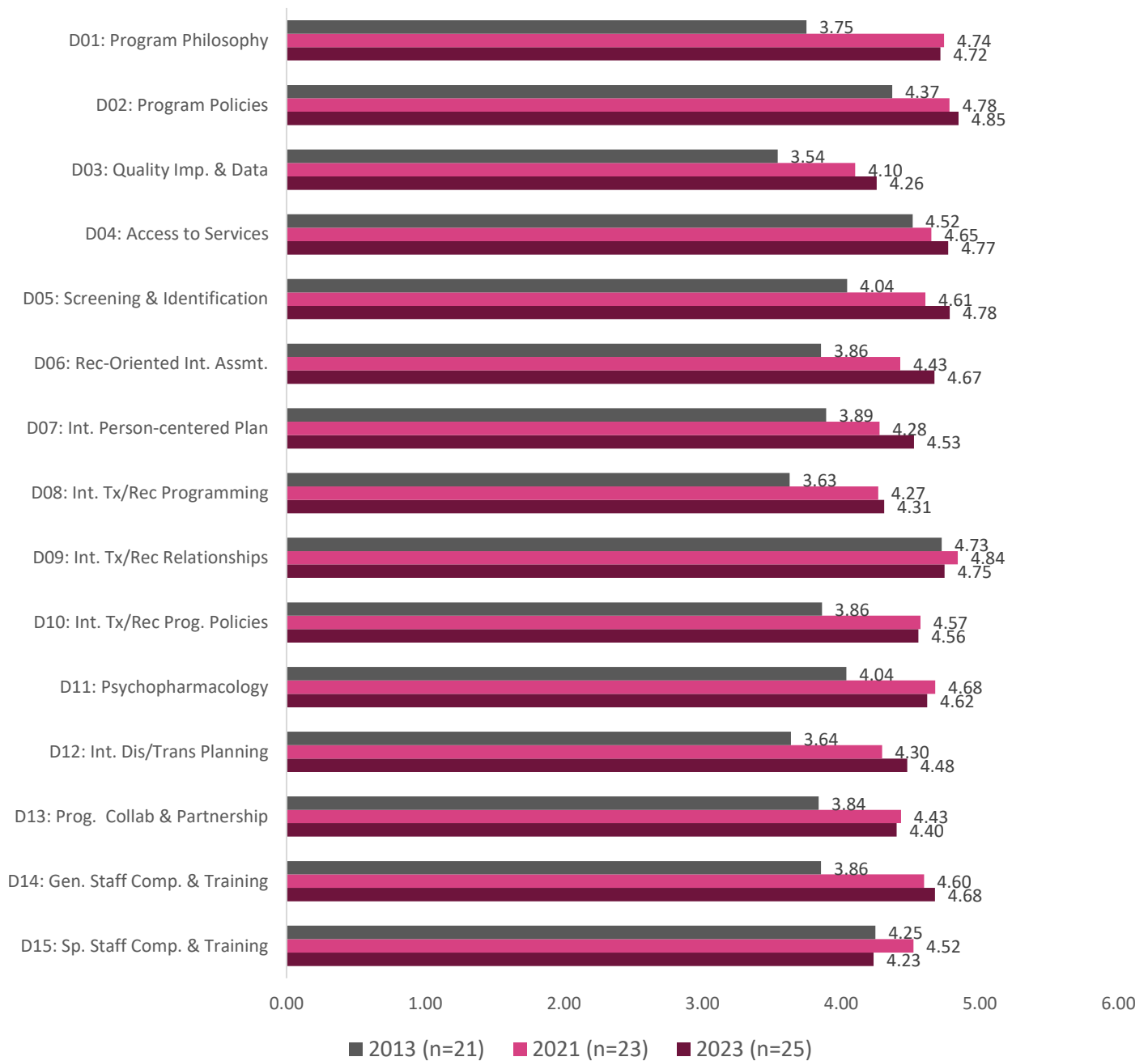


Figure 12: Region 5 Domain Changes

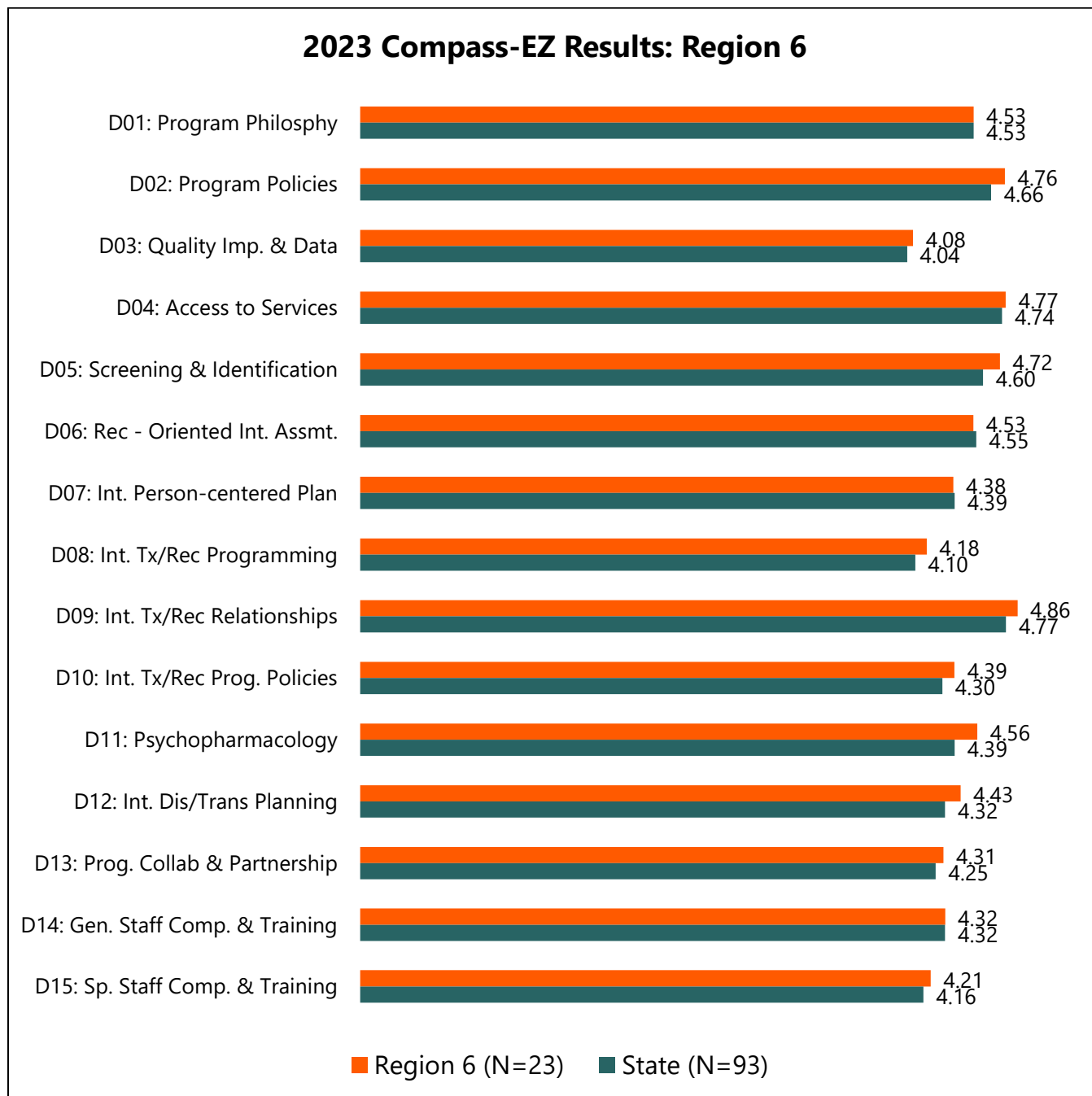


Figure 13: Region 6 and Statewide Domain Means

Region 6 Domain Changes

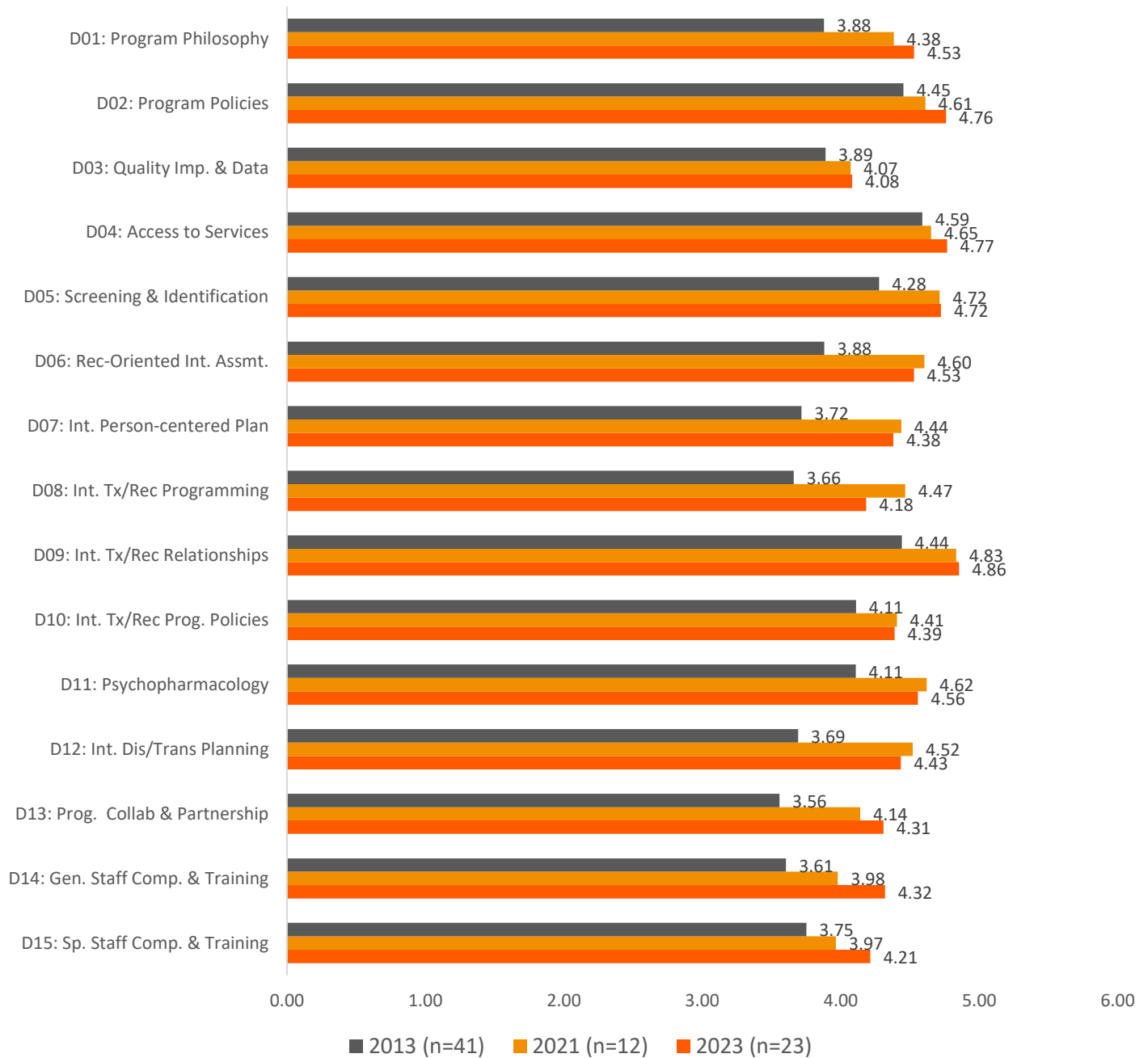


Figure 13: Region 6 Domain Changes

Level of changes between measurement years (Figure 13, Table 25):

- From the baseline in 2013 to 2023, all average domain scores have increased. Domains 13 (0.75), 12 (0.74), and 14 (0.72) saw the greatest increases while Domains 4 (0.18), 3 (0.19), and 10 (0.28) saw the lowest increases.
- From the previous measure in 2021 to 2023 nine domains saw increased average domain scores with the remaining domains saw decreased mean scores.
 - Domains 14 (0.34), 15 (0.25), and 13 (0.17) showed the greatest increases.
 - Domains 8 (-0.28), 12 (-0.09), and 6 (-0.07) saw the greatest decreases.

Compass-EZ Full Item Text

Domain 1: Program Philosophy

Q01_1: The program operates under a written vision, mission or goal statement that officially communicates to all staff and stakeholders the agency-wide goal of all its programs becoming welcoming, recovery-oriented, and complexity (co-occurring) capable.

Q01_2: Written program descriptions specifically say that individuals and families with complex (co-occurring) issues are welcomed for care.

Q01_3: Written program descriptions specifically say that individuals and families with complex (co-occurring) issues will be helped to use their strengths to address all their issues in order to achieve their goals.

Q01_4: The program environment (e.g., waiting room, treatment spaces, wall posters, flyers) creates a welcoming atmosphere that supports engagement and recovery for individuals and families with both mental health conditions and substance use conditions.

Q01_5: Program brochures for clients' welcome individuals and families with complex (co-occurring) issues into service and offer hope for recovery.

Domain 2: Program Policies

Q02_1: Program billing instructions support delivery of integrated approaches within each billing event.

Q02_2: The program confidentiality or release of information policy is written to promote appropriate routine sharing of necessary information between mental health providers, substance abuse providers, and medical providers to promote quality of care.

Q02_3: Clinical recordkeeping policies support documentation of integrated attention to mental health, health, and substance use issues in a single process note and in a single client chart or record.

Domain 3: Quality Improvement and Data

Q03_1: The program has a culture of empowered partnership in which leadership, supervisors, representative frontline staff (clinical and support) and consumers and families work together to design and implement a vision of recovery-oriented complexity (co-occurring) capable services.

Q03_2: The program has a continuous quality improvement team, with representation from leadership, supervisors, frontline staff, and consumers and families, that meets regularly and uses a written plan to guide, track, and celebrate progress toward being recovery-oriented and complexity (co-occurring) capable.

Q03_3: The program has identified and empowered change agents or champions to assist with the continuous quality improvement process.

Q03_4: Program management information systems are designed to collect accurate data on how many individuals in the program have complex (co-occurring) issues.

Q03_5: Program management information systems in infant/child/youth services are designed to collect data on how many families served have complex (co-occurring) issues. (You may omit this question if the program does not specifically serve infants, children, and youth.)

Domain 4: Access

Q04_1: The program has “no wrong door” access policies and procedures that emphasize welcoming and engaging all individuals and families with complex (co-occurring) issues from the moment of initial contact.

Q04_2: Individuals and families receive welcoming access to appropriate service regardless of active substance use issues (e.g., blood alcohol level, urine toxicology screen, length of sobriety, or commitment to maintain sobriety).

Q04_3: Individuals and families receive welcoming access to appropriate service regardless of active mental health issues (e.g., active symptoms, type of psychiatric diagnosis, or type of prescribed psychiatric medications, such as antipsychotics, stimulants, benzodiazepines, opiate maintenance).

Domain 5: Screening and Identification

Q05_1: The program’s screening policy states that all individuals are to be screened in a welcoming and respectful manner for complex (co-occurring) mental health issues (including trauma), substance use issues, medical issues, and basic social needs, and for immediate risk concerns in each of these areas.

Q05_2: The program uses screening processes, checklists, and/or tools for each complex (co-occurring) issue that are appropriately matched to the population being screened.

Q05_3: Staff follow a procedure for clearly documenting positive screenings for complex (co-occurring) issues in the program data system.

Q05_4: The program has a screening process for identifying and documenting co-occurring nicotine use/dependence.

Q05_5: The program has a clear protocol on how to facilitate access to primary health care for every client.

Q05_6: The program has a formal screening procedure for identifying high-risk infectious diseases, including Hepatitis C, HIV and TB.

Domain 6: Recovery-Oriented Integrated Assessment

Q06_1: Assessments document individual and/or family goals for a hopeful, meaningful and happy life using the person’s/family’s own words.

Q06_2: The assessment identifies and elaborates on a specific time period of recent strength or stability, and skills and supports that the individual or family used in order to do relatively well during that time.

Q06_3: The assessment documents data to support the presence of a substance use/gambling issue or diagnosis, including distinguishing between use, abuse and dependence for each substance or behavior.

Q06_4: The assessment documents current and past information to support the identification of a mental health issue or diagnosis when present, including if possible, describing mental health symptoms during previous periods of non-harmful substance use or sobriety.

Q06_5: Assessments routinely document each complex (co-occurring) condition, active or stable, when previously diagnosed or when identified/diagnosed during the current assessment process

Q06_6: The assessment documents the stage of change (i.e., pre-contemplation, contemplation, preparation, early action, etc.) the individual is in regarding each disorder, condition or issue.

Domain 7: Integrated Person-centered Planning

Q07_1: The person's/family's hopeful goals, recent successes and strengths are the foundation of the service plans.

Q07_2: Service plans list all the relevant complex (co-occurring) issues in the plan.

Q07_3: For each of the complex (co-occurring) issues listed in the plan, there is an identified stage of change, stage-matched interventions, and achievable steps to help the person feel and be successful.

Q07_4: Person-centered plans focus on building skills and supports, using positive rewards for small steps of progress in learning and using skills and supports.

Domain 8: Integrated Treatment/Recovery Programming

Q08_1: Educational materials about complex (co-occurring) disorders and recovery are routinely provided to clients and families.

Q08_2: All clients are engaged in group or individual work that provides basic education and assistance with choices and decisions regarding complex (co-occurring) issues.

Q08_3: Clients have access to group programming that is matched to their stage of change for each issue. (You may omit this question if the program does not have groups.)

Q08_4: There are specific group or individual interventions for all clients providing education about psychiatric medications, including how to take medication as prescribed, and how to take medications more safely if continuing to use substances.

Q08_5: There are specific co-occurring skills manuals that are used regularly in the program for individual or group skill building regarding complex (co-occurring) conditions, such as manuals on managing trauma symptoms while in addiction treatment, or sobriety skill building while in mental health treatment.

Q08_6: Clients with complex (co-occurring) issues are helped to get involved with individual and group peer support for both mental health and substance use issues, including dual recovery support programs.

Domain 9: Integrated Treatment/Recovery Relationships

Q09_1: Each client has a primary relationship with an individual clinician or team of clinicians that integrates attention to complex (co-occurring) issues inside the relationship.

Q09_2: The primary clinician or team continues working with the client on each issue even when the person may still be using substances, may not be taking medication as prescribed, or may be having trouble following other aspects of the treatment plan.

Q09_3: Each clinical staff person on the team directly provides and documents the delivery of integrated services.

Domain 10: Integrated Treatment/Recovery Program Policies

Q10_1: Program policies state clearly that individuals are not routinely discharged or "punished" for substance use, displaying mental health symptoms, or having trouble following a treatment plan.

Q10_2: Program policies and procedures are designed to reward individuals for asking for help when they are having difficulty or beginning to relapse with any issue.

Q10_3: Integrated service plans and behavioral policies provide for positive reward for small steps of progress in addressing any problem, rather than focusing on negative consequences for "treatment failure," "relapse," "inappropriate behavior," or "non-compliance."

Q10_4: For clients with complex (co-occurring) issues who are also involved with the court or with child welfare, integrated service plans are designed to reward small steps of progress to help clients be successful with their multiple issues, not just to monitor compliance with external mandates.

Domain 11: Psychopharmacology

Q11_1: Whether prescribing is done on- or off-site, there are procedures, forms, and materials to help clients learn about medications, communicate openly with prescribers, and take medication as prescribed.

Q11_2: The program provides and documents for all clients' routine communication between clinical staff and medical and mental health prescribers.

Q11_3: Policies or practice guidelines specify access to medication assessment and prescription without requiring a mandatory period of sobriety.

Q11_4: Policies or practice guidelines ensure that necessary medications for treatment of serious mental illness are appropriately maintained even though clients may continue to use substances.

Q11_5: Medications with addictive potential (e.g., benzodiazepines) are neither routinely initiated nor routinely refused in the ongoing treatment of individuals with substance dependence. Prescription of such medications is individualized based on evaluation and consultation or peer review.

Q11_6: Medications used specifically for treatment of substance use disorders are prescribed routinely for clients who might benefit from such medications as part of their treatment.

Domain 12: Integrated Discharge/Transition Planning

Q12_1: Discharge plan policies, procedures, practices, and forms address specific stage-matched continuing care requirements for each complex (co-occurring) issue.

Q12_2: Each discharge plan for individuals and/or families with complex (co-occurring) issues provides for continuing integrated care with a clinician or team, ideally in a single setting.

Domain 13: Program Collaboration and Partnership

Q13_1: The program has developed a network of partner programs offering differing services to function as a learning collaborative to develop its own recovery-oriented complexity (co-occurring) capability and to help other programs to do the same.

Q13_2: The program has policies and procedures for documentation of care coordination and collaborative service planning for clients with complex (co-occurring) issues who attend services in another program.

Q13_3: There is a routine process where program staff provide complexity (co-occurring) consultation (ideally on site) to a collaborative program providing services in the "other" domain.

Q13_4: There is a routine process where program staff receive complexity (co-occurring) consultation (ideally on site) from a collaborative program providing services in the "other" domain.

Q13_5: Designated program clinicians participate in a regularly scheduled mental health and substance abuse provider interagency care coordination meeting that addresses the needs of individuals and/or families with complex (co-occurring) issues.

Domain 14: General Staff Competencies and Training

Q14_1: There are specific recovery-oriented complexity (co-occurring) competencies for all staff included in human resource policies and job descriptions.

Q14_2: The program has a written scope of practice for complexity (co-occurring) competency for all clinicians trained or licensed in only one area of service (e.g., licensed or formally trained in mental health OR substance abuse, but not both).

Q14_3: The program has written procedures for routinely documenting complex (co-occurring) issues and interventions provided by any clinician with any level of licensure or training.

Q14_4: The program has a written plan for recovery-oriented complexity (co-occurring) competency development (e.g., supervision, training activities) related to all staff (e.g., clinical, support, management).

Q14_5: Supervisors have the appropriate knowledge and skills to help staff become more welcoming, recovery-oriented and complexity (co-occurring) competent.

Q14_6: Recovery/resiliency and complexity (co-occurring) competencies are evaluated as part of annual staff performance reviews.

Domain 15: Specific Staff Competencies

Q15_1: The program staff demonstrate competency to welcome and address the needs of clients with complex (co-occurring) issues who are from different cultural and linguistic backgrounds.

Q15_2: The program staff demonstrate specific competency in working on complex (co-occurring) issues with clients who have cognitive impairments (e.g., clients with learning disabilities, intellectual impairments, thought processing difficulties).

Q15_3: The program staff demonstrate specific competency in providing family support, family psychoeducation, family-to-family peer support, and in addressing complex (co-occurring) issues with families in the context of these individual or group interventions.

Q15_4: The program staff demonstrate specific competency in providing developmentally matched services to seniors and older adults with complex (co-occurring) issues. (You may omit this item if the program does not provide senior or older adult services.)

Q15_5: The program staff demonstrate specific competency in providing developmentally matched services to children and youth with complex (co-occurring) issues. (You may omit this item if the program does not provide services to children and youth.)
