### Nebraska Mental Health Commitment Records Reported to National Instant Criminal Background Check System Status Report

Nebraska State Statute § 69-2409.01 requires the Department of Health and Human Services and Nebraska State Patrol to report to the Legislature on mental health commitment activities of the state.

69-2409.01 (5) The Nebraska State Patrol and the Department of Health and Human Services shall report electronically to the clerk of the Legislature on a biannual basis the following information about the database (mental health commitments):

- (a) The number of total records of persons unable to purchase or possess firearms because of disqualification or disability shared with the National Instant Criminal Background Check System;
- (b) The number of shared records by category of such persons;
- (c) The change in number of total shared records and change in number of records by category from the previous six months;
- (d) The number of records existing but not able to be shared with the National Instant Criminal Background Check System because the record was incomplete and unable to be accepted by the National Instant Criminal Background Check System; and
- (e) The number of hours or days, if any, during which the database was unable to share records with the National Instant Criminal Background Check System and the reason for such inability.
