

## State Targeted Response (STR) Opioid Crisis Grant Program Overview

**Project time period:** 05/01/2017 – 04/30/2019

**Purpose:** Nebraska’s State Targeted Response to the Opioid Crisis Grant program aims to substantially reduce the incidence of abuse of prescription and illicit opioid drugs through ongoing collaboration between practitioners, experts, and leaders across the continuum of care. The program will also work to mitigate the effects of opioid use disorders (OUD), including both prescription opioids and illicit drugs such as heroin, by identifying statewide needs, increasing access to treatment, including medication assisted treatment, and reducing prescription drug overdose deaths through the provision of prevention, treatment and recovery activities.

While the misuse of prescription opioids and the use of heroin have reached epidemic proportions in other areas of the United States, Nebraska is not experiencing the same crisis that other states are with these drugs. This places Nebraska in a position to focus on prevention and workforce capacity to safeguard against a significant increase in opioid use disorders, opioid overdoses, and opioid-related deaths.

<b>Prevention</b>	Promotion of prescribing guidelines
<b>Prevention</b>	Promotion of Prescription Drug Monitoring Program (PDMP)
<b>Prevention</b>	Promotion of the Dose of Reality awareness media campaign
<b>Prevention</b>	Increase in safe drug disposal initiatives
<b>Prevention</b>	Fund community coalitions to provide OUD prevention best practices in communities of need
<b>Prevention</b>	Provide naloxone to at-risk populations and providers
<b>Treatment</b>	Create an addiction medicine fellowship
<b>Treatment</b>	Train providers in the ECHO model
<b>Treatment</b>	Purchase buprenorphine
<b>Treatment</b>	Increase utilization of medication assisted treatment
<b>Recovery</b>	Identify an opioid-specific training for individuals providing peer support
<b>Recovery</b>	Enhance recovery support services
<b>Recovery</b>	Train treatment providers who serve consumers transitioning from criminal justice settings or other rehabilitative settings

**Target population:** Nebraska intends to serve the entire population of the state through training and prevention initiatives, while targeting high burden areas of the state for outreach, training and technical assistance.

**Intended reach:** Increase the number of clients served by the DHHS Division of Behavioral Health in the opioid replacement therapy service by 5% each year. Supply 1,000 naloxone kits to high-risk clients each year, resulting in 2,000 Nebraskans having access to this life-saving drug. Serve approximately 340 individuals receiving assistance with treatment and in support of their path to recovery by providing funding for medication assisted treatment through the use of buprenorphine.
