

# **2025 BOARD OF HEALTH FACT SHEET**

## **STATUTORY AUTHORITY:**

- N.R.S. 71-2601 through 71-2611 (Revised July 1, 2007).

## **MEMBERSHIP and MEETINGS:**

- 17 members appointed by the Governor for five-year terms. Members appointed in 2025: Ryan Palmer, OD; Jeremiah Rethwisch, DC; and Jacob Sikes. Current vacancies: Veterinarian and Physician representatives.
- 2025 Officers: Chair David Reese, Vice Chair Dan Vehle, and Secretary Brett Lindau. 2026 officers were elected at the November meeting and remain as listed above.
- Meetings are generally held the fourth Monday in January, and the third Mondays of March, June, September, and November. There was 1 special and 5 regular meetings held in 2025. Governor Pillen met with the Board of Health members on September 15, 2025.
- 2026 meeting dates: January 26, March 16, June 15, September 21, and November 16.

## **PROFESSIONAL BOARD APPOINTMENTS:**

- In 2025 there were 82 applicants; 51 interviews conducted; and 43 members appointed or reappointed to different professional boards. There are 27 professional boards in total including the newly created Board of Behavioral Analysts. Two boards, APRN and ADC, will be sunsetted in 2026 and some positions will be added the Board of Nursing and the Board of Mental Health Practice.
- There were 41 positions that we were unable to fill. With those, we have 41 planned for 2026.

## **RULES AND REGULATIONS:**

- There were 5 sets of regulations submitted for approval in 2025. Many of the updates were required due to Uniform Credentialing Act updates and reducing duplicative language.

## **CREDENTIALING REVIEW:**

- Completed the reviews on Occupational Therapists and Nurse Practitioners. There are no reviews in process. A new Credential Review manual was developed with input from several stakeholders. <https://dhhs.ne.gov/licensure/Pages/Credentialing-Review.aspx>

## **PUBLIC HEALTH, EDUCATION & LEGISLATION:**

- Researched initiatives to develop position statements and prepare news articles.
- Received regular presentations by the DHHS Chief Medical Officer, Director of Public Health, State Epidemiologist and the Legislative Liaison. Healthcare Workforce Issues and LB503.

## **REVIEW PANEL:**

- There is an ad hoc committee to address the potential removal of professional board members for cause, in accordance with 184 NAC Ch. 6. There was no need to meet in 2024.

**Committee Goals:**

In November 2025, the current Committee Chair and members established the following committee goals for 2026:

1. Continue to work with professional organizations to increase the pool of qualified applicants for positions. Urge organizations to nominate at least three members for consideration.
2. Utilize the prescreening process again to make the best use of our interview times.
3. Continue to build and utilize the data base of professional board applicants who were excellent candidates, but for various reasons were not appointed to the positions they were seeking. Continue to develop and use protocol for notification, content of the letter or to be handled on an individual basis based upon the Professional Board recommendations. These applicants should receive consideration for the Credentialing Review Pool or PREP.
4. Utilize the peer evaluation process for incumbents for the 2024 interviews and develop a method of obtaining feedback from board members and staff about the process.
5. Improve upon and continue to use more efficient electronic means of processing application forms.
6. Formalize and continue the process of inviting professional board chairpersons to meet with the Committee and discuss how their board functions and any concerns or issues they have that the Board of Health might address. Increase the number of board members maintaining contact with the assigned professional boards to enhance communication and clarify BOH members function at professional board meetings. Discuss possibilities for consolidation or mergers of boards.
7. Develop guidelines for the appointment of individuals who wish to serve concurrently on more a Professional Board as well as the Credentialing Review Pool.
8. Further define the role of the committee in mediating issues with professional board members.

There were 60 planned vacancies for 2024. This number always goes up based on resignations and deaths.

***Committee Duties and Responsibilities:***

The Public Health, Education, and Legislation (PHEL) Committee met via conference call one time during 2025 and in person five times. Their objective is to identify and promote public education and legislation to enhance the health, mental health, and living environment of all residents of Nebraska.

***Activities in 2025:***

***January:***

In the morning committee meeting they reviewed the legislative bills on the BOH Tracker as potential bills to follow. Board of Health members were identified as liaisons to most bills. At the public meeting we voted on official Board of Health positions on specific bills. If any board members wants to speak or testify on a specific bill, they either need to be approved by the Board of Health, or be clear that they are testifying on their own and not as a board member.

The Public Health Recognition Program has been dormant and there was a committee discussion about resurrecting it. Dr. Petersen will lead a subcommittee for this, and Dr. Hubert and Ms. Stuhmer will join efforts.

***March:***

In the morning committee meeting we reviewed the status of legislative bills on the Board of Health Legislative Tracker sent out almost daily by Monica Webb.

The Public Health Recognition Program format was discussed. Dr. Petersen, along with Dr. Hubert and Ms. Stuhmer, reviewed the program and suggested updating the nomination form and reactivating it.

The Board approved a motion to create a sunset provision for the Public Health Recognition Program. If the program is not extended in March 2027, the program would cease.

Dr. Cook distributed a draft statement to the Legislature in support of LB202 Exempt certain activities from disciplinary action under the Medicine and Surgery Practice Act. After discussion, the Board voted to approve the draft statement. Monica will post the statement on behalf of the Board of Health. There was a question about liability for Board of Health members in the performance of their duties. N.R.S. 71-2611 addresses coverage.

**June:**

Reviewed final actions of the Legislature this session including implementation strategies.

**September:**

The nomination form for the Public Health Recognition Program has been updated to be a fillable pdf. The program will be highlighted on the main Division of Public Health or Licensure Unit webpage. Caryn Vincent offered to share information about this program with local health directors.

The 2026 Legislative session begins on Wednesday, January 7. Day 10 will be January 21, which is the last day for bill introduction. The PHEL Committee will have a conference call at 3:00 PM on Thursday, January 22, 2026 to discuss the bills.

**November:**

The committee discussed an interactive document to track legislation in the 2026 session before. Members learned about how they could provide information to senators regarding the Credentialing Review Program.

***Committee Objectives for 2026:***

- ✓ Develop BOH position statements directed toward public health issues that affect Nebraskans.
- ✓ Advocate for and actively support proposed legislation that enhances health of Nebraskan's citizens, including opportunities for the education and development of health care professionals, especially in underserved areas in Nebraska.
- ✓ Nominate public health programs that have worked to improve the lives of Nebraskans.
- ✓ Inform and educate about selected health programs in Nebraska that promote public health and the prevention of health and behavioral health problems. Areas of interest include Environmental issues, and Communication/Representation by Board members.
- ✓ Find effective methods to actively monitor and impact introduced legislation via electronic and other safe means during a pandemic.
- ✓ Collaborate with DHHS to get public health initiatives out. Work with Chief Medical Officer.
- ✓ Plan retreats and provide program content for special meetings of the Board of Health.
- ✓ Cooperate with district health departments and other public health entities to promote issues.

The State Board of Health is required by law to consider all rules and regulations of the DHHS Division of Public Health. Professional and occupational credentialing regulations must be adopted (or “approved”) by the Board. Other regulations of the Division of Public Health must be advised upon (or “reviewed”) by the Board.

To enhance discussion and improve efficiency of Board meetings, all Public Health regulations come before the Board’s Rules and Regulations Committee prior to the meeting of the full Board. Staff support for the Rules and Regulations Committee was provided by Monica Webb.

Staff worked hard to create and revise sets of regulations to reduce duplication and comply with new mandates, with several more in process. We continue to monitor movement of draft regulations through the process and attend public hearings.

Regulations reviewed and approved in 2025:

January: There were no proposed regulations before the Board of Health today

- Title 177 NAC 7 – Methods and Permits for Analyses to Determine the Presence of Drugs.
- Title 172 NAC 97 – Approval of Basic Nursing Programs in Nebraska.

- 172 NAC 94, Independent Mental Health Practitioners, Mental Health Practitioners, Marriage and Family Therapists, Professional Counselors, Art Therapists, and Social Workers.
- 184 NAC 3 - Rules of Practice and Procedure of the Department of Health for Petitions for Promulgation, Amendment, or Repeal of Regulations.

172 NAC 2 – Care of Clients with Tuberculosis.

November:

There were no proposed regulations for the Board of Health at this meeting.

### **Goals for 2026**

The Rules and Regulations Committee will consider all regulations of the DHHS Division of Public Health prior to their presentation to the Board of Health, with adequate time to make recommendations.

This will include consideration for approval of additional professional and occupational credentialing regulations under the Uniform Credentialing Act (UCA).

The Committee will also continue to review all other regulations of the Division of Public Health. This will include program regulations of the following units of the Division:

- Community and Rural Health Planning
- Epidemiology and Informatics
- Environmental Health
- Health Promotion
- Lifespan Health Services

Special meetings will be scheduled as necessary to keep the regulations process moving.
