## **NEW 2021 CONTINUING COMPETENCY REQUIREMENT:**

**ATTENTION:** All Physician Assistants who prescribe controlled substances:

Requirement: 3 hours of the 50 hours of Category 1 CE (continuing education) are required to be on the subject of opioids and .5 hours of the 3 hours are required to be on the subject of the PDMP (Prescription Drug Monitoring Program).
