Chiropractor Member	Active license to practice chiropractic in Nebraska.
Dentist Member	Active license to practice dentistry in Nebraska.
Hospital Administrator Member	Administrator of a hospital in Nebraska which is licensed under the Health Care Facility Licensure Act.
Mental Health Professional Member	Credentialed Mental Health Professional.
Nurse Member	Active license to practice nursing in Nebraska.
Optometrist Member	Active license to practice optometry in Nebraska.
Osteopathic Physician Member	Active license to practice osteopathic medicine and surgery or as an osteopathic physician in Nebraska.
Pharmacist Member	Active license to practice pharmacy in Nebraska.
Physical Therapist Member	Active license to practice physical therapy in Nebraska.
Physician Member	Active license to practice medicine and surgery in Nebraska.
Podiatrist Member	Active license to practice podiatry in Nebraska.
Professional Engineer Member	A professional engineer in Nebraska.
Public Member	Public-spirited citizen of Nebraska interested in the health of the people of the State of Nebraska and not less than twenty-one years of age.
Veterinarian Member	Active license to practice veterinary medicine in Nebraska.
