#### PHARMACY TECHNICIAN SEAT ON THE BOARD OF PHARMACY LETTER

Dear Board of Pharmacy Members,

We are writing to express our strong support for the establishment of a dedicated board member seat for a pharmacy technician on the Board of Pharmacy in your state. We are a group of pharmacy technicians that currently or recently have served as board members on our respective Boards of Pharmacy but are sending this letter as a representation of our individual thoughts, not on behalf of any board or NABP. We have seen firsthand the evolving and expanding role of pharmacy technicians in healthcare. Including a pharmacy technician on the Board provides invaluable insights, ensures more comprehensive decision-making, and better reflects the composition of the professional pharmacy workforce.

In 2022 our team put forward a resolution through NABP to support pharmacy technicians on boards of pharmacy which passed nearly unanimously. The Model Act has been amended to include language to support a pharmacy technician board seat as part of the Board of Pharmacy makeup [Section 202]. The Model Act serves as NABP's "endorsement" for regulatory and statutory language. The next step is carrying the momentum forward into your state to make the change that is needed.

Pharmacy technicians have become integral to the operation of pharmacies across various settings – retail, hospital, compounding, long-term care, specialty, operations, education, compliance, regulatory, and beyond. Their responsibilities have significantly increased in scope and complexity. Yet, despite these critical duties, the unique perspectives and challenges faced by pharmacy technicians are often underrepresented in policy and regulatory discussions that impact the profession.

A dedicated board seat for a pharmacy technician offers several key benefits:

Representation of the Pharmacy Team: Pharmacy technicians are vital in delivering safe and effective care to the public. Their inclusion on the Board would help to better represent the makeup of a pharmacy team and ensure decisions are made by pharmacy professionals involved in patient care.

Enhanced Regulatory Insight: Pharmacy technicians provide the Board with crucial insights into the practical implications of regulatory changes, particularly those related to pharmacy operations and patient

safety. Their experience in day-to-day pharmacy practice offers a valuable perspective in the creation and revision of rules and regulations.

Patient-Centered Care: Pharmacy technicians often serve as the first point of contact for patients in the pharmacy. Their unique understanding of patient needs and concerns is an asset in the development of more patient-centered policies and regulations, ultimately improving the quality of care provided and patient safety.

As the role of pharmacy technicians continues to evolve, it is crucial that their contributions are recognized and that they have a voice in shaping the policy and regulations within the practice of pharmacy. A dedicated board seat for a pharmacy technician not only acknowledges their critical role within the pharmacy profession, but also enhances the Board's ability to create informed, effective policies and regulations that benefit the entire healthcare system.

We respectfully urge the Board to consider this important step towards inclusivity and representation. Thank you for your attention to this matter, and for your ongoing commitment to public safety and the pharmacy profession.
