1. ROLL CALL

The Board of Nursing Home Administration was called to order by the Chair, Shannon Buckminster, at 1:01 p.m., at the Nebraska State Office Building, 301 Centennial Mall South, Lower-Level Morrill Room, Lincoln, Nebraska. - e) **Reports: Disciplinary and Non-Disciplinary Actions; License Statistics; and Examinations:** Fish expressed concern about the low numbers in the Nursing Home Administrator profession. She suggested we need to take action to attract more people to the field. She encourages others to get people to become preceptors and promote the profession. Some are participating only for the continuing education credits. The number of people taking the exam was higher before COVID. Since COVID, the number of exam takers has decreased.

Buckminster mentioned that people go through the education but don't take the exam.
