DEPARTMENT OF AGRICULTURE UPDATES

Kaylie Fritts, DVM, Deputy Nebraska State Veterinarian with the Agriculture Department, was present via WebEx for discussion with the Board.

H5N1 or Avian Influenza – there is an uptick in detections with the migratory season in wild waterfowl.

Good News – for Large Animal medicine there will be a free ECVI (Electronic Certificate of Veterinary Inspection) platform that will be available this spring which will make it easier for Veterinarians to file the health certificate to cross state lines.

New World Screwworm (NWS) – continues to be an issue in Mexico. Nebraska at this time of the year has a natural barrier with our cold weather.

PRACTICE QUESTION(S)

A. Are Equine Aquatred, Theraplate and Equine Acuscope/Myopulse considered as an “apparatus”?

Mindi Clarke, Certified for Equine Acuscope from Lincoln, NE – presented the Practice Question to the Board.

It is the Board’s opinion that you would need to be licensed as a Veterinarian to provide these services in Nebraska.

The Board suggested that if Ms. Clarke is interested in providing a pathway for these services to be provided by anyone other than a licensed veterinarian that she should seek the support of a State Senator for Statutory change.

DESIGNATION OF THE METHOD BY WHICH THIS BODY WILL GIVE PUBLIC NOTICE OF ITS MEETINGS

Jan Gadeken-Harris explained that the Board needs to inform the public each year the method by which the Board will provide notice of their meetings.
