LEGISLATION & REGULATION UPDATES

Megan Kilgore, Executive Director of the NVMA (Nebraska Veterinary Medical Association) and Kaylie Fritts, DVM, Deputy Nebraska State Veterinarian with the Agriculture Department were present for discussion with the Board.

Dr. Byers is proposing the NVMA explore with their lobbying ability the need or possibility of amending Statute to include specific licensed specialties for Veterinarians.

Dr. Farrington agreed to draft questions for the Board to approve and then consult with Megan to address the NVMA constituents for feedback.

Since Josh Schlote, LVT member of the Board was unable to be at the meeting the Board wants to table the discussion regarding the current needs for Veterinary Technicians in the field of large animal veterinary practices. They have requested that Dr. Fritts or Dr. Dudley with the Department of Agriculture attend the next meeting to join in on that discussion to provide their perspective.
