PRACTICE QUESTION(S)

- A. With the recent DEA expansion of the telemedicine rules is it permitted under Nebraska laws and regulations for licensed physicians to prescribe Suboxone and Buprenorphine products specifically for opiate use disorder VIA initial telemedicine consult either audio or video without an initial in-person appointment?
- B. If so, is there any length of time which a physician can continue to prescribe without an in-person appointment OR after a specific amount of time OR whether they can be prescribed via telemedicine indefinitely?

It is the opinion of the Board that it does not give legal advice and that it would be best practice to consult their attorney for advice on the questions above.

Adam commented that the Board working with the Department Legal could develop or evaluate the Board's role in giving recommendations or what suggested best practices might be going forward.
