#### **LEGISLATION & REGULATION UPDATES**

Megan Kilgore, Executive Director of the NVMA (Nebraska Veterinary Medical Association) and Kaylie Fritts, DVM, Deputy Nebraska State Veterinarian with the Agriculture Department were present for discussion with the Board.

Dr. Byers is proposing the NVMA explore with their lobbying ability the need or possibility of amending Statute to include specific licensed specialties for Veterinary professionals. Dr. Byers believes that the Nebraska Practice Act should incorporate language regarding DVM and Veterinary Technician specialists. Dr. Byers feels that perhaps there is not a need for a specialist specific license, but he thinks defining and restricting the use of the term is appropriate and in the interest of public health and for the animal owner awareness.

The Board also discussed the need for Veterinary Technicians in the field of large animal veterinary practices and the possibility of amending the scope of practice for Veterinary Technicians.

Dr. Farrington agreed to draft survey questions for the Board to approve and then consult with Megan to address the NVMA constituents for feedback.
