Mamacita Nails - Nail Technology Salon

Anderson moved, seconded by Bavougian, to recommend the approval of the application for a Nail Technology Salon Consideration Certificate with censure, a \$500 civil penalty to be paid over 1 year, and completion of the jurisprudence exam for the owner within 90 days. The basis for the censure, civil penalty, and the completion of the jurisprudence exam for the owner is due to operating for two hundred (200) days without an active license. Voting aye: Bingham, Bavougian, Kozisek, Reed, Anderson, Bain and Wendt. Voting nay: none. Abstain: none Absent: Nims and Battistelli. Vacant positions: 3 Motion carried.

Eyebrow Threading and Lashes (4801 S 50th St Omaha) - Esthetics Salon

Anderson moved, seconded by Bavougian, to recommend approval of the application for an Esthetics Salon Consideration Certificate, with censure, a \$7,000 civil penalty to be paid over 2 years, and completion of the jurisprudence exam for the owner within 90 days. The basis for the censure, civil penalty, and the completion of the jurisprudence exam for the owner is due to operating for two thousand seven hundred sixty-five (2,765) days without an active license and aiding and abetting employees in practicing in an unlicensed salon. Voting aye: Bingham, Bavougian, Reed, Anderson, Bain and Wendt. Voting nay: none. Abstain: Kozisek Absent: Nims and Battistelli. Vacant positions: 3 Motion carried.

Eyebrow Threading and Lashes (18460 Wright Street Omaha) – Esthetics Salon

Anderson moved, seconded by Bavougian, to recommend the approval of the application for an Esthetics Salon Consideration Certificate with censure, a \$2000 civil penalty to be paid over 2 years, and completion of the jurisprudence exam for the owner within 90 days. The basis for the censure, civil penalty, and completion of the jurisprudence exam for the owner is operating for one thousand thirty-five (1,035) days without an active license and aiding and abetting employees in practicing in an unlicensed salon. Voting aye: Bingham, Bavougian, Reed, Anderson, Bain and Wendt. Voting nay: none. Abstain: Kozisek Absent: Nims and Battistelli. Vacant positions: 3 Motion carried.

Scissors & Scotch – Cosmetology Salon

Anderson moved, seconded by Reed, to recommend approval of the application for a Cosmetology Salon Consideration Certificate, with censure, a \$ 3,000 civil penalty to be paid over 3 years, and completion of the jurisprudence exam for the owner within 90 days. The basis for the censure, civil penalty, and the completion of the jurisprudence exam for the owner is due to operating for four hundred (400) days without an active license. Voting aye: Bingham, Bavougian, Kozisek, Reed, Anderson, Bain and Wendt. Voting nay: none. Abstain: none Absent: Nims and Battistelli. Vacant positions: 3 Motion carried.

Chloe Johnson - Cosmetologist

Anderson moved, seconded by Bavougian, to recommend approval of the application for a Cosmetologist license on three (3) years probation with conditions. The basis for the three (3) years probation is due to federal convictions and dishonorable conduct. Voting aye: Bingham, Bavougian, Kozisek, Reed, Anderson, Bain and Wendt. Voting nay: none. Abstain: none Absent: Nims and Battistelli. Vacant positions: 3 Motion carried.
