Chiles updated, Medical Nutrition Practice Act the hearing was February 3, Revised Statutes Cumulative Supplement, 2022; to provide, change, and eliminate definitions; to restate intent; to change membership on a board; to provide and change licensure requirements; to change provisions regarding scope of practice; to harmonize provisions; to repeal the original sections; and to outright repeal section 38-1804
