

# **NEBRASKA BOARD OF MEDICINE AND SURGERY**

## **MEETING MINUTES**

**June 24, 2022**

### **ROLL CALL**

## **PUBLIC PRESENTATION**

Dr. Jeffrey Fraser was present at the meeting. Dr. Fraser addressed the Board regarding his Reinstatement after Discipline Physician Application requesting early release from probation and dismissal of civil penalty that has been submitted for Board review.

## **2022 LEGISLATION UPDATES**

Amy Reynoldson, Executive Vice President, with the NMA (Nebraska Medical Association), was present to discuss and provide updates to the Board on the 107th Legislature.

Amy mentioned that the NMA is anticipating a potential special session.

LB933 - Adopt the Nebraska Human Life Protection Act – the NMA strongly opposes language in this bill regarding felony penalties for physicians treating patients according to the standard of care. The NMA will be working to remove this language from LB933. The NMA as well is strongly concerned with preserving IVF.

## **LIFEBRIDGE - NEBRASKA'S PHYSICIAN WELLNESS PROGRAM**

Lindsey Hanlon, M.S., CPH, LifeBridge Program Coordinator with the Nebraska Medical Association and Dr. Todd Stull, Medical Director for LifeBridge Nebraska joined the meeting to make a presentation to the Board to share an in-depth overview of the LifeBridge program.

LifeBridge is not just another wellness program, it's a preventative approach to address the spectrum of burnout. Rates of physician burnout are two times higher than any other profession. Physicians need a confidential resource. LifeBridge is not treatment or an employee assistance program. LifeBridge is confidential coaching that's non-discoverable coaching from trained coaches. There are no medical records created or written notes. LifeBridge aligns with Nebraska state laws to preserve the client/coach relationship.

The basic sequence of how LifeBridge functions:

- A Physician in need calls into LifeBridge (1-888-569-2036)
- The call center takes basic information and identifies a coach to connect with
  - Completely Confidential – no electronic medical records created, no reporting to employer and no reporting to medical board or licensure
- The Physician is given the coach's contact information to connect with
- The Physician and Coach meet
  - Each step in this process is adaptable to the physician's needs including: length of sessions, number of sessions, how to meet (in-person, phone, virtually, text, email) and when to meet.
- The Physician completes a satisfaction survey

To reiterate LifeBridge is coaching only, no patient - physician relationship is established, no diagnosis is made and no records.

Why does physician wellness matter? Because the consequences threaten health systems and hospitals both directly and indirectly:

- Direct Consequences
  - Turnover
  - Early Retirement
  - Reducing hours
- Indirect Consequences
  - Poor care quality
  - Increased medication errors
  - Unnecessary testing
  - Greater malpractice risk
  - Loss of patient satisfaction and loyalty

LifeBridge is available free for all Nebraska licensed physicians and residents. It's funded through the Nebraska Medical Foundation, health care systems, hospitals, corporate sponsors and payers.

## **IV HYDRATION THERAPIES**

Evidence Based Care - The Nurse Practice Consultant for the Nursing program area is considering a joint advisory from the APRN Board and Practice Committee for the Board of Nursing in conjunction with the Board of Medicine and Surgery and the Board of Pharmacy. The joint advisory would address various practices for which the Department receives regular inquiries regarding IV Hydration, including who can prep the IV bag, and who can administer.

## **FSMB IMPROVING LICENSURE FOR WORKFORCE WELLBEING**

One of the sessions at the FSMB annual conference was concerned with states auditing their licensure applications to change or remove any invasive or stigmatizing language and communicate to physicians that it is safe for them to seek mental health care.

Jesse reiterated to the Board that we have taken steps at a Department level to review all applications and where possible consider what questions we are asking and if we are getting the information that we have a statutory obligation to collect. Through the application process all physician concerns must be balanced with public safety considerations. Within the past few years we have reviewed and made modifications to our application to address concerns around these sensitive topics. Again we continue to consider the questions we ask on all applications to protect the applicant but also to ensure we are taking appropriate steps to protect public safety.
