# AMERICAN BOARD OF DENTAL EXAMINERS (ADEX) AND CDCA-WREB-CITA MEMORANDUM OF UNDERSTANDING ANNOUNCEMENT

(June 20, 2025) The American Board of Dental Examiners (ADEX) and CDCA-WREB-CITA have signed a Memorandum of Understanding (MOU) on June 12, 2025, to merge into a single organization under the unified name American Board of Dental Examiners. This decision reflects a shared commitment to national dental licensure standards and uniting exam development and delivery under one roof.

The combined organization will continue to include the direct representation of dental boards throughout the United States and North America, furthering the ADEX national exam standard and its innovative psychomotor performance exam administration capabilities.

"The new ADEX is uniquely positioned to bring the dental community the licensure uniformity it has sought for decades," explained CDCA-WREB-CITA Chair Dr. Mark Armstrong.

This combination marks a new chapter in dental licensure, one that advances public protection, professional mobility, and common competency exam standards throughout the United States and beyond.

"At each step, it has taken forethought and intention to create the path to where we are today. I am proud of what we have already achieved and grateful for the thoughtful leadership that has guided us here," noted current ADEX President Dr. Conrad McVea.

#### What This Means for Stakeholders:

One connected organization: Combining ADEX's exam development expertise with CDCA-WREB-CITA's national exam administration delivery network, similar to Medical's USMLE and Nursing's NCLEX.

Broader representation: All member dental boards will have the opportunity to appoint both a dentist and a dental hygienist to participate in the development of exam content and oversight.

Continued innovation: The organizations' successful joint efforts, including the CompeDontTM and SimuDont exam technology, will continue under a common mission.

# Next Steps:

Final approval of the merger is expected later this summer, pending votes by both organizations, including the ADEX House of Representatives and the General Assembly of CDCA-WREB-CITA.

Stakeholders will be kept informed throughout the process, with additional details to be shared following ratification.

# The Difference Between Oral Exams and Oral Health Screenings

Oral examinations and oral health screenings are procedures for assessing the health of children's mouths, but they serve different purposes. An oral health screening does not take the place of an oral exam.

Knowing which procedure each child receives is important for Head Start programs. The table below describes the differences between an oral exam and an oral health screening.

# **Oral Health Screening**

# **Purpose**

Provides a complete evaluation of a child's oral health status. Results in a child's oral health status. May result diagnosis and a treatment plan.

Provides a limited assessment of a in a referral to a dentist or mid-level oral health professional\* for an oral exam.

#### Performed Dentist or mid-level oral health professional.\* by

Mid-level oral health professional,\* dental hygienist, or health professional (e.g., physician, nurse practitioner, or physician assistant trained to conduct an oral health screening).

# **Categories Oral Exam**

# **Oral Health Screening**

#### Follow-up

If tooth decay or another oral health problem is identified, treatment is provided by a dentist or mid-level oral health professional,\* and the child is scheduled for their next dental appointment. If no oral disease is identified, the child is scheduled for their next oral exam in 6-12 months.

If signs of possible tooth decay or other problems are identified, the child is referred to a dentist or midlevel oral health professional\* for an oral exam. Case management may be provided if a child does not have an ongoing source of continuous, accessible oral health care.

# Differences Between an Oral Exam and an Oral Health Screening

\*In some states, mid-level oral health professionals (e.g., advanced dental hygiene practitioners, dental therapists, dental health aide therapists) are licensed by the dental board. These professionals are legally allowed to conduct oral assessments and evaluations that qualify as an oral exam under their state's dental practice act.



Nebraska Legislative Statute 38-1130 allows a licensed dental hygienist with a public health authorization to perform public health-related services in a public health setting or in a health care or related facility. These services include dental screenings, dental cleanings, topical fluoride applications, dental sealant placement, silver diamine fluoride applications, caries risk assessments and professional referrals.

There are approximately 200 hygienists with a public health authorization across Nebraska. This unique workforce provided almost 30,000 dental screenings for people of all ages in 2023. They often work with local health departments in remote areas of the state where there is a shortage of dentists. Utilizing the PHRDHs to perform the EPSDT dental screenings for entry into the Head Start program reduces a significant barrier for our children.

This challenge can be overcome by utilizing our qualified public health hygienists to perform screenings that capture the same basic oral health information that an initial child dental examination does. Oral screenings detect early dental issues, provide proper dental referrals for urgent needs, offer educational services and help establish dental homes. The Nebraska Head Start Dental Screening Form is attached here.

Dental screenings (D0190) and assessments (D0191) have been recently approved for reimbursement to PHRDHs by Nebraska Medicaid. The screening services provided by PHRDHs meet the dental evaluation requirements of Nebraska's EPSDT program. We are aware that this same approach has also been taken

in Minnesota and Iowa and we believe it should also be recognized here in Nebraska.

The purpose of this topic is to inform the BOD that after an internal DHHS review, it was determined that dental screenings performed by Nebraska Public Health Hygienists, meet the Early and Periodic Screening, Diagnosis and Treatment (EPSDT) schedule requirements for an initial dental evaluation and for entry into the Nebraska Head Start program. Attached here is a letter from DHHS to the Administration of Children and Families in Kansas City that explains Nebraska Statute 38-1130, along with the Nebraska HS Dental Screening Form. The reply from the Region VII Office of Head Start is also attached along with a document from the Head Start explaining the difference between oral exams and dental screenings.

My intention is to join this meeting by Zoom through a Starlink Satellite connection. I will be fishing in Alaska on a boat in the Yukon River near the Bering Sea (the wilderness) so this may or may not work.
