#### **DEPARTMENT OF AGRICULTURE UPDATES**

Kaylie Fritts, DVM, Deputy Nebraska State Veterinarian with the Agriculture Department was present for discussion with the Board.

NPAI (Highly Pathogenic Avian Influenza) to date no detections have been made in Nebraska, this includes the bovine, poultry, or human population. The State of Colorado does have 3 confirmed reports in poultry and dairy.

EIA (Equine Infectious Anemia) one positive case was reported in NE and the horse was euthanized. The rest of the herd was tested and all tested negative for EIA.

#### **2024 LEGISLATION UPDATES**

With the passing of LB910 the DHHS EMS Department is inquiring if the Board has any specific suggestions for additional education and or training that should be implemented.

The Board's basic suggestion is to take or review BLS (Basic Life Support) Training for canines.

**<u>LB910</u>** - Authorize an emergency medical service to transport and emergency care providers to provide emergency medical care to injured law enforcement canines.

Approved by the Governor on April 16, 2024.

The Board reviewed the Draft Regulations for Title 172 Chapter 180 Practice of Veterinary Medicine and Surgery. Vonda Apking noted that the Regulations will be updated further once the Licensure Unit has received the opinion on LB16 from DHHS Legal Department.

<u>LB16</u> - Require occupational boards to issue certain credentials based on credentials or work experience in another jurisdiction, provide and change requirements regarding applicants with a criminal conviction, provide for jurisprudential examinations and appeals, change requirements for membership of the State Electrical Board, and adopt the Interior Design Voluntary Registration Act

Approved by the Governor on March 5, 2024.
