# MINUTES OF THE MEETING OF THE BOARD OF VETERINARY MEDICINE AND SURGERY

## **ROLL CALL**

## **LEGISLATION & REGULATION UPDATES**

Kaylie Fritts, DVM, Deputy Nebraska State Veterinarian with the Agriculture Department was present for discussion with the Board.

Dr. Fritts reported that the last commercial outbreak for NPAI (Highly Pathogenic Avian Influenza) was in May, nationally, and there are no current open control zones in the United States at this time.

Dr. Fritts also reported that the USDA does routine surveillance for pseudorabies (PRV) in pigs. There was a report of a positive result at the end of April at a slaughterhouse in Nebraska. Ultimately after all the checks and triple checks were performed, they came back as false positives or non-negative and the situation has been resolved.

The Board continued the discussion regarding the need for Veterinary Technicians in the field of large animal veterinary practices and the possibility of amending the scope of practice for Veterinary Technicians.

Dr. Farrington has drafted survey questions from the Board and consulted with Megan Kilgore, Executive Director of the NVMA to construct a survey with the questions to be sent out to the NVMA constituents for their feedback responses.
