

**MINUTES OF THE MEETING OF THE

A. COVID-19

B. NVMA (Nebraska Veterinary Medical Association) Letter to the Board

Jeremy Young, DVM, 2020 NVMA President, joined the meeting to express the NVMA's request for expansion of the hours allowed for online continuing education (CE) opportunities for the next licensing period ending April 1, 2022. The current regulations state that one quarter of the required hours can be obtained from online/home study (DVM- 8 of the 32 hours; Veterinary Technician 4 of the 16 hours). Due to the COVID-19 pandemic many of the traditional in-person meetings and CE courses have been cancelling, therefore they want to be proactive in clarifying how the veterinary professions can be compliant with completing the continuing competency requirement.

It was clarified that many of the in-person meetings and CE opportunities have been rescheduling to "interactive webinars", which are considered to be "live" and therefore do not count as home study online courses.

It was also noted that Executive Order (EO) 20-27 #10 states:

DHHS shall afford credential holders under the UCA the opportunity to request waivers of continuing competency as part of the renewal process as provided for in Neb. Rev. Stat. § 38-146 (2)

C. Newsletter

The Board discussed the concept of publishing a "Newsletter" for Veterinary Medicine and Surgery that would be posted on the DHHS website semi-annually. Suggested content for the newsletter would be educational topics such as regulatory education - reviewing the UCA (Uniform Credentialing Act), mandatory reporting, medical records documentation and current veterinary interest topics. The newsletter would focus on being inclusive for all the veterinary professions of DVM's, Veterinary Technicians and Animal Therapists. Jesse Cushman and Dr. Kohles will pursue the concept.

AAVSB Annual Meeting Update

The AAVSB Annual Meeting scheduled for September 24-26, 2020 in Portland, Oregon has been cancelled for the in-person components.

The Annual Meeting has two components – the Educational Meeting and the Annual Delegate Assembly. The Educational Meeting will be held virtually. These education sessions will be submitted for RACE® approved credit. The schedule will be designed over several months with 1 – 1.5-hour sessions approximately twice per month. The AAVSB looks forward to your engagement in these virtual offerings.

The other component of the Annual Conference, the Delegate Assembly, will be cancelled for 2020. The Board of Directors feels there are three important reasons for the cancellation including:

- The business session of the Association lends itself to Delegates and members being face-to-face.
- Achieving quorum would be difficult through virtual means.
- Continuity of leadership is extremely important during these unprecedented times.

The cancellation of the Delegate Assembly impacts voting on proposed Bylaws amendments as well as elections for the open positions. Per the AAVSB bylaws, the current members of the Board of Directors, the Nominating Committee, and the Representatives to the ICVA, shall serve "until a successor is elected and qualified" which will occur at the 2021 AAVSB Annual Meeting & Conference in Denver, Colorado on September 30 – October 2. Submitted proposed Bylaws amendments will be deferred until 2021.
