# Minutes of the September 6, 2023, Board of Registered Environmental Health Specialists Meeting

## 1. ROLL CALL

Sarah Pistillo, Vice-Chairperson, called the meeting of the Board of Registered Environmental Health Specialists to order at 2:23p.m. on September 6, 2023, in the Goldenrod Conference Room at the Nebraska State Office Building located at 301 Centennial Mall South, Lincoln, Nebraska. #### 2. ADOPTION OF AGENDA

## **4. BOARD RECOMMENDATIONS ON APPLICATIONS**

The Board did not make any recommendations.

## **5. FOOD INSPECTIONS**

The Board discussed food establishments and inspections. It was determined that the Nebraska Pure Food Act does not include nursing homes, health care organizations, schools, in the definition of a food establishment, and does not require inspections by Registered Environmental Health Specialists.

#### **6. LEGISLATIVE UPDATE**

Covert-ByBee advised that LB 262 had amendment 719 introduced, which stated: (4) All inspections conducted pursuant to the act shall be performed by persons who (a) meet the requirements of section 8-402.10 of the Food Code and, within thirty-six months after being hired to conduct such inspections, pass a certified professional food safety credential examination approved by the department that meets the requirements of Option 2 of Standard 2, Trained Regulatory Staff, of the 2022 United States Food and Drug Administration's Voluntary National Retail Food Regulatory Program Standards or (b) are provisional environmental health specialists or registered environmental health specialists as defined in section 38-1305 or 38-1306. This bill and amendment were carried over to the next legislative session.

## 7. SCHEDULE MEETINGS FOR 2024

The Board scheduled meetings for January 17, and September 4, 2024.

#### 8. UPDATE ON LICENSURE DATABASE

Covert-ByBee advised that the Department secured a contract with System Automation to stabilize the current licensure database. The project kicked off on June 15, 2023, and is slated to be 100% operational by January 1, 2025. The stabilized database will be cloud-based instead of terminal-based, which will allow for great stability. The Department is simultaneously working on creating a request for proposal (RFP) to expand the online services for licensure.

## 9. APPLICATION PROCESSING REPORT (APR)

Blinston stated that the application processing report was provided for informational purposes only.
