- b. Legislation Loving stated no new updates since last board meeting.

Discussed what to do about new statutes/updated statutes.

Nail tech bill didn't get carried over because of a new senator in that district.

Loving mentioned there is a limit on the number of bills that each senator can introduce.

Health & Human Services committee doesn't reach out to any boards; it's possible the senators don't know that the boards exist

Kozisek has previously emailed meeting agendas to senators

Sims - Oklahoma & Mississippi board have been dissolved (emergency stay for one year in MS)

Sims – microlicensing occurring in some other states

Kozisek – certifications for medical esthetics (not a license)

- c. Statistics: examinations, licensing, disciplinary/non-disciplinary Information, and renewals (report attached to agenda) board discussed concern regarding exam results
- d. NIC

Nordboe mentioned the National Convention in October (17-20)

Marie & Chevy (Marie doesn't have to pay registration)

Anderson moved; Reed seconded - all voted aye

Nordboe – virtual meeting in June

i. Discussion of disinfectant products (look for email for the agenda/minutes of this meeting – sent by NIC)

- a. Contains citric acid & botanicals (thyme)
- ii. Head spas
 - a. Discussion of who can work in head spas cosmetology, barber, estheticians, physicians; depends on state as to who is allowed (depends on whether they can shampoo products out after the treatment.
 - b. Can do a head spa treatment but only on dry hair, only non-medicated products
 - 1. Med spas can do treatment that penetrates dermis (in some states)
 - 2. History of NIC
 - 3. Best practice exam \$125 (similar to JP exam); can't pass until you answer every question correctly
- 2. Head Spas
 - a. Kozisek thinks estheticians should be able to do head spa treatments
 - b. Definition of cosmetology, esthetics, etc. in statute
 - 1. Japanese head spa holistic treatment of the scalp; cleanse, exfoliate, massage the scalp
 - 2. Deep cleansing
 - 3. Discussion of scope of practice cosmetology vs. esthetics; cosmetologists are trained in esthetics at some schools, but not as many hours as they would in a separate esthetics program
 - c. Best to change the statutes
 - 1. Usually they are changed because there is a powerful lobbying group
 - 2. Bingham & Kozisek can reach out to some contacts in professional organizations
 - d. Braiding bill
 - 1. Platte institute
 - e. Best to schedule a special meeting in August & put head spas on the agenda
 - 1. August 11 set for this special meeting.
 - 1. Asked that they forward materials to us if they want specifics reviewed at this meeting
 - 2. Also will discuss advisory opinions
